

REGULAR MEETING

The Monday, September 11, 2023 Regular School Board meeting of the Howard Lake-Waverly-Winsted ISD #2687 was called to order at 6:31pm. by Chairperson Heuer. After the pledge of allegiance, roll was taken with the following members present: Heuer, Koch, Borrell, Marketon, Mulvihill and Puncochar; absent: Bravinder and Principal Jim Schimelpfenig. Also present were Superintendent Nate Walbruch, Principals Stephanie Kuehn and Jennifer Olson, and Board Secretary Marilyn Greeley.

(Item IV) Puncochar recommended approval of the agenda; Koch seconded; passed unanimously.

(Item V) There were no questions or comments from visitors.

(Item VI) Puncochar recommended approval of the consent agenda which included August 14, 2023 Regular Board meeting minutes, August 21, 2023 Special Board meeting minutes, August 28, 2023 Work Session meeting minutes, bills, monthly treasurer report, enrollment, the FMLA leave request for **Tammi Thiemann** effective immediately thru September 30, 2023; and the resignation of **Emily Rice** as a High School English Teacher effective immediately; **Erin Schumm** as ECSE teacher effective when a replacement is found; and **Janai Kittock** as a paraprofessional at Humphrey Elementary effective mid September 2023, employment for **Erin Schumm** as a Paraprofessional replacing Janai Kittock; and **Janai Kittock** as an ECSE Teacher replacing Erin Schumm, the second reading and approval of the following annual policies (from the August 14th meeting): **514**-Bullying Prohibition Policy; **524**-Internet Acceptable Use and Safety Policy; **616**-School District System Accountability; **806**-Crisis Management Policy, and communications: Thank you from Graves Family, MSBA Upcoming School Board Learning Opportunities; Borrell seconded; passed unanimously.

(Item VII, Subd. A) Community Education Director, Rachel Bender, gave an update on Community Education, Laker Care and Preschool (Little Laker Learners).

(Item VII, Subd. B) Buildings & Grounds Director, Joe McKee, gave an update on buildings and grounds.

(Item VII, Subd. C) The board discussed changing the submission of the school board committee reports as a google form instead of a fillable document. The consensus was that the board will change to submitting the committee reports as a google form.

(Item VII, Subd. D) Heuer indicated we do not need to take action on the resolution stating the intention to issue refunding bonds but we will take action at the work session. Superintendent Walbruch reviewed the information from Ehlers.

(Item VII, Subd. E) Joe McKee, Buildings & Grounds Director, recommended renewing the contracts with Andy's for the HS/MS Campus, and Joey Bayerl for Winsted and Humphrey Elementary.

Mulvihill recommended approving Andy's for the HS/MS Campus, and Joey Bayerl for Winsted and Humphrey Elementary for snow removal vendors for the 2023-24 season; Puncochar seconded; passed unanimously.

(Item VII, Subd. F) Mulvihill recommended approval of the overnight student trip to London, Paris and the Alps for High School Students March 22-31 2024; Deep Portage January 10-12 2024 for sixth grade students; and varsity Volleyball to Holiday Inn, Rogers October 6-7, 2023.; Katie seconded; passed unanimously.

(Item VII, Subd. G) Borrell recommended approval of the resolution accepting donations; Koch seconded; those in favor: Borrell, Koch, Marketon, Mulvihill, Puncochar and Heuer; those opposed: none; passed unanimously.

(Item VII, Subd. H) Heuer indicated the following items will be on the special board meeting agenda:
