



**ADDENDUM TO CONTRACT FOR SERVICES AGREEMENT
BETWEEN AUSTILL'S REHABILITATION SERVICES, INC.
AND CONESTOGA VALLEY SCHOOL DISTRICT**

July 1, 2026

This ADDENDUM to the LETTER OF AGREEMENT ("Addendum") is made on March 12, 2026 by and between AUSTILL'S REHABILITATION SERVICES, INC. with offices at 100 John Robert Thomas Drive, Exton, PA 19341 ("Austill's") and Conestoga Valley School District, with offices at 2110 Horseshoe Road, Lancaster, PA 17601 ("Conestoga Valley").

Austill's contracted with Conestoga Valley on May 20, 2020.

NOW THEREFORE, the parties, in consideration of the premises and the covenants and promises contained in the LETTER OF AGREEMENT do hereinafter agree to as follows:

1. Engagement. Conestoga Valley engages Austill's to provide occupational therapy, physical therapy and speech-language pathology services consistent with Conestoga Valley's needs and requirements. Austill's agrees to provide such services through credentialed and experienced therapists.
2. Term. All terms and conditions of the Contract for Service Agreement shall remain in full force and continue through June 30, 2029 unless terminated by either party upon sixty (60) days prior written notice to the other party.
5. Compensation/Reimbursement for Services. Austill's will be reimbursed at the following rate structure:

Reimbursement will include, but is not limited to, the following: on-site and virtual evaluation/consultation/treatment time; off-site follow-up documentation/consultation time; travel time between Conestoga Valley locations; and travel time to and from one itinerant student per off- site location. An itemized accountability form detailing specific student services rendered each month will be generated and furnished to Conestoga Valley for each therapy service provided.

ESY – HALF DAY PROGRAMS: The Contractor shall be reimbursed based on a guaranteed minimum block of three (3) hours per day for each assigned therapist. This daily block covers all professional activities, including but not limited to: student evaluation, consultation, direct treatment, documentation, inter-school travel, and other duties required to fulfill the student's IEP and District obligations.

In the event that actual service minutes fall below the three-hour threshold, the Contractor shall be reimbursed for the full three-hour block. Any service time required beyond the guaranteed three-hour block shall be billed at the standard contracted hourly rate.

An itemized invoice form detailing specific student services rendered each month will be generated and furnished for each therapy service provided.

All other terms and conditions will remain the same.
