

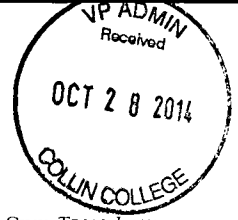

This property was sold at a Sheriff's Sale on April 6, 2010 pursuant to delinquent tax collection suit number 219-00907-2008. There were no bidders and the property was struck off to the Collin County Community College District for itself and on behalf of the other taxing jurisdictions.

The property's most recent value according to the Appraisal District is \$9,320.00. The property was struck off for the total judgment amount, \$4,138.15, which includes taxes, penalties and interest, costs of court, and costs of sale.


