WHEREAS, Vienna Township has previously designated and received Community Development Block Grant Funds; and

WHEREAS, Vienna Township has designated \$8,500.00 2025-2027 Community Development Block Grant Funds grant to 2025 Clio Area Senior Center Power Door Openers; and

WHEREAS, the 2025 Clio Area Senior Center Power Door Openers bid was advertised and emailed to potential bidders, including women owned businesses and minority owned businesses; and

WHEREAS, the 2025 Clio Area Senior Center Power Door Openers bid was due April 02, 2022; and

WHEREAS, 2025 Clio Area Senior Center Power Door Openers bid received no bids by the due date; and

WHEREAS, Vienna Township received directions from the Planning Commission that we could solicit quotes for 2025 Clio Area Senior Center Power Door Openers project; and

WHEREAS, Vienna Township received one quote after reaching out to multiple vendors, which is Dover Doors and Windows; and

WHEREAS, Vienna Township, Genesee County Planning Commission, and Dover Doors and Windows had a preconstruction meeting on Monday, May 04, 2026; and

WHEREAS, Dover Doors and Windows said it could take up August to receive the supplies ordered; and

WHEREAS, Dover Doors and Windows said it expecting an installation date to happen in September; and

WHEREAS, Vienna Township has a timeline of September 30, 2026, to spend 2025 Community Development Block Grant Funds; and

NOW, THEREFORE, BE IT RESOLVED, that the Vienna Township Board hereby requests the \$8,500.00 in Community Development Funds timeline be extended from September 30, 2025, to November 30, 2026.
