Pursuant to Texas Education Code §37.108, the K–12 School District Audit Cycle for the period of September 1, 2023, through August 31, 2026, has concluded. The Safety and Security Department has completed audits at every district campus, as well as all auxiliary locations including central administration, maintenance facilities, the special events center, district stadiums, and the warehouse.

The audit team is comprised of Safety and Security personnel and fire department representatives. The audit process is a comprehensive review utilizing the audit tool kit provided by the Texas School Safety Center (TSSC). Each campus receives a summary report detailing audit findings, including a breakdown of each component reviewed and supporting photographic documentation. These reports are also forwarded to any district department identified as needing to adjust procedures or initiate repairs.

The final district audit report will be submitted to the Texas School Safety Center via the online portal when the link is received. The Safety and Security Department will begin the next three-year audit cycle at the start of the 2026–2027 academic year.

The audit schedule is structured as follows:

**Year 1** – Elementary Schools

**Year 2** – Middle Schools and ½ of “other facilities”

**Year 3** – High Schools and ½ of “other facilities”

This phased approach allows the audit team to thoroughly evaluate all facilities in a structured and manageable manner.

Copies of individual campus audit reports are available for review by Cabinet members and Board Trustees upon request. These materials are classified as safety and security documents. As such, they are not authorized for duplication or release to outside parties under the asserted statutory exception.
