**RESOLUTION PROVIDING FOR A PUBLIC HEARING  
TO CONSIDER GRANTING A PROPOSED PROPERTY TAX ABATEMENT**

BE IT RESOLVED, by the School Board (the “Board”) of Independent School District No. 1 (Aitkin Public Schools), Aitkin and Crow Wing Counties, Minnesota (the “District”) as follows:

1. The School Board hereby finds and determines that a public hearing shall be held, pursuant to Minnesota Statutes, Section 469.1813, Subdivision 5, to consider granting an abatement of certain property taxes levied against net tax capacity (the “Proposed Property Tax Abatement”) imposed by the District for taxes payable in 2027 through 2034 on the following properties within the District boundaries (identified by property identification number):

2. The purpose of granting the Proposed Property Tax Abatement is to provide funds to finance the construction of and improvements to parking lots at various sites in the District. The total estimated cost of the Proposed Property Tax Abatement by the School District is \$2,893,083 over eight (8)

years, an amount estimated to be sufficient to pay the principal and interest charges on approximately \$2,300,000 of bonds issued to finance parking lot construction, reconstruction and improvements districtwide and related financing costs.

3. The public hearing to consider the granting of the proposed tax abatement shall be held on June 22, 2026, at 6:30 o'clock p.m., in the Media Center at the Aitkin Public Schools, 306 Second St. NW, Aitkin, MN 56431. The Clerk is authorized and directed to cause notice of the hearing to be published in a newspaper of general circulation in the District at least one time at least ten (10) days but less than thirty (30) days before the date of the hearing. The newspaper must be one of general interest and readership in the community and not one of limited subject matter. The newspaper must be published at least once per week. The Notice of Public Hearing shall be in substantially the form of the Notice attached hereto as EXHIBIT A.

4. All who wish to be heard as to the Proposed Property Tax Abatement will be given an opportunity to express their views at the time of the public hearing or may file written comments with the Superintendent prior to the public hearing.

5. All actions taken by the District to cause the publication of the attached Notice of Public Hearing prior to the date of this resolution are hereby ratified, confirmed, and approved.
