

**RESOLUTION CANVASSING RETURNS OF VOTES OF
FOREST LAKE AREA SCHOOLS INDEPENDENT SCHOOL DISTRICT NO. 831
SPECIAL ELECTION HELD MAY 20, 2014**

BE IT RESOLVED by the School Board of Forest Lake Area Schools Independent School District No. 831, State of Minnesota, as follows:

1. It is hereby found, determined and declared that the Special Election of the voters of this school district held on May 20, 2014 was in all respects duly and legally held.
2. As specified in the attached Abstract and Return of Votes Cast, a total of 7,523 voters of the district voted at said Special Election on the following question.

Approval of School Building Bonds

Shall the School Board of Independent School District No. 831 (Forest Lake Area Schools), Minnesota, be authorized to issue general obligation school building bonds in an amount not to exceed \$188,205,000 for acquisition and betterment of school facilities?

3. Votes cast for and against the question are as follows:

4. The question, having not received a majority of the votes cast, hereby declared to have not passed.

5. The clerk is hereby directed to certify results of the Special Election to the county auditors of each county in which the school district is located in whole or in part.

6. The clerk is further directed to notify the Commissioner of Education of the results of the election and to provide the certified vote totals for the ballot question in written form within 15 days after the results have been certified by the board.
