

**Agreement for 2021-22 Educational Services  
Between  
Welch Public School District 1017  
And  
Welch Skills Center (ROCMND)**

This agreement is entered on JUNE 23, 2021 by and between Welch Public School District 1017 of Craig County, Oklahoma (hereafter referred to as District), and the Welch Skills Center (ROCMND) of Welch Oklahoma (thereafter referred to as Center) for educational services at the Welch Skills Center. Teacher

**Witnesseth:**

Whereas the Welch Public School System is required by state and federal law to provide educational services to all students; and

Whereas the Welch Skill Center houses student who are entitled to a public education; and

Whereas the Welch Public Schools and the Welch Skill Center are authorized to enter into an agreement for the provision of educational services.

Therefore, the Welch Public Schools and the Welch Skill Center (ROCMND) do mutually agree as follows:

**1. Services**

The District agrees to provide for delivery of educational services at the Center to all youth residing therein by reason of judicial order made consistent with the laws of the State of Oklahoma during the 2021-22 school year. The educational services provided shall be in accordance with the curriculum as designated by the Welch Board of Education. The Center agrees to provide proper classroom space for conducting class.

**2. Teachers**

A certified teacher will be provided and paid for by the district to implement the instructional curriculum at the Center. Continuity of teacher assignment at the Center will be maintained, if at all possible, throughout the school year. A substitute may be utilized in case of the teacher being absent.

**3. Teacher Evaluation**

The teacher will be evaluated in accordance with District policies. Evaluators will consult with the Center Director, regarding compliance with the Center Regulations.

**4. Materials/Supplies**

The District will provide online curriculum licenses and other related instructional supplies including books, paper, and pencils. The District will be responsible for the supervision and implementation of the curriculum. The Center will provide/maintain internet access and the District will provide/replace existing internet access devices for individual online instruction as needed. The center will provide a copier/fax machine.

**5. Discipline**

The center will provide staff in the classroom to assist the teacher in maintaining order and discipline. This will be maintained at the resident/staff OJA (state) ration. The teacher shall control the class and the Center personnel will intervene only at the teacher's request or in case of an obvious need. The teacher will follow the District's rules for discipline along with the Center's rules for discipline. The teacher will, in consultation with the Center's Staff, make the decision when removal of a student from class is necessary. The teacher will, in consultation with the Center staff, make the decision when the student may return to class.

**6. Records**

The District will record student enrollment, days on roll, student business and withdrawals according to school district policy. Center students will be enrolled through Welch Public Schools according to age and grade level, and shall earn credits as a regular student. The district shall provide maintenance of permanent school records for Center Students with assistance of the Center. Handling records, release of information and transfer of records shall be governed by state and federal statutes.

**7. Confidentiality**

District personnel are required to maintain the same level of confidentiality concerning juveniles in the Center as is required of other Center personnel. District personnel may retain such data or records on such juveniles as required by Federal, State or District guidelines. The teacher shall provide progress reports on students to probation officers or caseworkers if required.

**8. Liability**

Each party, hereto, shall be responsible for any liability arising from the negligence of its employees, agents, and officers to the extent authorized by law.

**9. Term**

The term of the argument shall begin on July 1, 2021 and terminate on June 30, 2022.

**10. Amendment**

The agreement can only be amended by mutual written consent of both parties.
