

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE FRISCO  
INDEPENDENT SCHOOL DISTRICT APPROVING THE FIRST  
AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN  
CITY OF FRISCO AND FRISCO ISD SAFER PROJECT**

**WHEREAS**, the Texas Government Code §§791.001 et seq. (the "Act") authorize units of local government to enter into interlocal agreements; and

**WHEREAS**, the Frisco Independent School District (the "District") and the City of Frisco ("City of Frisco"), parties (the "Parties") to the First Amendment to the Interlocal Agreement (SAFER Project) ("SAFER Amendment") are local government units under the Act; and

**WHEREAS**, the District desires to reach an agreement with the City of Frisco to extend (and amend) the SAFER Program with the District; and

**WHEREAS**, the District wishes to enter into that certain SAFER Amendment for this purpose; and

**WHEREAS**, the Board of Trustees for the District has determined it is in the best interest of the health, safety and welfare of students and citizens of the District to enter into this SAFER Amendment and to adopt this resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE FRISCO INDEPENDENT SCHOOL DISTRICT THAT:**

**Section 1:** The above and foregoing recitals are true and correct and are incorporated into the body of this Resolution.

**Section 2:** That certain SAFER Amendment is hereby accepted and approved in the form attached to this Resolution as Exhibit A and incorporated herein by reference.

**Section 3:** The Board does hereby delegate authority and authorize the Superintendent of Schools to execute and cause to be delivered the SAFER Amendment on behalf of the District.

**Section 4:** It is officially found and determined that the meeting at which this Resolution was considered was open to the public and public notice of the time, place and purposes of the meeting was given and posted as required by Chapter 551 of the Texas Government Code, as amended.
