



CONTRACT
Agreement to Secure and Provide
Evaluations and Psychological Services

This is an Agreement dated the 15th day of February 2022, by and between Welch Public Schools: as referred to in this contract as ("**Welch Public School**") and School Based Services, PLLC: as referred to in this contract as ("**School Based Services**") whereby School Based Services employees, agents, or subcontractors agree to provide certain services to Welch Public School. This contract is for the 2022-2023 school years. The services are more particularly described as follows:

Evaluation & Screening

Consultation With Parents And Teacher

Observations

Psychological Related Services

Crisis Interventions

Welch Public School gives authority to School Based Service's employees, agents, or subcontractors to have access to information, confidential or otherwise, on any student involved with School Based Services in the provision of the above services. School Based Services agrees to document on State Department of Education **FORM 1 (or other appropriate forms provided by Welch Public School)**, all access of any student's confidential records. School Based Services agrees to comply with all relevant federal and state confidentiality compliance requirements concerning student records.

School Based Services and staff will report directly to the Welch Public School Director or his/her designee, as requested. School Based Services assumes responsibility for its employees, agents, interns, or subcontractors to sustain credentialing requirements in the State of Oklahoma.

Welch Public School shall make available facilities, equipment, and supplies it deems necessary for the appropriate delivery of the above-described services by School Based Services employees, agents, or subcontractors.

Services provided by School Based Services under this Agreement shall be in accord with relevant federal and state statutes and regulations, and with Welch Public School policies and regulations. Welch Public School shall make available to School Based Services a copy of said policies and regulations.

A mutually agreed upon schedule of service delivery shall be developed and approved by the Welch Public School Director or his/her designee, and School Based Services. The School District shall, upon reasonable request by School Based Services, alter the schedule of service delivery, so long as such alteration does not substantially impair Welch Public School's ability to provide its students with legally required services.

Agreement to Secure and Provide Certified School Psychologist Services

School Based Services compensation shall be \$300.00 per Psychoeducational Evaluation. A Psychological Evaluation and Psychoeducational Evaluation performed together shall be \$660.00. Psychological Evaluations performed separately will be \$470.00. ADHD Screenings performed for medical consultations will be \$300.00. ADHD Screenings for Medical Consultation and Special Education Placement will be \$320.00. Autism Evaluations will be \$700.00. These assessments include conducting the assessments, scoring, interpretation and writing the report. Explanation of results at MEETS meeting (one hour) will be billed at \$95.00 for Licensed Psychologist and \$75.00 for School Psychologist. Travel expense will be \$35.00 per trip. These services shall be paid after approval by Welch Public School or appropriate personnel. Payments for services shall be paid following Welch Public School's monthly Board Meeting.

It is further agreed that the school psychologist utilized by School Based Services cannot return to the public school as an employee or contractor for a period of 3 years after termination to provide services. In order for a former employee of School Based Services to provide school based services within 3 years from termination requires written consent from Dr. Randy Randleman.

No part of this Agreement may be assigned by either party to any other party without prior written consent of Welch Public Schools and School Based Services.

This Agreement constitutes the entire Agreement of the parties and may be modified only upon the mutual written consent of Welch Public Schools and School Based Services.
