Service Agreement

This agreement made this 16th day of June, 2026, by and between Central Montcalm Public Schools, 1480 S. Sheridan Rd. Stanton, MI 48888 and Montabella Community Schools, 1390 E North County Line Rd., Blanchard, MI 49310

Whereas, Section 1711 of the Michigan School code of 1976 (MCL 380.1711) provides that a local school district may fulfill its obligation to provide special education programs and services to its resident students by contracting with another local district or an intermediate school district, and the parties desire to enter into such an agreement. *(The terms used in this agreement are defined as they are used in the School Code of 1976, the Special Education Rules, and the State Aid Act, unless otherwise indicated.)*

The parties agree as follows:

SECTION 1: TERMS

The term of this agreement shall be for the 2026-2027 school year.

To meet the requirements of PL 94-142, Public Act 193, we, the undersigned, entered our LEA into the following contract extension agreement to employ a Speech and Language Pathologist (SLP).

Said SLP will be employed by Central Montcalm, and all costs of such employment will be charged on the following basis: Approximately 90 days through the 26-27 school year, structured at 2 days per week in each district with the fifth day alternating between districts.

For example: Tuesday and Thursday at Central Montcalm, Monday and Wednesday at Montabella, and alternating Fridays.

Costs will equate to a .50 FTE (wage and fringe benefits). Materials and tests will be the responsibility of each LEA per their Mandatory Plan for Special Education.

- Invoicing will be issued periodically, and payment is due upon receipt of the invoice.
- Both parties agree that only services authorized will be reimbursed.

SECTION 2: SERVICES

CM agrees to provide special education supervision services and any necessary tasks incident to the full performance of the described duties.

SECTION 4: OPERATIONAL REQUIREMENTS

This service shall be operated and provided in accordance with all applicable federal and state laws and regulations as well as the Delivery of Special Education Programs and services. The local districts requiring such services are responsible for all necessary facilities and equipment and all necessary instructional materials and supplies.

SECTION 5: TERMINATION

Either district may terminate this agreement with written notification 60 (sixty) days prior to termination.

SECTION 6: DURATION and AMENDMENT

This agreement supersedes any prior agreements between the parties concerning the subject service(s). It may be amended only in writing, and signed by all parties to this agreement.

SECTION 7: LIABILITY and WORKERS' COMPENSATION INSURANCE

CM agrees to maintain adequate insurance on their employee, securing the liability during their duties while providing services at Montabella.

Copies of insurance certificates for this coverage, including any updates, shall be provided upon request to Montabella during the contract period.
