TEACHERS HIRED AFTER July 30	
HR Dept. will schedule the initial T-TESS 2.0 training	GSPD & SGM training within the first two weeks of initial T-TESS 2.0 training by campus appraiser/administrator (Use Recording from 8/6/26 District Training)
TEACHER SELF-ASSESSMENT, GOAL SETTING, AND DEFINING IMPACT PERIOD	
*September 18 th - GSPD submitted within six (6) weeks from the day of completion of the orientation *Late hires after July 30 will submit GSPD four weeks from the day of completion of the orientation	
WALKTHROUGH PERIOD	
August 12, 2026, to May 26, 2027 <i>(UISD DMAC Timeline: August 17, 2026, to May 5, 2027)</i>	*Informal observations/walkthroughs shall be conducted during this period for all teachers. *All teachers must receive one COUNTED walkthrough in the Fall Semester (Aug-Dec) and one COUNTED walkthrough in the Spring Semester (Jan-May).
UNANNOUNCED DOMAINS 2 & 3 ONLY – FULL LESSON CYCLE OBSERVATION PERIOD	
*Exclude observations in the two weeks following the day of completion of the T-TESS 2.0 orientation *Announced observations begin August 24, 2026 *Announced observations end April 28, 2027 *Late hires must wait two weeks after completing T-TESS 2.0, GSPD, and SGM training before they can be observed.	*No Pre-conference required. * Unannounced observation will not be scheduled by date and time. *Post-conference is optional. * One observation is required each semester. Announced and unannounced observations must occur in opposite semesters.
ANNOUNCED DOMAINS 1, 2, & 3 – FULL LESSON CYCLE OBSERVATION PERIOD	
*Exclude observations in the two weeks following the day of completion of the T-TESS 2.0 orientation *Unannounced observations begin August 24, 2026 *Unannounced observations end April 28, 2027 *Late hires must wait two weeks after completing T-TESS 2.0, GSPD, and SGM training before they can be observed.	*Pre-conference will be conducted within five (5) days of an announced observation. * Will be scheduled by date and time. *Post-conference is required after the announced observation has been conducted. * One observation is required each semester. Announced and unannounced observations must occur in opposite semesters.
POST-CONFERENCE PERIOD	
Post-conference is required between the appraiser and teacher within ten (10) working days of announced observation.	
END OF YEAR and SUMMATIVE CONFERENCE DEADLINES	
May 5, 2027 T-TESS 2.0 requires the end-of-year and summative conference to be held at least fifteen (15) days prior to the last day of Instruction.	Last day to conduct all end-of-year conferences and provide the written summative annual appraisal reports to teachers. *Evaluations due at HR Dept. by May 14, 2027
