Lake Orion Community Schools requested bids for bond projects listed on the approved bond list approved on Nov 6, 2018. Architect, GMB and Construction Manager, Frank Rewold and Sons, wrote the bids according to the standards and specifications of the district. The bids were advertised in the local newspaper, the Sigma website, and the district website. Bids were received on April 28, 2026. The projects as presented are within the 2018 bond budget.

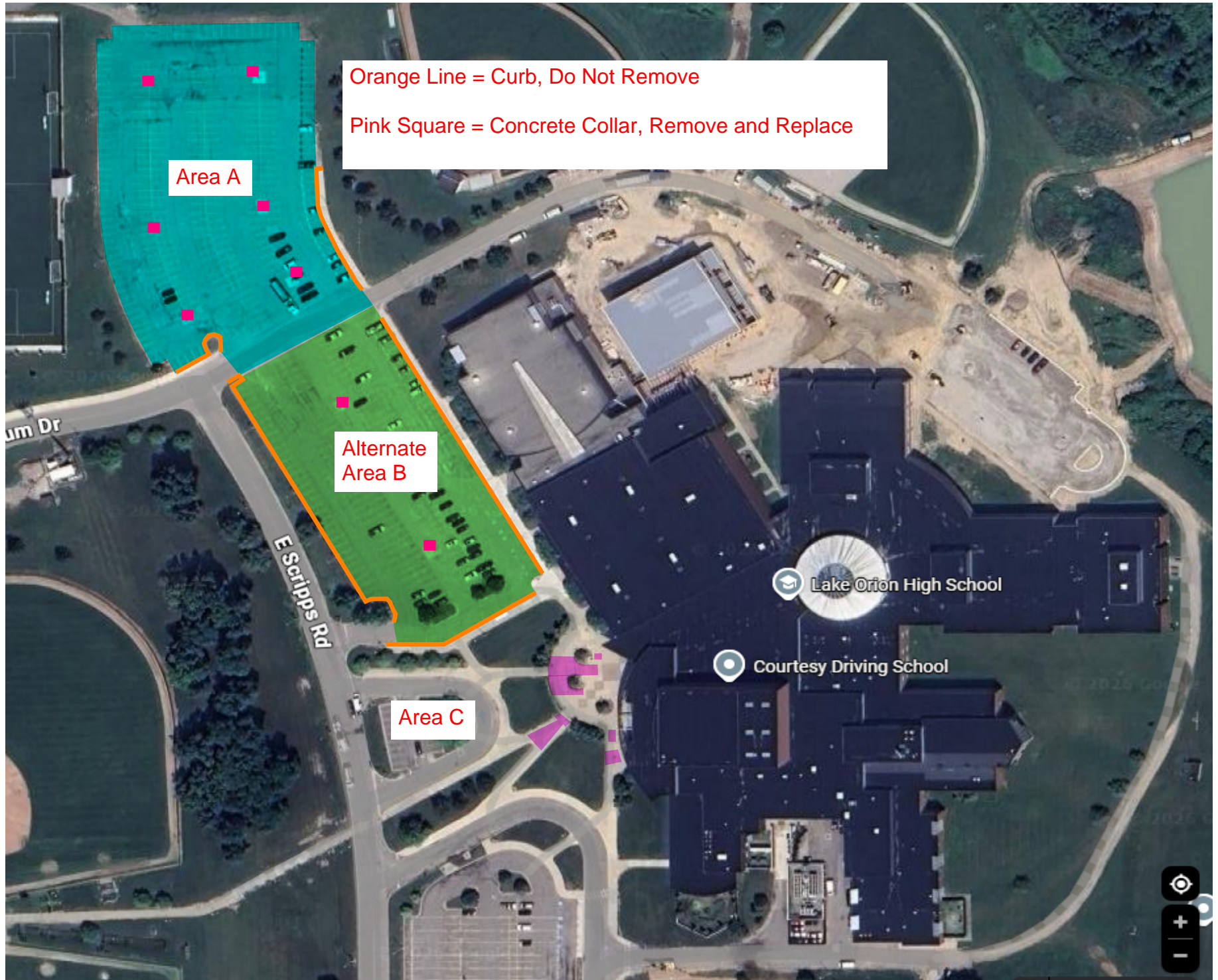

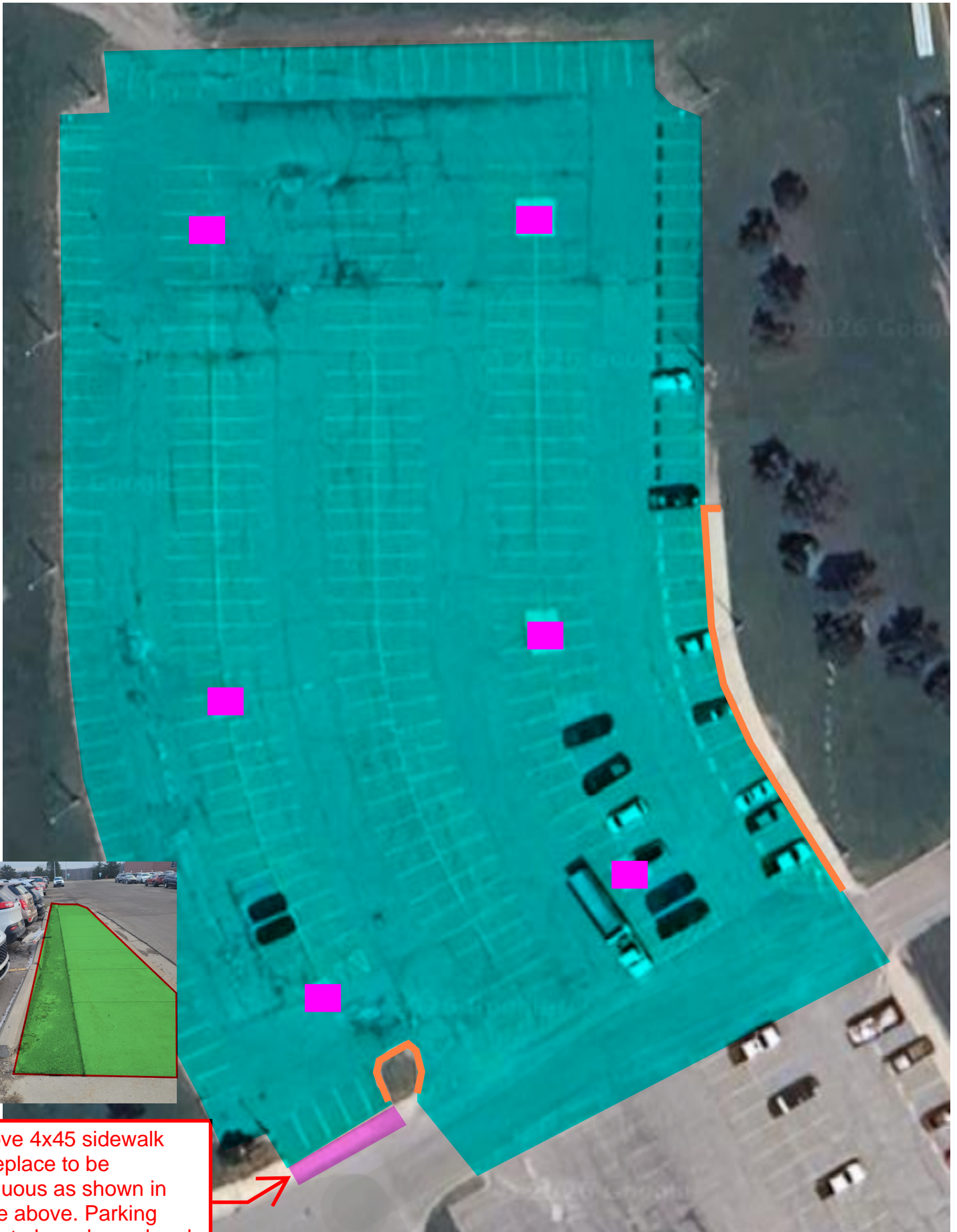

# Lake Orion High School Overall Paving Plan

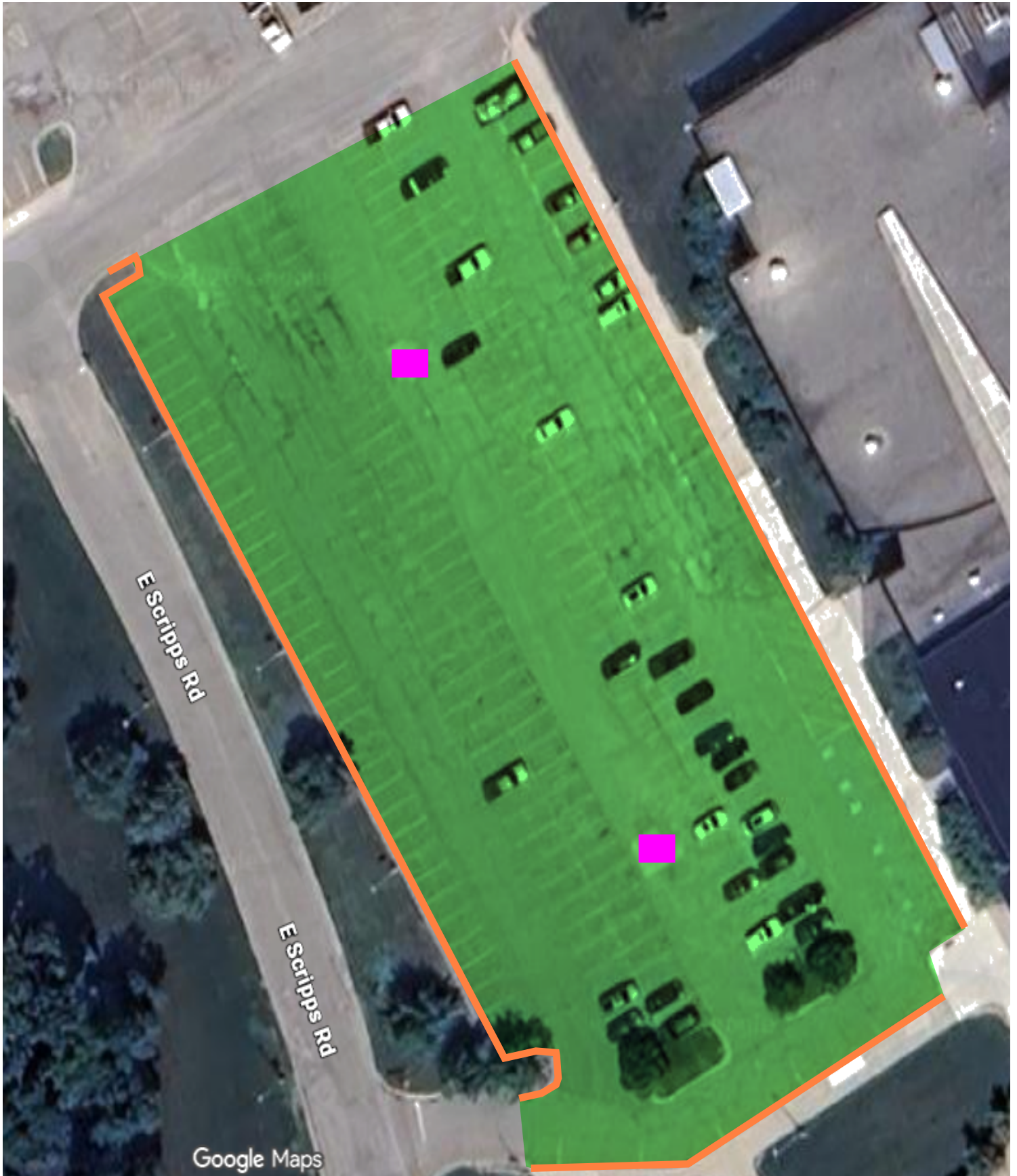


# Enlarged Drawing Area A
