Objective:	Review the policies and administrative regulations as a first reading

Background: OSBA provides quarterly policy updates that include current revisions to state and federal laws and guidelines. Staff has reviewed the updated language and applied revisions which are reflected in the policy packet.

Additionally Policy BG has been added as a first reading following the approval of the Board Operating Agreement (BOA) in order to align the policy with the school visit section of the BOA.

Revisions in **red** font indicate OSBA updated language. Revisions in **blue** font indicate staff updated language. OSBA includes informative footnotes that will be removed from the final adopted policy.
