Pursuant to the Illinois Freedom of Information Act (5 ILCS 140)

**Scope of Request:**

All products from: School Asset Manager, Collaborative Student Transportation, Prismatic Services Inc, and TransPar Group

We are seeking records from 2022 to now that reflect the pricing structure of any such engagement, including (if available), per-unit costs, subscription or licensing terms, and/or implementation fees.

We are looking for the following types of records:

- Contracts, service agreements, order forms
- Purchase orders relating to the above vendors
- RFP or solicitation documents
- Task orders issued against cooperative purchasing agreements

Where portions of the requested records may be withheld under an applicable exemption, we ask that all reasonably segregable non-exempt portions still be produced.

This request *is* being submitted for commercial purposes. We are willing to work within whatever procedures Gurnee SD 56 uses for handling such requests, and are happy to clarify, narrow, or adjust the scope to reduce the burden on your office.
