- C. The previous version of the Budget has been deleted in its entirety and replaced as outlined in attachment B-1. All references to the maximum reimbursable amount shall be amended from **\$144,650.00** to: **\$212,150.00**

All other terms and conditions of the Contract, including prior amendments, shall remain in full force and effect.

SOW Details:

For FY 2026-2027, this one-year extension provides continued access to the Benefit Navigator platform following the initial pilot year. The approved scope is limited to Benefit Navigator platform licenses, standard platform support, standard dashboards, user account administration, product updates, and related services included in the standard licensing model. User access shall be limited to First 5 Riverside County staff and approved partner users, subject to available licenses and applicable privacy, security, confidentiality, and user-access requirements.
