Description of Request: Traffic cones are a great choice for managing traffic flow and improving safety, in school zones where student crosswalks are involved. Here are some of the many ways they will be used at our campus:

1. **Placement of Cones:** Position cones along the traffic lane near the student crosswalk to create a visible boundary, guiding cars to slow down and stay on track.
2. **Highlight Crosswalk Entry and Exit:** Place cones at both ends of the crosswalk to make it more visible to drivers and to mark where pedestrians will be crossing.
3. **Create a Safe Waiting Zone:** Use cones to designate a safe waiting area for students near the crosswalk, helping them stay at a safe distance from passing traffic until it's time to cross.
4. **Reflective Cones for Visibility:** cones with reflective strips or ones designed for higher visibility, especially if they'll be used during low-light times like early mornings or evenings.
5. **Portable Stop Signs:** Adding portable stop signs next to or attached to cones near the crosswalk can reinforce the message for drivers to stop and be extra cautious.


