X Tour and Cancellation Policies:

Initials

The provisions of this contract are based on a minimum of 50 paying persons. Should an individual cancel after depositing, Straight A Tours & Travel will retain the advance deposit in the amount stated above. Once we receive your rooming list any additional people over and above the initial deposit are considered deposited. Individuals canceling within Ninety days of their arrival date will forfeit the total amount of the package price. Any individual can be replaced with another individual sixty days prior to travel (Excluding Airfare). Straight A Tours & Travel reserves the right to make changes in the itinerary, accommodations, and services, provided the situation warrants such action.

X Penalties:

Initials

- Fees will be charged for all returned checks in which payment has been refused by the payer bank due to insufficient funds or no account.
- If final balance is not received by the due date there will be a \$25.00 per person late fee charged. If you are within 90 days of arrival and final payment has not yet been received the only form of payment accepted is a Cashier's Check or a Money order or wire transfer. If you are within 60 days to your trip, the final balance must be wired into our account prior to arrival.
- All arrangements are being held on a tentative first option basis until your deposit date. However, should another party request the dates and be in a position to confirm immediately, you will be advised and given (7) days to confirm on a definite basis or alternate dates can be researched and held for your use. If the contract is not received by the deposit date, the space will automatically be released unless other arrangements have been made with your representative in advance.
- Straight A Tours or any of its vendors is not responsible for any missed activities due to traffic, individual or group-related problems, Covid-19, war, weather, pandemics or any other circumstances beyond its control. Straight A Tours will, to the best of its ability, attempt to rebook any missed events wherever possible on behalf of the group.
