School-Owned Split Dollar Life Insurance Policies – Authorized Personnel

In 2001, the District began the practice of purchasing school-owned split-dollar life insurance policies as a means of providing a collectively bargained life insurance benefit to certain administrative employees and to the District’s Principals. Upon initiation of this practice, District administration sought and received a favorable legal opinion from its legal counsel, Briggs and Morgan, that such a practice was permissible. This longstanding practice has been financially advantageous to the District and to the District’s taxpayers.

The District administration recommends that the School Board affirm existing policies as of August 1, 2021 as follows:

- 96 Northwestern Mutual Life Insurance Company agreements
- 77 Mass Mutual Life Insurance Company agreements

Statement of Revenues Analysis

This analysis reflects revenue received by the month end noted above. Overall revenues are consistent with prior years with the exception of the Debt Service Fund. On June 28, 2021 the School Board approved the sale of bonds to refund the Series 2014A and Series 2014B General Obligation bonds. The District received the proceeds of the refunding bonds, the Series 2021A Taxable General Obligation School Building and Alternative Facilities Refunding Bonds, on July 22, 2021. The proceeds received by the District totaled \$137,249,726 and will be used to refund all maturities of the 2014A and 2014B bonds in February 2023, generating savings for taxpayers of the District in future years.

Statement of Expenditures Analysis

This analysis reflects actual expenditures and does not include outstanding encumbrances. Overall expenditures are comparable with prior years with the exception of the Debt Service Fund. As noted above, the District executed the sale of refunding bonds and received the proceeds of the sale in July. Also in July, the District remitted the proceeds of the sale to the escrow agent responsible for making required principal and interest payments on the bonds. This transaction increased expenditures and other financing uses by the figure noted above.

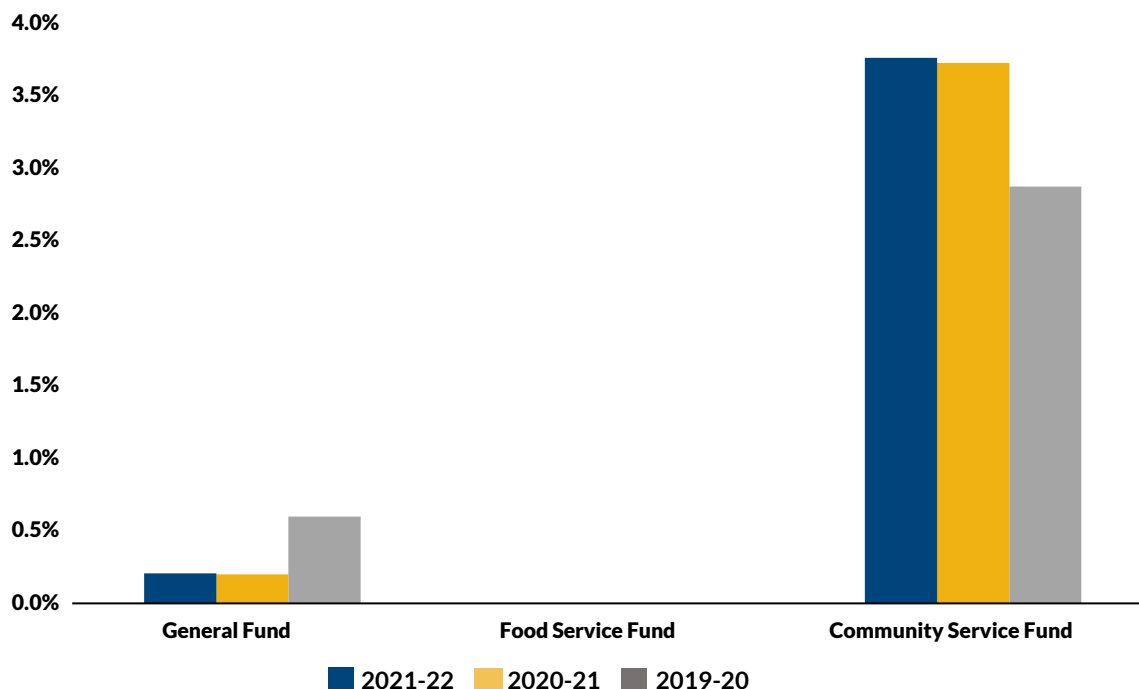

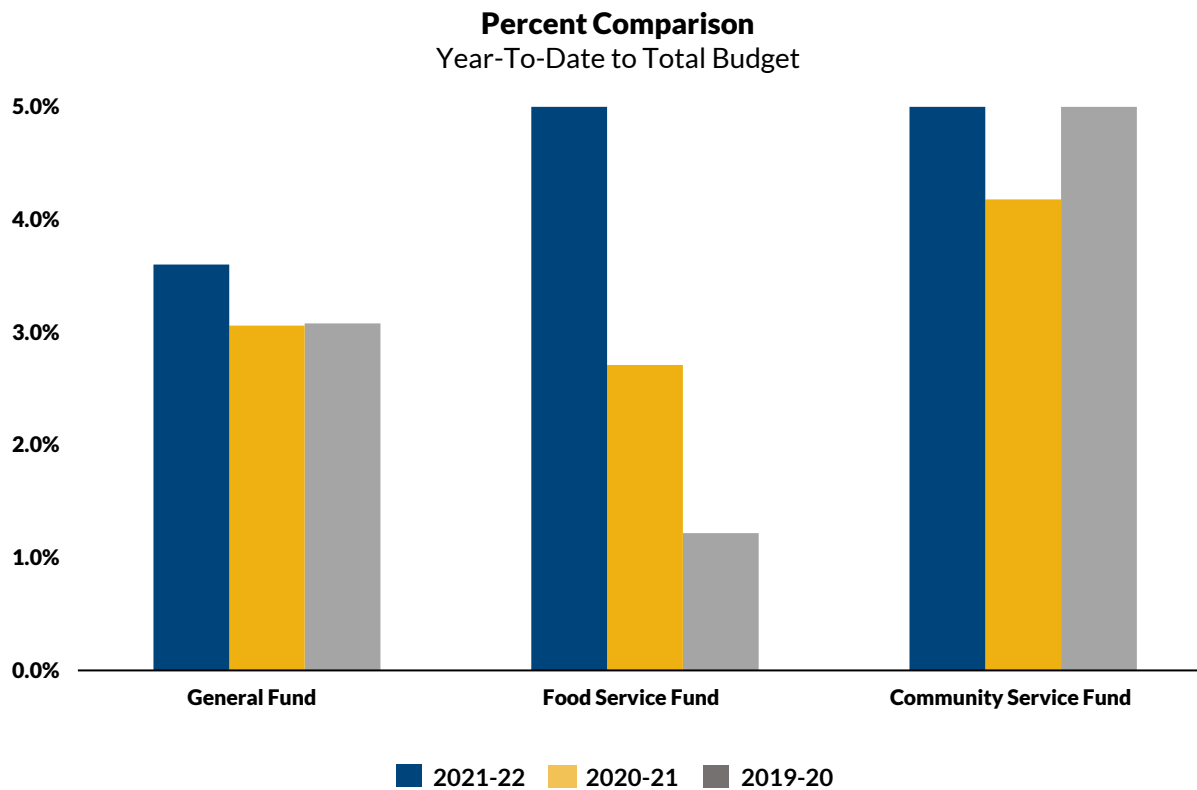

1) Review of the Board Approved, September 9, Special Meeting, Contract with Wayzata Education Association for Fiscal Years 2021-2023

The School Board’s Bargaining Team and the Wayzata Education Association representatives reached a tentative contract agreement on July 21, 2021. Subsequently, the WEA teachers voted on Wednesday, September 8 to ratify the contract. On September 9, 2021 during a special meeting the WEA Contract was approved by the board. As a reminder, a special meeting was necessary in order to allow for the proper processing time necessary to meet payroll’s deadline of September 15, 2021.

In summary:

The District and the WEA negotiations team engage in Interest Based Bargaining and worked on over thirty issues from May through July. A few of the issues we reached agreement on included 403(b) contributions, Child Care Leave, Special Education stretch calendars and due process days. We created guidelines for teacher involvement should the district implement an Online Learning School and we worked through overall salary and extra-curricular salary increases which were negotiated at 2.5% in year one and 2.9% in year two.

The negotiations team members were; Peter McKown, Aaron Berndt, Andi Cohen, Tina Christopherson, and Clarice Jorenby, Wayzata Education Association; Andrea Cuene and Cheryl Polzin, School Board; DeeDee Kahring, Executive Director of Finance and Operations; Mert Woodard, Director of Business Services and Stacie Vos, Executive Director of Human Resource Services.

I would like to express my appreciation for the collaborative efforts put forth by the negotiation team members throughout this process. The team’s collective ability to resolve issues in a positive and respectful manner benefits all our entire school community.

Board Report: Dr. Anderson 2021 Annual Performance Review Summary

On September 2, 2020, the members of the Wayzata School Board met with Dr. Chace Anderson to review his goals for the 20-21 school year. In 2020, Wayzata School District faced a once-in-a-generation pandemic which required decisiveness, equanimity, and leadership to navigate. In addition, there was racial and political unrest across the country and close to home.

These circumstances were the backdrop for his goals of 1) improving racial equity across Wayzata Schools; 2) reducing the opportunity/achievement gap; 3) enhancing the focus on health and well-being of Wayzata Students, and 4) creating a management structure commensurate with the needs of the growing district.

Through these extraordinary times, Dr. Anderson created an extensive list of goals and action steps that would address the current and emerging needs of our District. Over the course of the year, Dr. Anderson provided quarterly updates regarding his work, and the Board would like to commend him for maintaining this focus, despite the continued disruptions brought on by the pandemic.

At the July 26, 2021 work session, Dr. Anderson provided a summary of his progress and Board members subsequently provided feedback regarding his strengths and areas for growth.

At the August 25, 2021 closed Board meeting, the School Board met with Dr. Anderson to discuss the results of his performance review.

Tonight, we would like to share a summary of our findings.

Some of Dr. Anderson's demonstrated successes in relation to the goal areas include:

Improve Racial Equity across Wayzata Schools. Examples of progress include launching the Equity Commitment aligned to the strategic directions and supporting Human Resources in documenting and standardizing the process for recruiting staff and teachers of color.

Reduce the Opportunity/Achievement gap. Examples of progress include supporting community education and parent programming dedicated to addressing the opportunity and achievement gaps.

Enhance the focus on Health & Well-being of Wayzata Students. Examples of progress include using the best data available to meet the mental health and well-being need of our students during the pandemic. Successfully distributing food to our students and families during the pandemic. And hiring additional student support staff and nurses in the district.

Create a Management Structure commensurate with the needs of the growing district. Examples of progress include creating the role of, and successfully hiring, a new Associate Superintendent and hiring a highly experienced Executive Director of Teaching and Learning and Executive Director of Business and Finance.

In addition to the above successes seen in the identified 4 goal areas, Dr. Anderson also demonstrated progress in his commitment to the District's three Vision areas.

Exceptional Student Learning, Experiences, And Relationships- during the pandemic. Examples of progress include focusing on, and providing leadership for, the development of comprehensive and educationally sound learning plans that provided meaningful educational experiences for students in distance, hybrid, and in-person learning that underscored personalization and challenged the teams to meet the diverse learning needs of our students.

Community Trust, Confidence and Partnership. Examples of progress include responding thoughtfully to 1000s of emails from parents, teachers, and community members, displaying empathy, professionalism, and a commitment to building relationships and earning community trust. Maintaining and improving our AAA bond rating, refinancing bonds to save taxpayers millions over ten years, and protecting the District's financial viability through continued commitment to fiscal prudence and financial discipline, even during a global pandemic.

Operational Excellence. Examples of progress include remaining committed to providing comprehensive quarterly updates on progress toward achieving your established goals, despite the incredible demands of leading the district through a global pandemic and the need for multiple learning model changes.

Opportunities for Improvement:

The Board recognizes that, even in the context of remarkable success, there is always room for growth and improvement. Below are some of the suggestions for Dr. Anderson's improvement in the identified goal areas.

Improve Racial Equity across Wayzata Schools: Further define the Equity Commitment; build awareness, make tactical plans, implement a timeline, and make steady progress.

Reducing the Opportunity/Achievement Gap: Address the achievement gap by adopting, evaluating, and strengthening our assessment practices.

Enhance the focus on Health & Well-being of Wayzata Students: Continue to explore and implement opportunities to bring parents and students to the table as groups/task forces/ad hoc committees to seek perspective and input, capture student voice, and operationalize a commitment to collaboration and transparency.

Create a Management Structure commensurate with the needs of the growing district: Continue to focus on hiring diverse candidates and encourage HR to seek out and report on efforts in recruiting and creating diverse candidate pools.

Looking Ahead:

The Board looks forward to meeting with Dr. Anderson in the upcoming weeks to consider and define goals for the 2021-22 school year. At this time, the Board suggests that Dr. Anderson consider prioritizing measurable improvement in the achievement gap along with a continued focus on health and well-being and on-going refinement of the organizational structure. As we began in the past year, the Board will look forward to quarterly progress updates on the established goals.

In conclusion, the Board would like to commend Dr. Anderson on his progress, and specifically for his commitment to the ambitious list of goals. As the review indicated, even in the most challenging of times, Dr. Anderson displays exceptional leadership and an unwavering dedication to excellence for each and every student.

The Board is exceedingly grateful for Dr. Anderson's leadership and his tireless commitment to our students. Thank you Dr. Anderson for your excellent service to our District.
