A. Consider Approval of the Castleberry High School Phase 2 Furniture Bid awarded to Interior Resource Group in the amount of \$905,421.09. A total of 4 proposals were received in response to a competitive Request for Proposals (RFP). The evaluation process was conducted in accordance with applicable state purchasing laws and TASB purchasing guidelines, and the proposal submitted by Interior Resource Group was determined to meet the district's needs and provide the best value to the District. Funding for this purchase is included in the furniture soft costs budget allocated in the 2024 Castleberry High School Bond.

B. Consider Approval of the Request for Qualifications (RFQ) and Award of the Energy Savings Performance Project to Centrix Energy Partners LLC through the TIPS Purchasing Cooperative

This recommendation is based on the vendor's proven experience, technical capabilities, project methodology, and overall capacity to meet the District's goals related to LED retrofits, HVAC replacement, building automation system controls, and roof repairs and replacements. Purchasing through Centrix Energy Partners LLC complies with competitive bidding requirements under TIPS Contract 220104.
