Board Member Resignation

The Board believes that any citizen who files and seeks election or appointment to the Board should do so with full knowledge of and appreciation for the investment in time, effort and dedication expected of all Board members, and that the citizen's intent is to serve a full term of office.

When a member decides to terminate service, the Board requests earliest possible notification of intent to resign so the Board may plan for the continuity of Board business. Resignations must be made in writing. Board members can resign the office effective at a future date. If the resignation is effective at a future date, the resignation is binding unless withdrawn in writing by the end of the third business day after the resignation is made.

The Board will announce the resignation and declare the vacancy at a Board meeting.

The Board will determine the procedures to be used in filling the vacancy. The Board may begin a replacement process and select a successor prior to the effective date of resignation; however, the actual appointment shall not be made before the resignation date.

Vacancies on the Board

Vacancies will be filled through Board appointment. The Board appointee must be a legally registered voter and a resident within the district for one year immediately preceding the appointment.

In the event of multiple vacancies, the position vacated first will be filled first.

Upon appointment by the Board, the newly appointed Board member(s) will be sworn and seated immediately.

If the offices of a majority of Board members are vacant at the same time, the directors of the Douglas Education Service District shall appoint persons to fill the vacancies from qualified district voters.

Board elections are held every odd-numbered year which for the purposes of this policy are termed “election” years. The appointee will:

1. Serve until June 30 following the next election, at which time the individual elected in May of that year will fill the remaining portion of an unexpired term or serve a full four-year term; or
2. Serve until June 30 of a subsequent election year if the vacancy occurs after the filing date in an election year.

A Board member so elected as a replacement will serve the remaining year(s) of the term of office of the Board member being replaced.

Strategies for Differentiated Instruction (TAG, SPED, etc.):

Accommodations and modifications will be afforded students with special needs in compliance with their IEP & TAG individualized plans, and 504 accommodations as recommended by their respective teams. Guided notes will be used when determined. Students will be encouraged to use technology to assist in their completion of the various activities.

In addition, this course is full new material that should challenge all students. Students will receive a variety of challenging exercises and problems. Students may have the opportunity to develop their own problem to explore on the modeling project-based assessments. The students identified as TAG may work on additional activities such as programming the graphing calculator to accomplish routine problem solving.

Specific Learning Activities:

Learning Activities in Modernized PreCalculus include the following.

1. Taking notes. Students will take notes and use them to assist them in the daily activity.
2. Participating in class discussion (answering questions, seeking clarification etc.).
3. Completing assignments based on notes and participation.
4. Participate in groups to complete Modeling-Based activities.
5. Complete Modeling-Based Assessments (Projects) when assigned.
6. Meets Essential Skills for graduation requirements for mathematics via work samples, PSAT scores, or SBAC scores.

13. FOR THE GOOD OF THE ORDER

Mr. Craig Anderson, DHS Principal shared the team reviewed their student data and all classes showed over 80% of students are passing. Semester 1 grades showed that 97% of the junior class passed all their courses. The school staff are doing an excellent job helping students improve their education.

Mrs. Michelle Clarno, WMS Asst. Principal/AD reported the school will be hosting an “80’s” theme dance on the 23rd. The bands will be participating in a festival on the 24th and home track meet on April 30th which will be held at UCC. Volunteers are needed for the event.

Mr. Rob Holveck, WMS Principal said the staff are working on improving grades, but more focus on the social/emotional aspect. They are committing more time to an advisory program. Students were surveyed in regard to advisory and what they think they need. The results showed that 8th grade intervention groups should meet twice a week to help with their transition to high school.

Mrs. Emily Ledbetter, LES Principal said that after the students returned from spring break they focused on school rules to remind the students of what is expected. She also said one of their goals is a social media center and they have seen a significant number for next year’s registrations. The school will also be showcasing all the students’ accomplishments. Some of the districts teachers who implement Partner Talk were filmed by the reading coach and showcased their successful techniques in the classroom which will be shared with other area teachers. LES 5th graders will get to participate in a fishing field trip sponsored by Fish and Wildlife which will take place at River Forks Park in June. Students will learn about water and boat safety and also receive a fishing pole, tackle box and life jacket.

Mrs. Lisa Dickover, BES Principal said families are invited to attend a “Math” night on April 24th where teachers will be presenting games and activities geared toward math. Teachers are working hard to prepare for conferences. She also shared that most of the students returned from spring break ready to learn and were excited to be at school. She attributes that to the teachers and thanks them for all their hard work at making those connections with the students. The BES Booster club will be providing dinner for the teachers during parent/teacher conferences.

Mr. Kyle Micken, Food Service Dir. reported 40-50 students per day were served meals over spring break. The district hosted a food vendors showcase and invited students from WDSB schools to come and sample various products and to get their opinion on what food items to be offered next school year. Later this month on the 22nd will be the “Iron Chef” competition. He also shared that Doug Rec has started a spring soccer program for students’ grades 6th-8th and they have about 15 students participating.

Mrs. Norma Frost, MES Teacher shared that the school has a new member. Her name is Mocha and she is a 7-month-old Maltese and is very well behaved and does very well with the students. She also shared that the 5th grade staff and chaperones felt like they had been treated like royalty at Camp Grove and do not wish to attend anywhere else in the future. The feedback from students was very positive about their experience while there.

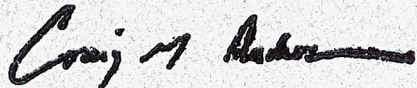

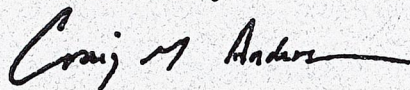

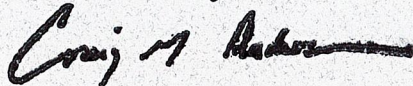

Purpose:

To provide Instructional Services for a specified group of students known as Expanded Options Students under the provisions of Senate Bill 300, Umpqua Community College (UCC) and Winston-Dillard School District agree to the following:

1. Provide UCC with the names and identification numbers of students in grades 11 and 12 who have been identified by the High School as eligible to enroll in UCC classes through the Expanded Options Program (EOP) for the academic year 26-27.
2. Complete the UCC EOP Student Authorization two weeks prior to the start of each term that students are eligible to register for classes. The authorization must include:
 - student name,
 - UCC student ID number or birthdate,
 - authorized course(s) for enrollment, and
 - additional (if any) textbooks, supplies and related software.
3. Provide UCC with the name of a high school representative contact for each EOP student referred to the College.
4. Retain the responsibility of providing special education and related services to eligible students with a disability. Student anticipating a need for accommodations should contact the UCC Accessibility Services Office.
5. Timely pay applicable agreed upon tuition (80% of the current rate), fees, books, and other required instructional course costs per student per term. Details are as follows:
 - a. Winston-Dillard School District will only pay for up to 12 credits per term and up to 36 credits per year.
 - b. Winston-Dillard School District will pay per-credit fees including the Student Resources fee, Legacy fee, and Instructional fee. In addition, Winston-Dillard School District will pay the \$25 credit registration fee if the student attends part-time. This fee is \$0 if the student is full-time.
 - c. Winston-Dillard School District will not pay for books, online resources, or additional course fees other than those listed above.
 - d. Winston-Dillard School District is not responsible for paying for a student who withdraws from the program before the term ends. If a student withdraws from Winston-Dillard School District before the end of the UCC term, students will be billed the full amount of the college expenses.

Umpqua Community College will:

1. Provide academic advising to each student as appropriate.
2. Not limit access to any classes other than by prerequisite requirements.
3. Provide notice of the tuition, fees, and other required instructional course costs as they are established by the College's Board of Education each spring.
4. Invoice the School District for application, tuition, textbooks, related software and fees per student per term. The remittance address and due date will be indicated on the invoice. All college policies as outlined in the current college catalog regarding student accounts, refunds and late fees will apply.
5. Provide guidance and links to registration information through the UCC website and student Self-Service account.
6. Comply with all applicable state and federal laws, rules and regulations that apply to student records. The records of student(s) enrolled at UCC are protected by the Family Education Rights and Privacy Act (FERPA).
7. Award post-secondary credit for any eligible course successfully completed for credit at the institution if the course is considered by the institution to be a college-level course.

Career Academy Program:

The school district will be responsible for tuition only (billed at 80%) for students participating in a Career Academy Program. UCC has obtained funding to cover textbooks and fees.

Terms:

The term of this contract shall be for the 26-27 academic year. Either party may cancel this agreement with 30 days written notice. Such cancellations shall not be cause for additional charges to either party. Courses already in progress shall be permitted to operate until the end of the current term when cancellations are in effect.
