BOE Meeting

 - 3.1 Public Comments – Dr. Stirn and President Gorman thanked guests and members visiting remotely.
 - 3.2 Public Comments – A community member brought her concerns about kindergarten social emotional curriculum and 4th grade social studies was addressed.
4. Action Items
 - 4.1 Consent Agenda– Business Manager Pflug presented the financials for January. Revenues are currently at 37.04% compared to 45.17% a year ago. Expenditures are at 39.66% compared to 40.17% a year ago. The district received impact fees for 15 new home starts in December totaling \$121,286.29 in impact fees. The January bills payable was typical.
 - 4.2 Approve Cafeteria Bids -- Dr. Stirn covered the bid information for the cafeteria expansions at Country Trails and Prairie Knolls Middle School. Several bids were received for the various items on the bid specifications. One alternate bid was accepted to replace the existing cafeteria flooring at Country Trails and Prairie Knolls.
 - 4.3 Approve Bus Bid -- Director Porto shared the bid results with the board. Bid specifications were sent to six (6) companies, and only one (1) bid was received. Midwest Transit will supply the buses for the 2022-2023 school year.
 - 4.4 Release of Closed Minutes – Dr. Stirn reported that personnel reports can be shared publicly, but issues related to litigation, information related to students and negotiations are not released to the public.
 - 4.5 Approve the 2022-2023 School Year Calendar – the calendar was brought back this month with the changes requested. One teacher institute day was added to the start of the school year for staff preparation.
 - 4.6 Accept Donation from Kane County Farm Bureau Foundation – The farm bureau annually awards FFA groups who volunteer their time in different community programs. The Central FFA group received \$500 that will help with expenses for their leadership retreat.

5. Information Items
 - 5.1 Enrollment – The report for January shows three years of historical data. Last year at this time enrollment was down by five students from the previous year, but this year we have increased 363 students.
 - 5.2 Mobile Unit Installation and Capital Project Update – Dr. Stirn shared that the mobiles at Country Trails are 90% completed and HBT is 75% complete. Lily Lake is 60% complete and needs to have the waste system installed along with the white boards and plumbing. Prairie View just needs the skirting finished and the punch list completed. For capital projects, the boiler and HVAC at Lily Lake may need to be replaced and maintenance is installing a generator at Lily Lake.
 - 5.3 ELA Textbook – Curriculum Director Birkmeier presented the new series IntoReading. The series was approved by the SAC committee and piloted at every grade school by teachers in each grade level.
 - 5.4 Data Analysis - . Dr. Mongan presented the 2021 student assessment data. IAR test data was also reviewed. Students were on a hybrid schedule last year and that impacted much of the data. Dr. Mongan also shared the percentage of student characteristics reported in the school report cards. The characteristics showed that the district has become more diverse at all schools except Lily Lake.

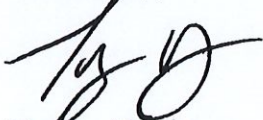

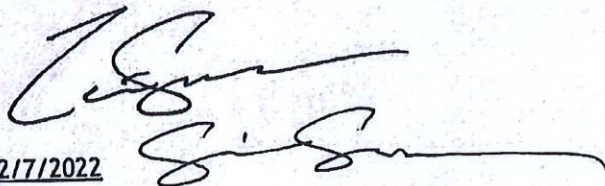
