5. **Petitions and Hearings** It is the practice of this Board of Education to provide a place on the agenda for and welcome comments and suggestions from the public. The School Board will allocate an overall minimum of 30 minutes for public participation. During public participation, there will be a 20-minute minimum total length of time for any one subject. The time for any one person to address the Board during public participation shall be limited to five minutes.

2:230 Public Participation at School Board Meetings and Petitions to the Board

The School Board will allocate an overall minimum of 30 minutes for public participation (any person may comment to or ask questions of the School Board). The public participation session of the School Board meeting is subject to the reasonable constraints established and recorded in this policy's guidelines below. During public participation, there will be a 20-minute minimum total length of time for any one subject. When public participation takes less time than these minimums, it shall end.

To preserve sufficient time for the Board to conduct its business, any person appearing before the Board is expected to follow these guidelines:

1. Address the Board only at the appropriate time as indicated on the agenda and when recognized by the Board President.
2. Identify oneself and be brief. Ordinarily, the time for any one person to address the Board during public participation shall be limited to five minutes. In unusual circumstances, and when an individual has made a request to speak for a longer period of time, the person may be allowed to speak for more than five minutes.
3. Observe, when necessary and appropriate, the:
 - a. Shortening of the time for each person to address the Board during public participation to conserve time and give the maximum number of people an opportunity to speak;
 - b. Expansion of the overall minimum of 30 minutes for public participation and/or the 20-minute minimum total length of time for any one subject; and/or
 - c. Determination of procedural matters regarding public participation not otherwise covered in Board policy.
4. Conduct oneself with respect and civility toward others and otherwise abide by Board policy 8:30, *Visitors to and Conduct on School Property*.

Petitions or written correspondence to the Board shall be presented to the Board in the next regular Board packet.

8:30 Visitors to and Conduct on School Property

The following definitions apply to this policy:

School property - District and school buildings, grounds, and parking areas; vehicles used for school purposes; and any location used for a School Board meeting, school athletic event, or other school-sponsored or school-sanctioned events or activities.

Visitor - Any person other than an enrolled student or District employee.

All visitors to school property are required to report to the Building Principal's office and receive permission to remain on school property. All visitors must sign a visitors' log, show identification, and wear a visitor's badge. When leaving the school, visitors must return their badge. On those occasions when large groups of parents/guardians, friends, and/or community members are invited onto school property or when community members are attending Board meetings, visitors are not required to sign in but must follow school officials' instructions. Persons on school property without permission will be directed to leave and may be subject to criminal prosecution.

Except as provided in the next paragraph, any person wishing to confer with a staff member should contact that staff member to make an appointment. Conferences with teachers are held, to the extent possible, outside school hours or during the teacher's conference/preparation period.

Requests to access a school building, facility, and/or educational program, or to interview personnel or a student for purposes of assessing the student's special education needs, should be made at the appropriate building. Access shall be facilitated according to guidelines from the Superintendent or designee.

The School District expects mutual respect, civility, and orderly conduct among all people on school property or at a school event. No person on school property or at a school event (including visitors, students, and employees) shall perform any of the following acts:

1. Strike, injure, threaten, harass, or intimidate a staff member, Board member, sports official or coach, or any other person.
2. Behave in an unsportsmanlike manner, or use vulgar or obscene language.
3. Unless specifically permitted by State law, possess a weapon, any object that can reasonably be considered a weapon or looks like a weapon, or any dangerous device.
4. Damage or threaten to damage another's property.
5. Damage or deface school property.
6. Violate any Illinois law, or town or county ordinance.
7. Smoke or otherwise use tobacco products.
8. Distribute, consume, use, possess, or be impaired by or under the influence of an alcoholic beverage, cannabis, other lawful product, or illegal drug.
9. Be present when the person's alcoholic beverage, cannabis, other lawful product, or illegal drug consumption is detectable, regardless of when and/or where the use occurred.
10. Use or possess medical cannabis, unless he or she has complied with policy 7:270, *Administering Medicines to Students*, implementing *Ashley's Law*.
11. Impede, delay, disrupt, or otherwise interfere with any school activity or function (including using cellular phones in a disruptive manner).

12. Enter upon any portion of school premises at any time for purposes other than those that are lawful and authorized by the Board.
13. Operate a motor vehicle: (a) in a risky manner, (b) in excess of 20 miles per hour, or (c) in violation of an authorized District employee's directive.
14. Engage in any risky behavior, including roller-blading, roller-skating, or skateboarding.
15. Violate other District policies or regulations, or a directive from an authorized security officer or District employee.
16. Engage in any conduct that interferes with, disrupts, or adversely affects the District or a School function.

Convicted Child Sex Offender

State law prohibits a child sex offender from being present on school property or loitering within 500 feet of school property when persons under the age of 18 are present, unless the offender is:

1. A parent/guardian of a student attending the school and has notified the Building Principal of his or her presence at the school for the purpose of: (i) attending a conference at the school with school personnel to discuss the progress of his or her child academically or socially, (ii) participating in child review conferences in which evaluation and placement decisions may be made with respect to his or her child regarding special education services, or (iii) attending conferences to discuss other student issues concerning his or her child such as retention and promotion; or
2. Has permission to be present from the Board, Superintendent, or Superintendent's designee. If permission is granted, the Superintendent or Board President shall provide the details of the offender's upcoming visit to the Building Principal.

In all cases, the Superintendent, or designee who is a certified employee, shall supervise a child sex offender whenever the offender is in a child's vicinity.

Exclusive Bargaining Representative Agent

Upon notifying the Building Principal's office, authorized agents of an exclusive bargaining representative will be provided reasonable access to employees in the bargaining unit they represent during duty free time in accordance with State law. Such access shall be conducted in a manner that will not impede the normal operations of the District.

Enforcement

Any staff member may request identification from any person on school property; refusal to provide such information is a criminal act. The Building Principal or designee shall seek the immediate removal of any person who refuses to provide requested identification.

Any person who engages in conduct prohibited by this policy may be ejected from school property. The person is also subject to being denied admission to school events or meetings for up to one calendar year.

Procedures to Deny Future Admission to School Events or Meetings

Before any person may be denied admission to school events or meetings as provided in this policy, the person has a right to a hearing before the Board. The Superintendent may refuse the person admission pending such hearing. The Superintendent or designee must provide the person with a hearing notice, delivered or sent by certified mail with return receipt requested, at least ten days before the Board hearing date. The hearing notice must contain:

1. The date, time, and place of the Board hearing;
2. A description of the prohibited conduct;
3. The proposed time period that admission to school events will be denied; and
4. Instructions on how to waive a hearing.

1. Facility Projects for 2021-22

Mr. Hoster reviewed the issue of Hufcor and their fallout from not only our project but the industry in general. Apparently the company is unable to fulfill orders. Mr. Hoster indicated that we have moved on from Hufcor and contacted Modernfold who has an 8-10 week leadtime. The cost which we received from Modernfold for the Addison Trail room divider curtain is \$39,445.00 which is an increase of \$2,810 over the previously accepted Hufcor price of \$35,690.00. There are no other vendors that have been bidding on these divider curtain projects, other than third party vendors who are going through either Modernfold or Hufcor to obtain their pricing. The committee was in support of moving this project along. Mr. Hoster will bring the recommendation to the upcoming Board meeting.

2. Facility Projects for 2022-23

Mr. Hoster let the committee know that we are also investigating a divider curtain at Willowbrook for Room 130. We had Modernfold out to provide a quote which came in at \$38,500.00. Room 130 is currently a computer lab that we are converting into a classroom this summer with the divider curtain providing for a smaller classroom or flexible learning space. This project would be funded from the building in-house facility improvement allocation for 2022-23. The committee was in support of moving this project along. Mr. Hoster will bring the recommendation to the upcoming Board meeting.

Mr. Domeracki presented to the committee the recommendation to purchase extensions for the auditorium forestage at Addison Trail. These units would cover the open wing spaces on each side and address a safety issue when using this section. We obtained two quotations and recommending acceptance of the proposal from Wegner Corp. in the amount of \$9832.01. This would be funded from the building in-house facility budget for 2022-23. The committee was in support of moving this project along. Mr. Domeracki will bring the recommendation to the upcoming Board meeting.

Mr. Hoster presented four new projects for consideration to complete in 2022-23 now that we have deferred the major projects due to bids exceeding the budget estimates. Three for Willowbrook including female locker replacements, backstop replacement for both freshman baseball and freshman softball fields. In addition, the auditorium rigging inspection corrective work for Addison Trail. We have current pricing for each of these and the total budget for these projects would be \$245,750. The committee was in support of moving forward with these projects. Mr. Hoster will bring this revised Building Improvement Projects for 2022-23 to the May 23, 2022 board meeting so that we can begin our bidding process.

3. Master Plan - Project Priorities for 2023-24

Mr. Hoster reviewed the updated Building Improvement Project list for 2023-24 which now reflect the updated budget estimates from Wight and Co. in addition to 20/10 Engineering. The revised budget for both the deferred 2022-23 and new 2023-24 projects reflects an increase of \$433,119. Mr. Hoster outlined the increase in budget estimates of \$144,040 to the HVAC replacement and air conditioning work at Addison Trail. Mr. Hoster is asking for a budget increase to accommodate the increase in cost of this project.

Mr. Hoster continued to provide additional updates on some of the pricing that we are seeing as we begin to gather quotes. One of the projects, the turf field replacement for Addison Trail, has increased by approximately \$123,000, not including an alternate shock pad. The ongoing professional maintenance from Turfix and Gmax hardness testing two times each year indicate that all fields in the district are in really good condition. In addition to adding Ecofil to them periodically. We are recommending that this be deferred until 2024-25 at the earliest.

Mr. Hoster also reviewed the boiler projects at Addison Trail and Willowbrook; and the pricing increase of approximately \$124,000 caused by the supply chain issues and the rising costs of steel. The only project still awaiting budget adjustment is for

the concrete replacement which Mr. Buck said he would have before the next June 7, 2022 committee meeting. The administration will have a final recommendation for the committee for that meeting with the goal of bringing the 2023-24 project list to the full board for approval at the June 20, 2022 board meeting. The tentative budget estimate for 2023-24 projects is \$3.8 million and without the artificial turf field it would be \$2.8 million. We continue to develop strategies for bidding the projects next year to maximize success based upon the unique circumstances for each type of project. Consideration of bidding for the replacement HVAC equipment and either paying for storage or renting a facility are options to consider given that we can't even begin the demolition process for such work without having delivery of the actual replacement equipment.

4. Architect/Engineer Services for 2023-24

Mr. Hoster reviewed the Wight fee proposals for the design, bidding, construction work of the CTE spaces air conditioning project which had a fee of \$84,000. In addition, Mr. Hoster reviewed the Wight fee proposal for the design, bidding, and construction of the boiler work at both schools. This work had a fee of \$38,000. There was no concerns from the committee regarding the fees. Mr. Hoster will bring this fee recommendation to the upcoming Board meeting.

5. Other items and Building Reports

Mr. Domeracki presented to the committee the recommendation to purchase a replacement projector screen for the auditorium at Addison Trail. The recent auditorium inspection by Chicago Flyhouse identified a number of areas that need corrective action but this one is more urgent. We obtained pricing from three companies and are recommending the most competitive from Vertigo in the amount of \$14,995.43. This would be funded from the building in-house facility budget for 2022-23. The committee was in support of moving this project along. He shared that he included students in the discussion about what they'd like to see within the building. Mr. Andrews also shared the graphical decal layout for some of the areas within the building. The quote that Bannerville gave was approximately \$15,000 for all areas combined. We will continue our work on this before we bring it to a Board meeting for approval and it would be part of the building budget for 2022-23.

Dr. Krause shared that in addition to the request to begin the fencing replacement for freshman fields, the varsity softball is also a need due to the deteriorating backstop. However, they want to do a thorough evaluation of the work needed, keeping in mind the other amenities that the varsity baseball field has and some improvements they would like to consider.

The public notice was published May 17, 2022 (see attached) in accordance with the thirty-day requirement. In addition, copies of the budget were made available in the main office and placed on our district website. To date there have been no inquiries regarding this proposed amended budget. Following the required public hearing session Monday, June 20, 2022, we are recommending adoption of the attached Amended Budget for fiscal year 2021-22 by approving the attached resolution. The recommendation to amend the budget is being made for the following reasons:

- To recognize the sale of Working Cash Bonds in the amount of \$4,002,089 with the final closing as of October 19, 2021.
- To recognize the added expense for purchasing two more replacement buses in August 2021 in the amount of an additional \$162,900. The original capital budget was for \$330,000 and should now be \$492,900.
- To recognize the added revenue/transfer from Working Cash to Transportation Fund in the amount of \$162,900 for the replacement buses. The original budget was \$330,000 and will now be \$492,900. We will also add the receipt of said transferred amount to the Transportation Fund. The board approved the August 2021 bus purchase/transfer in December 2021 for \$492,900.
- To recognize the Illinois State Board of Education matching maintenance grant proceeds of \$50,000 that was awarded for this summer 2022 roofing replacement but the state already paid us in advance.
- To reflect the corrected transfer of funds from the Working Cash Fund for 2022-23 as we pre-fund the next fiscal year facility projects due to the accrual accounting requirements since this fund does not carry a reserve sufficient to cover the obligations. We originally planned to transfer \$1,100,000 for the summer 2022 projects but those were all rejected except for the roofing project.
 - The transfer to the Capital Projects Fund will be reduced from \$1,100,000 to \$0 as we only awarded the roof replacement project for summer 2022 and that will be paid from the Operation & Maintenance Fund. Therefore, the only additional expenses will be for

the architect/engineering services to plan for the 2023-24 projects to be designed and bid. As of March 2022, the Capital Projects Fund balance is sufficient at \$340,000.

- To adjust the IMRF Fund to increase the total expenditure budget of \$2,114,970 by \$85,030 to \$2,200,000 so that we don't exceed the total fund budget as required by Illinois School Code. Increased expenditures relating to the federal ESSER grants and other salaries that drive expenses for Medicare, Social Security and IMRF pension continued to trend 3% higher than expected benchmarks since February 2022.
- To adjust the Transportation Fund to increase the total expenditure budget by \$400,000 to avoid exceeding the total fund budget as required by Illinois School Code. The increased expenditures for homeless and special education outside placements will both exceed the original budget allocation. As of April 2022, they are at 97% and 89% expended respectively. Furthermore, the fund overall expenditures are trending 8.0% higher than expected benchmarks as of April 2022, excluding the purchase of two additional buses mentioned above.
- To reflect the Teacher Retirement System (TRS) on-behalf contribution in the amount of \$30,000,000. This is an annual amendment that is required to meet the state board requirements for an accurate budget that reflects this on-behalf contribution. This on-behalf amount represents the state share of the annual contribution to the TRS pension fund for our district. There is a corresponding revenue and expense added to the budget so the net impact is \$0.00 but this is still required in accordance with the accrual accounting standard GASB 68.

Following the public hearing, I recommend that the Board of Education take the following action and complete the following documents:

1. Move that the Board of Education adopt the "Resolution to Adopt Amended Annual Budget" for 2021-22.
2. Signatures of the Board of Education on the official Illinois State Board of Education School District Budget Form #50-36 – All Members Present.
3. Certification signature by the Secretary of the Board of Education – page 1 "Budget Summary of Cash Transactions", of the Final Amended Annual Budget for 2021-22.

RE: Fiscal Year 2022-23 Tentative Budget

The 2022-23 Tentative Budget is presented to the Board of Education for review and further discussion. This budget is considered a “tentative” version in that there are some unconfirmed sources of funding and uses of funds that still need to be finalized before adoption at the September 26, 2022 meeting. In particular, we will be filing the end of year state and federal claim reports in July which will determine the funding reimbursement amounts for 2022-23. Therefore, due to timing, we will always be waiting for these final funding determinations when placing the tentative budget on file for the public access and review in June. However, we will finalize and update the tentative budget in time for adoption at the September meeting as required by Illinois School Code. The good news is that the state has once again approved the education funding budget. Therefore, the major state funding is known and we will just be waiting for them to complete the adequacy formula calculations to see what level of additional funding may be forthcoming. We have assumed level funding from the current fiscal year for the next school year until we know otherwise. Secondly, the June installment of property tax receipts are just arriving so we only have two of the three payments for the advance or “early” June property tax collections. As this represents approximately 80% of our annual revenue, any fluctuations will impact the amount that we budget for the coming fiscal year 2022-23.

In addition, while the certified staffing has been completed as of the March student course registrations, the final staffing needs may still develop, particularly with ongoing special education assessments and final student enrollment during registration. This will take place throughout the summer and, routinely, we expect that many of the staff who were released in the spring will be returning as the special education enrollment continues to increase. In regards to major service provider contracts, all are in place including the transportation and food services.

At the June 20, 2022 board meeting all that is required by statute is Board of Education authorization to place the tentative budget on public display for a minimum of thirty (30) days before the scheduled public hearing and adoption. We are prepared to publish the required notice declaring that a public hearing will be held in September. The budget adoption schedule is as follows:

1. **June 20, 2022** - the Tentative Budget will be presented for authorization by the full Board of Education to place on public display for 30 days before the scheduled budget hearing on September 26, 2022 at 7:30 PM. The Secretary of the Board of Education will publish a notice of where, when, and during what hours the Tentative Budget will be on display for public inspection and the time and place for the budget hearing. *A copy of said notice is attached.*
2. **September 26, 2022** - at the regularly scheduled board meeting there will be a public hearing for the community to comment on the budget for fiscal year. Subsequent to that hearing the final budget will be presented for adoption, as required by the Illinois School Code.

While we all understand that the budget planning process reflects a conservative approach, given the unpredictable nature of the state and local economy, we are committed to exercising strong management of the expenditures throughout the year. Throughout the budget there are additional resources specifically aligned with a higher commitment to preparing students to be college and career ready. In addition, the ongoing commitment to investing the federal ESSER grant funding to continue the commitments that we made in the prior fiscal year. In prior years we have consistently been able to come in under expended by controlling the staffing, securing the best pricing through competitive bidding, scrutiny of purchasing requests, maximization of the building automation controls for utilities, verification of outside student placement attendance for tuition billing, etc.

The operating budget contingency remains the same for the coming year but we may adjust this upon the final closing results of the current fiscal year. Examples of the types of expenses that necessitate some contingency related budgeting include: staffing for unexpected teacher aide assignments, outside student placement tuition changes, staff paid leaves and substitutes, teacher advance studies tuition reimbursement and related salary increases for lane advancement, changes to staff insurance enrollment during the year, petroleum pricing for buses, utility expense, and unexpected facility or mechanical equipment repair/replacement, to name a few. We will continue to actively work toward achieving balanced budgets through intentional efforts with the Board of Education and staff in the coming year. This will entail important discussions to maximize revenue, control future costs, prioritize programs, secure best pricing and identify opportunities for efficiency.

At this time, although the Illinois School Code requires a balanced budget, we are within the allowable use of reserves as we have sufficient fund balances as outlined in the state budget form (see the last page of this report). According to the ISBE financial profile score, we are currently trending with 309 days “cash on hand” as of the prior year 2021, including the Working Cash bond proceeds. In addition, we have consistently received the highest designation of “Recognition” by the ISBE since the year 2003 and only for three of those years did we receive the third highest designation. Therefore, we are not required to submit a deficit reduction budgeting plan at this time.

HIGHLIGHTS AND KEY BUDGET DRIVERS REGARDING TENTATIVE BUDGET

GENERAL

Although the estimated cost of programs and services have historically outpaced available resources at budget time, we have historically prepared this financial plan with a conservative approach to both revenue and expenditures. During the past six years we have been able to consistently avoid financial deficits and fully restore the fund balances that we used during the prior economic downturn.

While the total budget is important, the primary focus will be on the Operating Funds Budget – which includes only the Education, Operation & Maintenance, Transportation, IMRF {pension} and Working Cash Funds. This definition excludes the restricted funds of Debt Service, Capital Projects and Health, Life Safety. The remainder of this report will focus on the Operating Funds and reference various pages throughout the supplemental Tentative Annual Budget Report (attached).

When reviewing Operating Funds, **revenues of \$79,620,504 reflect an increase of \$3,966,129 or 5.24% over the fiscal year 2022 budget.** (See page 4 of Tentative Annual Budget) The primary changes include the estimated distribution of Tax Increment Fund (TIF) remaining balance from Villa Park (\$600,000), increased CPPRT revenue (\$479,000), increased transportation state aid (\$491,000) in addition to restoring

all local revenue sources for registration, parking and food sales. This is in addition to the additional \$1,507,512 of property tax revenue.

The Operating Funds **expenditure budget of \$80,018,114 reflects an increase of \$2,042,459 or 2.62% over the fiscal year 2022 budget.** (See page 6). ***The Operating Funds deficit, including the inter-fund transfers, is projected to be (\$404,309) and the projected fund balance of \$59,401,991 as of June 30, 2023*** (See page 1, Budget Summary of Cash Transactions). This excludes the expected positive fund balance increase for the current fiscal year but does include the planned transfer of \$1,854,500 from working cash fund bond proceeds to the Capital Projects Fund and Transportation Fund.

The Tentative Budget reflects:

- A. Budgeted June 30, 2022 fund balance cash reserves.
- B. Estimated property tax collection percentages of 50.2% for 2022 (September) and 49.3% for 2023 (June) advanced or “early” taxes based on the historical trends.
- C. Preliminary estimates for state/federal funding based upon the most recent collections in the prior year and all available information.

OPERATING REVENUES: (see page 4)

Revenue in the Operating Funds (Education, Operations & Maintenance, Transportation, IMRF and Working Cash) are projected to increase by \$3,966,129 or 5.24%.

- Property tax revenue continues to be our primary source representing 84% of the operating budget, and is estimated to increase by \$1,507,512 or 2.56%.
- The September 2022 tax revenue budget is based upon the actual tax extension for 2021, representing the second and final installment of taxes.
- The December 2022 tax levy (June 2023 advance tax) ***will be based upon a 4.50% increase which is 90% of the full 5.0% CPI***, up from the prior year 1.40%, plus an estimate for new property.
- New property growth is estimated to be \$10.0M or 0.29% as there is no expiring TIF until the year 2029. We applied historical trend factors for both townships for the coming year as the real estate market remains strong at this time.
- The Corporate Personal Property Replacement Tax is estimated to increase by approximately \$479,000 as of tentative budget. This represents an increase of 20% over the current year budget. However, the actual revenue collected in fiscal year 2022 was 191% of the IDOR budget estimate. We will update this with the Illinois Department of Revenue final estimate when they release it in August 2022.
- Investment earnings remain level at the current fiscal year budget level for now. We will be placing investments throughout the summer and rates are increasing again so we expect the final budget to reflect an increase for the year. We will continue to monitor the market for ways to maximize the return with a focus on safety and liquidity.
- Other local revenue for textbooks, registration and other student related fees are expected to resume to the more normal 2021 level as we are no longer waiving them, other than event fees. This is also the same for cafeteria ala carte food sales as the federal lunch program has not renewed their “feed all students free” waiver for 2022-23. There are many groups still advocating for this at the federal level but nothing has been approved yet.

- The preliminary calendar year 2023 Illinois Municipal Retirement (IMR) board pension rate that we received for non-certified staff actually decreased to 5.30%. However, since this is a calendar year change, the average rate of 5.92% for the fiscal year **reflects a (2.0%) decrease over the prior year average.**
- Purchased Services includes many essential support services throughout the budget such as transportation, food service, insurance (workers compensation & property, casualty liability), financial audit, legal services, technology licensing, curriculum and student assessment consulting, athletic trainer, service contracts to maintain the facilities, along with many of the grant related program supports. Overall, this category of expense is ***projected to increase by \$841,016 or 8.80%***. There are a number of contractual increases for 2022-23 that are driving this.
 - The primary change is the transportation service contract that is increasing by 14.5% or \$488,000.
 - The expansion of athletic trainer services to now staff two full time trainers per school along with the rate increase added an additional \$72,000.
 - The technology services (including licensing) is increasing by \$193,000 to migrate the T-Mobile hot spots (\$115,000) from the federal ESSER grant along with many new system enhancements ranging from addressing language deficiencies noted in the recent ISBE audit to improvements to the core student information system (Powerschool) and the new Transversa transportation routing system.
 - The Chartwells food service contract rate will increase by 3.0% for 2022-23.
 - The district property, casualty insurance is estimated to increase by \$25,000, pending the final cyber insurance that is still being negotiated. The workers compensation insurance is declining by (\$66,000).
 - Unfortunately, the transportation needs of homeless families continue to be in demand but we amended the budget to \$210,000 for the prior year and will keep it at this level for 2022-23. Approximately 40%-50% of this is billed to other districts for reimbursement. In addition, we are able to claim this expense and receive state reimbursement for approximately 7% of our cost.
 - All other purchase service line items were increased by the approved 2% for the coming year which we hope will cover the volume of pricing increases from vendors who are passing along the fuel escalations and labor escalation.
- Supplies are estimated to increase by \$238,598 or 5.21% as we recalibrate from the heavy supply impact during the pandemic. The one area of concern is for electricity service which is expected to increase by 8% at this time. Unfortunately, the existing contract for electricity supply expires in December 2022 and the market rates are at least 50% higher than the expiring multi-year contract. The estimate for natural gas is expected to remain level at this time according to the consultant serving the Illinois Gas Cooperative. The gasoline supply budget was increased by 4% as the current year budget allocations were sufficiently under expended and should be able to sustain the coming year. The educational supply budgets at the building level were authorized to increase by 2% with the addition of \$8,000 for the auditoriums.
- Capital outlay is budgeted to decrease by (\$326,961) or 17% due to the reduction of funding for facility projects through the Operation & Maintenance Fund. The facility improvements of \$530,000, including some contingency, will be from the Operation and Maintenance Fund this year. In addition, we are budgeting \$255,000 for the purchase of three (3) replacement buses,

two less than the prior year and a reduction of (\$237,000). The technology capital budget is relatively level for the coming year.

- Tuition for special education, alternative education, and vocational programs is projected to remain relatively level to the prior year as of the tentative budget. Although the placement process continues throughout the summer, we are hopeful that this will be sufficient for the coming year. The transition program enrollment remains strong and we continue to achieve the collective goal of finding the best placements for students with careful consideration of the alternatives. The vocational program enrollment at TCD will increase by 23 students for the coming school year, in alignment with the post pandemic commitment to maximizing student opportunities. This additional expense will be covered by the federal ESSER grant and the IDEA grant for 2022-23.

Detailed revenue and expenditure budget information by fund compared to the prior year budget is as follows. All reserve estimates are from the prior year budget as the fiscal year has not closed yet.

EDUCATION FUND {pages 9 through 16}

The Education Fund revenues are projected to be \$66.7 million compared to expenditures of \$65.4 million which equates to \$1,738,905 or 2.73% more than the prior year budget. The majority of this is driven by purchase services, supplies and benefits. We are currently projecting a surplus of \$1,300,435, net of the \$6,699 transfer out, with estimated reserves of \$40.6 million. Some of the key expense drivers are outlined below:

- Staffing/hiring for 2022-23 includes the reduction of 5.3 full time equivalent (FTE) positions and some continued staffing to be funded by the federal ESSER grant. Overall, salaries are projected to increase by \$924,022 or 2.08% as of tentative budget. Teacher contract salaries include a 1.20% base increase and the cost of step advancement is projected at 1.80%. Classified salaries are estimated due to ongoing bargaining. Student Supervisors will realize a base increase of 1.20% plus step and longevity. Teacher aides will realize an increase of 3.25% plus longevity as they do not have a step schedule. The administrative/management salaries are estimated to increase by the CPI of 1.40% before adjustments for staff changes or ongoing retirement transition planning.
- Staff benefits are projected to increase by \$328,067 or 4.57% over the prior year budget. Included in this category are medical/dental/life insurance premiums, tuition reimbursement and TRS pension expenses. As previously stated, the PPO medical increase is 6.50%, HMO is 7.70% and PPO dental increase of 2%. In addition, there is the increased cost of \$85,000 for staff enrollment to our program during the spring 2022 open enrollment which will be offset slightly by retirements.
- Purchased Services are projected to increase by \$333,820 or 6.91% which primarily reflects increase from areas outlined above on page 6. We discontinued the licensing (\$17,695) for Forecast 5 Analytics Five-Labs student benchmarking service as we moved to an internal dashboard for measuring and reporting on this critical student program performance data throughout the year.

- Supplies are budgeted to increase by \$133,272 or 5.43%, primarily due to the increased cost of Chromebook devices. This will be somewhat offset by the rental fee that we charge students over the four years of use. We are phasing out the use of the federal ESSER funding to assist with technology purchases in fiscal year 2022-23.
- Capital Outlay is projected to decrease by (\$11,750) or 1.93% driven primarily by the technology equipment replacement cycle.
- Tuition expense budget for special education, vocational and alternative education programs, is \$4,113,135 which reflects an increase of \$31,474 or 0.77%. This preliminary budget will continue to develop during the summer as more student placement decisions and enrollments are finalized. We did open up access to the TCD vocational programs and enrollment increased by 23 students to a total of 79 for the coming year. This is in addition to the 10 more students enrolled in 2021-22.
- Note: within the salaries budget is the continued commitment to invest the federal Elementary and Secondary School Emergency Relief (ESSER) resources. For example, the salaries for many positions we are staffing to address learning loss in 2022-23 include:
 - C.A.R.E Team instructional coaches approximately \$93,000
 - Diversity & Inclusion coordinators approximately \$112,000
 - Athletic coaching positions approximately \$140,000 (added 10 per building)
 - Social Emotional Learning (SEL) supports, professional development etc.
- Budgeted amounts for state/federal programs, grants etc. are based on the latest information available. Revenues and expenses are intended to offset each other.

OPERATION & MAINTENANCE FUND {pages 17 through 19}

The Operations and Maintenance Fund revenues are projected to be \$7.5 million compared to expenditures of \$7.8 million which equates to an increase of \$205,626 or 2.70% over the prior year budget. The projected deficit is (\$323,674) with reserves of \$6.0 million. The key expense drivers are outlined below:

- Salaries of \$3,411,475 which represents an increase of \$124,675. The base salary increase for this group is estimated pending the ongoing bargaining process. There were three retirements as of June 2022. Benefits are estimated to increase by \$35,123 or 5.11%, reflecting the rate changes previously mentioned above for the medical and dental programs.
- Purchase services budget is down (\$18,632) or 2.13% as we will not need to purchase and install Ecofil material at the artificial turf fields this year. In addition, repair to the baseball field at Addison Trail and the tennis court light pole painting were removed from the budget for 2022-23.
- Supply budget reflects an increase of \$95,326 or 4.89% at this time. Some of the discontinued purchase for personal protective equipment (PPE) relating to the pandemic is offset by the increase for utilities. We are continuing to purchase the higher quality MERV filters for the coming year.

- Capital outlay budget is down (\$30,866) or 3.81% reflecting the change of facility projects to be funded for the coming fiscal year.

DEBT SERVICE FUND {page 20}

Revenue and expenditures are based on the anticipated property tax revenue and required principal and interest payments for existing bonds.

- Debt service for principal and interest expense will be \$10.8 million for the coming year for the four remaining outstanding debt issues {Series 2015 A, 2015B, 2018 and 2021}.

TRANSPORTATION FUND {pages 21 through 23}

The Transportation Fund revenues are projected to be \$3.6 million including the transfer of \$254,500 from the Working Cash Fund, compared to expenditures of \$4.8 million **which equates to an increase of \$297,928 or 6.6% over the prior year budget.** The projected deficit of (\$1,180,962) is appropriate as we carefully manage the reserves of \$3.6 million. The key revenue and expense drivers are outlined below:

- Estimating state aid reimbursements to be up \$725,000 for regular/vocational and special education due to a full year of services in 2021-22 that will be claimable. This conservative budget that assumes the same prior year proration of our claims. We are hopeful that in the future the state increases the funding for these critical services to our full funding level.
- Purchase services are budgeted to increase by \$525,828 or 13.7% reflecting a 14.5% rate increase for Cottage Hill Operating Co. and less for the other related service providers. We included \$210,000 for the homeless transportation allocation for the coming year. The budget for supplies (fuel for the buses) is estimated to increase by \$10,000 for the coming year as we are currently trending well below the fiscal year 2022 budget level. This may be adjusted in the final budget.
- The board approved the purchase of three replacement buses at a cost of \$254,500 in March 2022 and we took delivery in July for the coming school year. This represents a reduction of (\$238,400) from the prior year purchase of six buses and will be funded from the year 2021 working cash bond proceeds reserved for the Transportation Fund.

IMR/SOCIAL SECURITY & MEDICARE FUND {page 24}

The IMR/Social Security & Medicare Fund revenues are projected to be \$2.0 million compared to expenditures of \$2.0 million which equates to a decrease of (\$200,000) or 9.1% over the prior year budget. The projected surplus is \$42,200 with reserves of \$2.0 million.

- The expenditures are projected to increase in direct correlation to salaries but the annual actuarial rate is declining by 2.0% so we are realizing a reduction in expense for the coming year. This fiscal year the rate will be 5.92% compared to 7.92% for FY2022. The state IMR pension fund investment portfolio helped to reduce our estimated actuarial rate for calendar year 2023.
- This fund also covers employer portion of the board matching share for federal social security and Medicare related payroll taxes.

CAPITAL PROJECTS FUND {page 25}

- The Capital Projects Fund reflects the planned facility improvement work that we are funding from the remaining working cash bonds issued in the year 2018 and the new series 2021 bonds. There is approximately \$352,173 remaining from the series 2018 bonds. We assigned \$3.3 million for facility improvements from the new series 2021 bond issue. Although there are no projects to be funded for 2022-23 we do intend to fund the summer 2023 projects. Therefore, the budget reflects the advance funding of \$1.6 million for those projects as we do not maintain a reserve balance in this fund.

WORKING CASH FUND {page 26}

- We are budgeting for the transfer of bond proceeds to the Transportation Fund for \$254,500 and \$1.6 million for the Capital Projects Fund.

FIRE PREVENTION AND SAFETY FUND {page 27}

- No activity has been budgeted in this fund as we have depleted any remaining funds and all outstanding Illinois State Board of Education approved Health/Life Safety work will be completed from operating funds.

BALANCED BUDGET LEGISLATION

Public Act 94-0234 became effective July 1, 2006 and requires that school districts adopt a “balanced budget”, and if the budget is not balanced, a deficit reduction plan must be submitted to the Illinois State Board of Education. ISBE defines a “balanced budget” as follows:

Total expenditures for the Educational, Operations & Maintenance, Transportation, and Working Cash funds will be compared to total revenues in the same funds. If the total expenditures are greater than the total revenues, the total deficit must be less than one-third of the total ending fund balance of the four funds.

The “balanced budget” calculations for the 2022-23 Tentative Budget:

A deficit reduction plan is not required by the District at this time as our projected deficit represents (0.98%) of the total projected ending fund balance, which is less than the 33% limit.

Suggested Motion:

Move that the Board of Education authorize the administration to publish the tentative budget for fiscal year 2022-23 for public review.

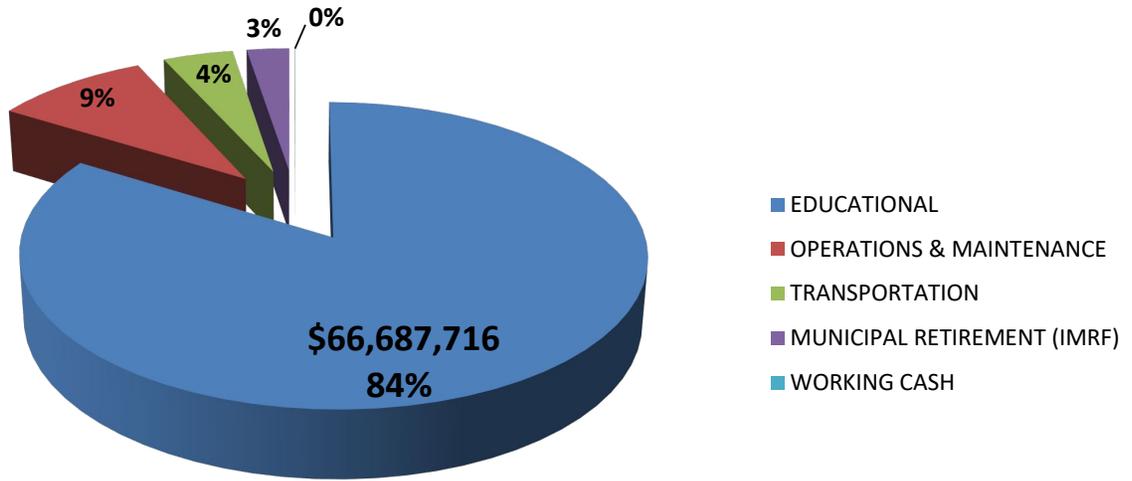

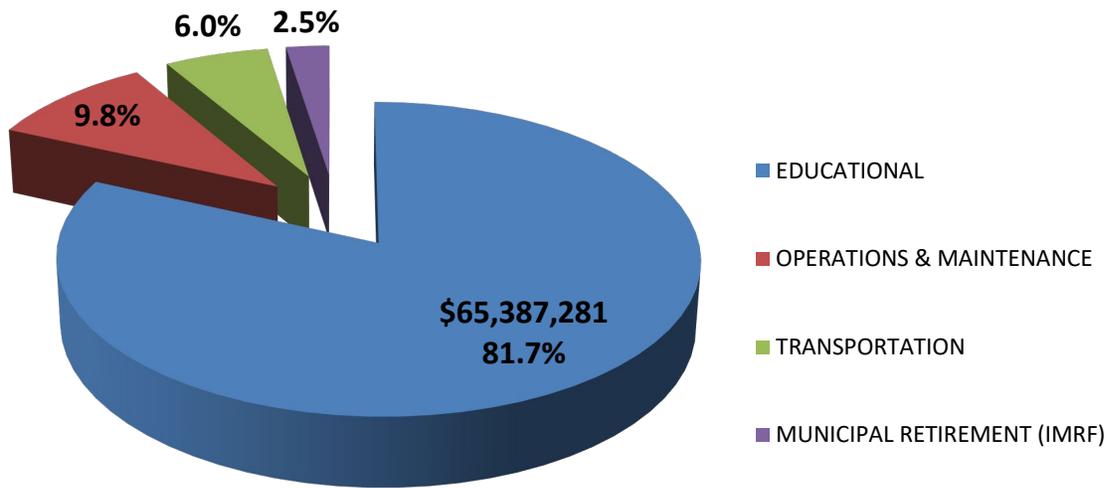

TOTAL OPERATING EXPENDITURE BUDGET = \$80,018,114

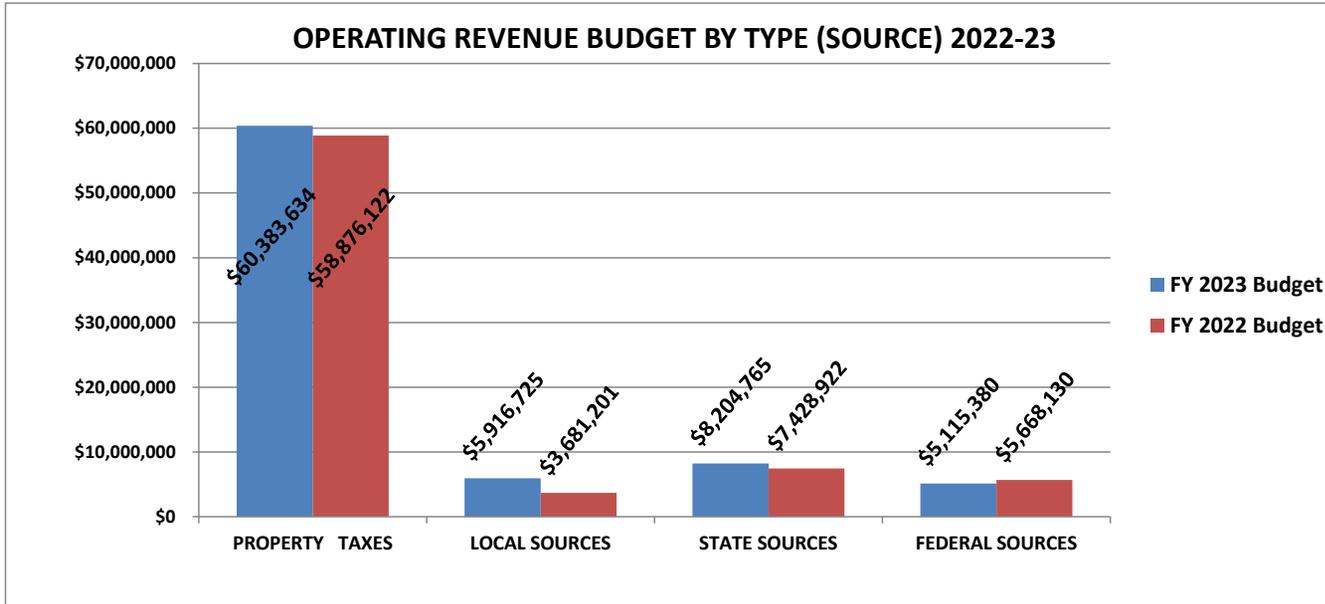

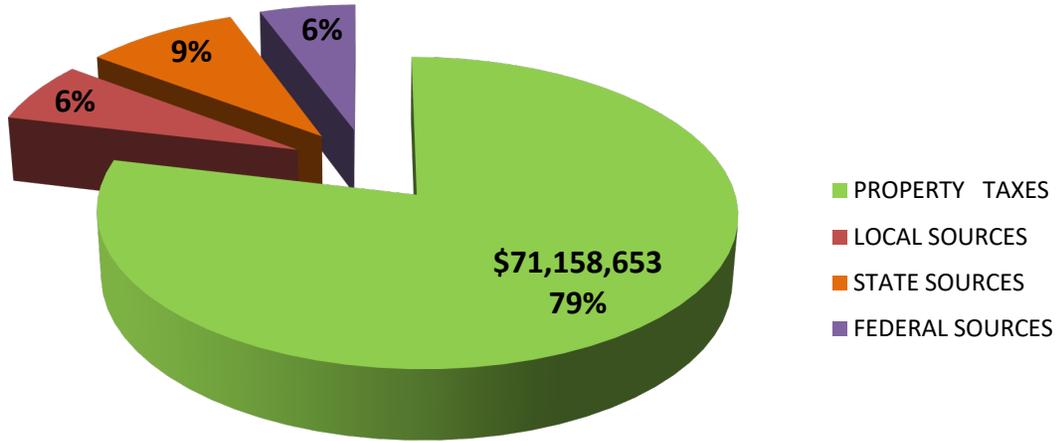

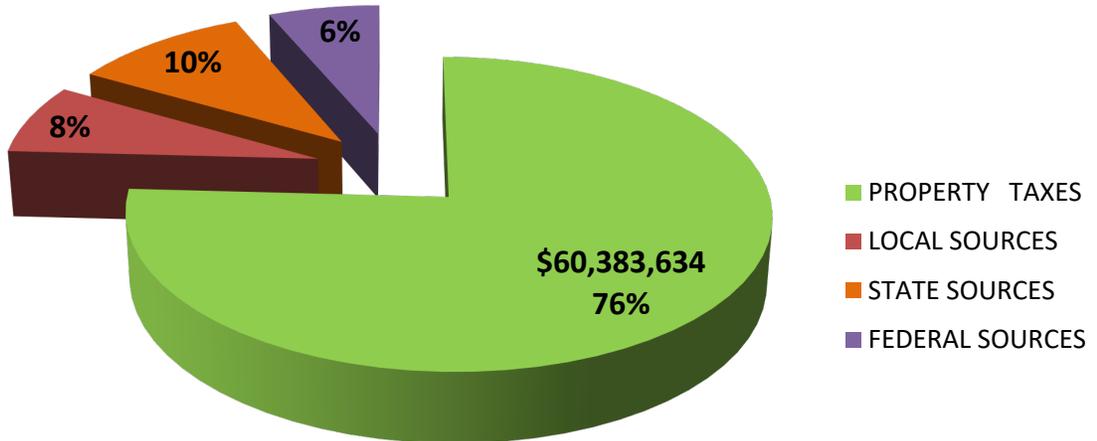
TOTAL REVENUE BUDGET BY TYPE (SOURCE) 2022-23

OPERATING REVENUE BUDGET BY TYPE (SOURCE) 2022-23



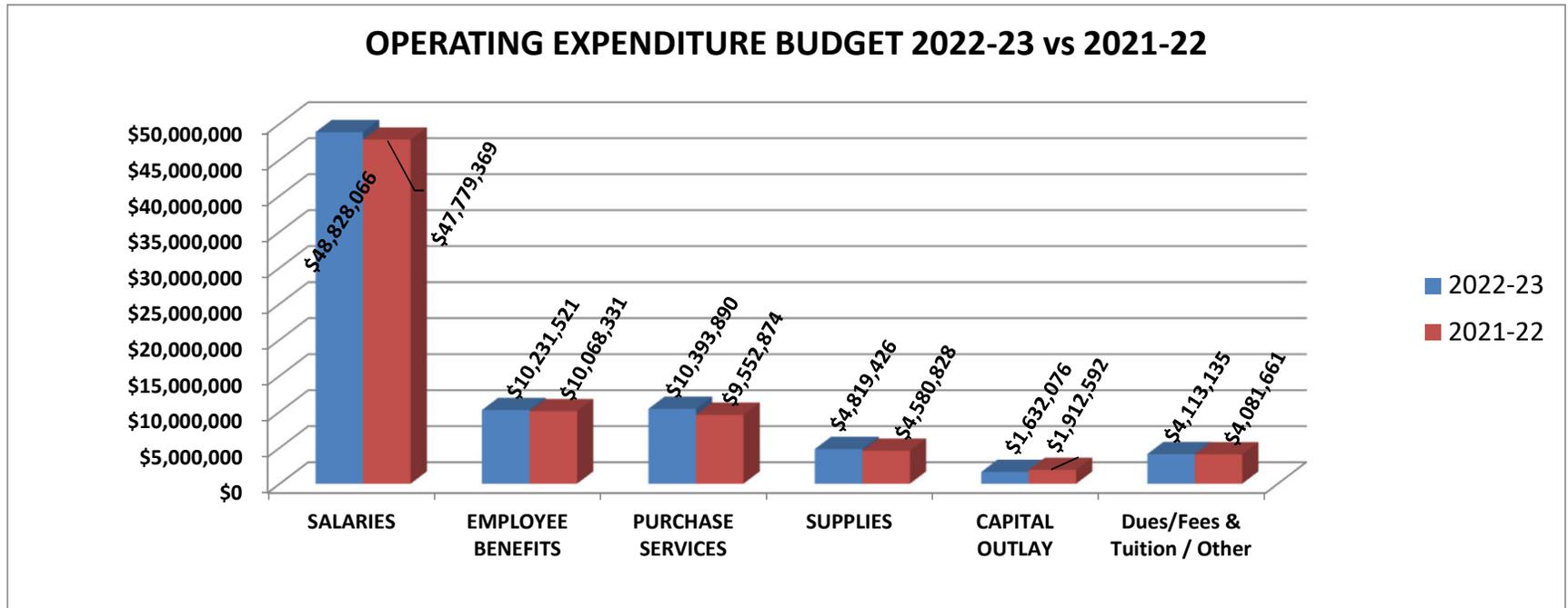

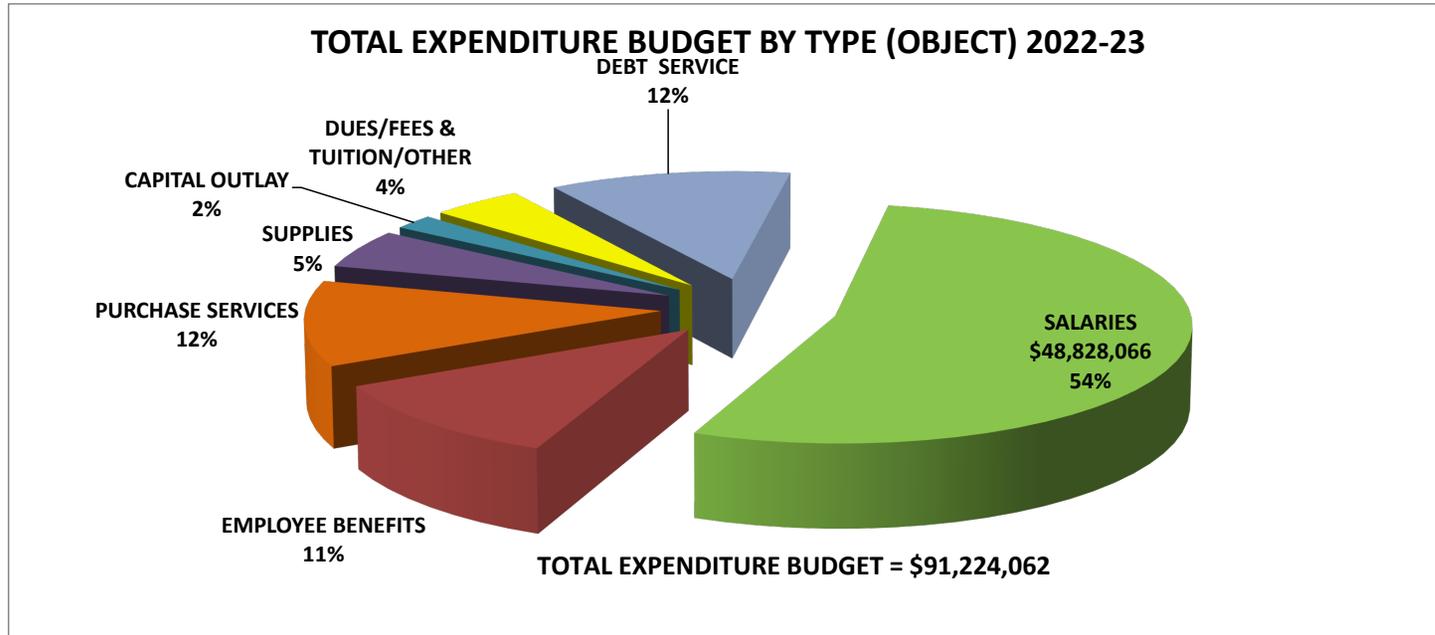

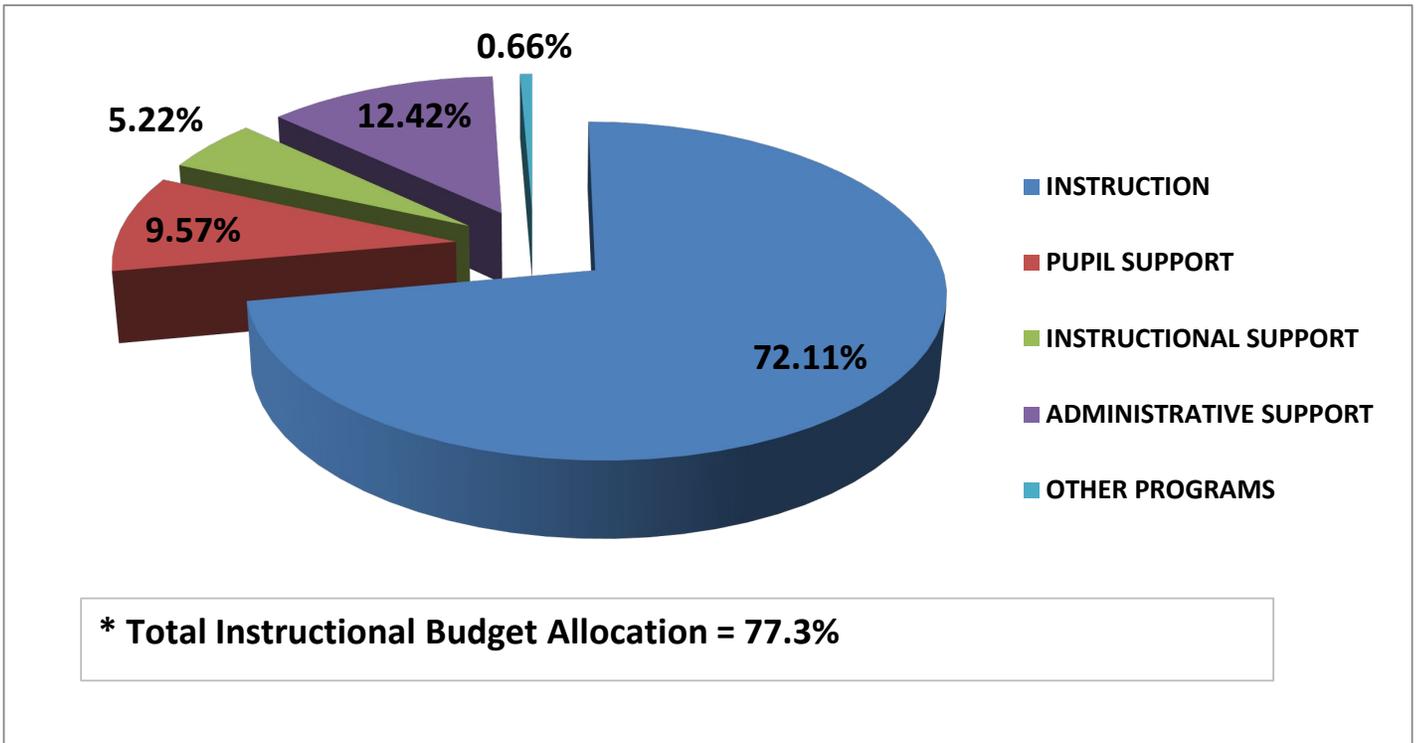

RE: Building Improvement Project Recommendation for 2023-24

We are presenting the recommended list of building improvement projects for the fiscal year 2023-24 as recently discussed and supported by the Building and Grounds Committee at the June 7, 2022 meeting. The scope of work includes two parts with the first part representing the work that was not successfully awarded for this summer 2022 due to pricing escalation. All of the budget estimates have been reviewed and adjusted with the assistance of both Wight & Co. and 20/10 Engineering. In addition, part two is the prioritized work from the Master Facility Plan for 2023-24 with updated budget estimates. The core of the projects continues to be the HVAC replacement and air conditioning for the vocational/CTE classroom and lab spaces at both buildings. A full list of the projects being recommended is outlined in Exhibit A. The total budget estimate, including architect/engineering fees is \$3,299,399 but the local funding is \$2,699,399. The funding for this proposed work will be primarily from the Capital Projects Fund (\$1,744,038) and the Operation & Maintenance (O&M) Fund (\$955,361). These amounts are net of the financial offset from the Dept. of Commerce and Economic Opportunity (DCEO) infrastructure grant of \$600,000 that will support the HVAC replacement and air conditioning for vocational classrooms at both schools.

There is still pending the scope definition and budget estimates for the Addison Trail varsity baseball field project and the ongoing special education space planning and manufacturing lab modifications for Addison Trail and the Transition Program at the District Office. We continue to work with Wight & Co. to finalize the concept layout and budget estimate for future planning. As such, we will bring this to a future meeting for consideration and possible addendum to the 2023-24 projects.

Suggested Motion:

Move that the Board of Education authorize the building improvement budget for 2023-24 in the amount of \$2,699,399 including contingency as outlined in Exhibit A.

RE: **Intergovernmental Agreement - Village of Addison**

We were approached by the Village of Addison regarding the need for an easement and maintenance provisions for the Driscoll Pond. This is located at the north boundary of Addison Trail adjacent to the new Pulte home subdivision. Apparently, the new stormwater detention area was reviewed by the Illinois Dept. of Natural Resources (IDNR) and determined that the future runoff from a possible overflow would enter our property. As such, they are requiring some heavy stone, also referred to as rip-rap, to be installed for approximately 2-5 feet beyond the existing boundary fence and run approximately 150-180 feet east to west. The good news is that this area is not used in any way by us as it is also a water retention area during heavy rains. The elevation in this area, just north of the existing baseball field, is a significant decline down to the bottom elevation and then north to our existing fence line. The Village will be asking for authority of the developer, under the Village supervision, to remove some fencing, dig down approximately 2 feet and install all of the new rock. Furthermore, the Village would maintain this new area in cooperation with the school district. The administration is in support of this cooperative effort to assist the Village and Pulte Homes.

Suggested Motion:

Move that the Board of Education approve the Intergovernmental Agreement with the Village of Addison for an easement and maintenance provisions pertaining to Driscoll Pond.

**INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF ADDISON
AND DUPAGE HIGH SCHOOL DISTRICT 88 FOR AN EASEMENT AND
MAINTENANCE PROVISIONS PERTAINING TO DRISCOLL POND**

WHEREAS, the Village of Addison (“Village”) is a municipal corporation duly organized and existing under the laws of the State of Illinois; and

WHEREAS, DuPage High School District 88 (“School District”) is a school district duly organized and existing under the laws of the State of Illinois; and

WHEREAS, the Village and the School District are each authorized pursuant to Article 7, Section 10 of the Illinois Constitution, and the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1, et seq.) to enter into agreements with other political subdivisions of the State of Illinois; and

WHEREAS, the Village has approved development plans and specifications for The Highlands Phase 1 & 2 (the “Project”) and the Illinois Department of Natural Resources (“IDNR”) has approved modifications to The Highlands/Driscoll Pond Dam IL50781 (also the “Project”); and

WHEREAS, the area of the Project includes both Village property and a small portion of School District property; and

WHEREAS, IDNR requires modifications be made to the Driscoll Pond Dam; and

WHEREAS, in order for the modifications to be made to the Driscoll Pond Dam, it is necessary for the Village to obtain an easement from the School District (the “Rip-Rap Easement”); and

WHEREAS, the property required for the rip-rap easement is under the jurisdiction and control of the School District; and

WHEREAS, the Village will be the Lead Agency for the Project; and

WHEREAS, the Village and School District have agreed that the development company for the Highlands Subdivision under the direction of the Village and pursuant to approved development plans will perform the work necessary for the Project on Village property and on the School District’s property within the rip-rap easement and that the School District will pay a zero share of the cost to complete such work; and

WHEREAS, the Mayor and Board of Trustees of the Village and the Superintendent and Board of Education of the School District find that it is in the best interests of the citizens of the Village and the School District to enter into this agreement; and

WHEREAS, the parties to this Intergovernmental Agreement desire to set forth their respective rights and duties concerning the Project.

NOW, THEREFORE IN CONSIDERATION of the foregoing and the mutual covenants and conditions contained herein, and other good and valuable consideration, the sufficiency and mutuality of which are hereby acknowledged by the Village and School District, the parties agree as follows:

Section 1. Incorporation of Recitals. The recitals set forth in the preamble hereto are incorporated herein and made part of this Agreement.

Section 2. Purpose of Agreement. The intent and purpose of this Agreement is to permit the Village to make modifications to a certain portion of School District property owned or under control of the School District without taking ownership of the improvements. The Village will be granted a rip-rap easement to make the modifications and future access via School District property to maintain and repair the same, which permission is hereby granted to the Village by the School District. The development company for the Highlands Subdivision under the direction of the Village will complete all of the work associated with the improvement on both the Village and School District portions of the Project.

Section 3. The Project. This Agreement contemplates the modification of Driscoll Pond, the nature of which is increasing its height and having an engineered weir overflow installed. The work will require removing and reinstalling an existing fence at the property line to access the rip-rap easement area. The Village or its agents/contractors, which may in this instance include the development company shall construct the Project substantially in accordance with the plans and specifications of the Highlands/Driscoll Pond, which plans and specifications are incorporated herein by this reference. The Village shall cause the work contemplated by the Project to be performed in a good and workmanlike manner in accordance with the approved plans by the development company. The rip-rap easement will be granted as set forth in Exhibit A.

Section 4. Lead Agency. The Village shall be the Lead Agency for the purposes of directing, coordinating, inspecting and supervising the Project. The Lead Agency shall coordinate intergovernmental communication, supervision of work and progress, and such other matters which are necessary and customary.

Section 5. Costs. The Village and the development company for the Highlands shall pay all costs associated with the improvement on both the Village and School District portions of the Project. Upon completion of the Project in conformity with the Approved Plans, the School District shall accept the relevant portion of the Project within thirty (30) days following notification of final completion of the Project (including all punch list items) by the Village. Upon the School District's acceptance of the Project, the Village will commence maintenance of the rip-rap easement area, at the Village's expense, using granted access as agreed to by the School District.

Section 6. Indemnification. To the extent permitted by law, the Village shall defend, indemnify and hold harmless the School District, its board members, officers, employees, and agents, from any and all claims, demands, causes of action, suits, damages or liability, including attorney's fees, expert witness fees and costs arising out of or alleged to arise out of the Village's (or its agents' or employees') acts or omissions related to the Project, including, but not limited to, personal injury, death, property damage, breach of contract, mechanic's liens or arising under the common law or any municipal, state or federal rule, regulation or statute. If any claim is asserted, the Village shall promptly notify the School District in writing. The parties agree and acknowledge that this provision is not intended to require indemnification for the School District

or its employees' own negligent acts or omissions. Nothing herein shall abrogate any immunities available to the Village or the School District under law. The Village's obligations under this Section shall survive the termination or expiration of this Agreement.

To the extent permitted by law, the School District shall defend, indemnify and hold harmless the Village, its officers, employees and agents, from any and all claims, demands, causes of action, suits, damages or liability, including attorney's fees, expert witness fees and costs arising out of or alleged to arise out of the School District's (or its agents' or employee's) act or omissions related to the Project, including, but not limited to, personal injury, death, property damage, breach of contract, mechanic's liens or arising under the common law or any municipal, state or federal rule, regulation or statute. If any claim is asserted, the School District shall promptly notify the Village in writing. The parties agree and acknowledge that this provision is not intended to require indemnification for the Village's (or agents' or employees') own negligent acts or omissions. Nothing herein shall abrogate any immunities available to the Village or the School District under law. The School District's obligations under this Section shall survive the termination or expiration of this Agreement.

Section 7. Amendment or Modification to this Agreement. This Agreement may be amended or modified only by written instrument signed by both the Village and School District.

Section 8. Effective Date. This Agreement shall become effective upon the date fully executed by the parties.

Section 9. Entire Agreement. This Agreement represents the entire Agreement between the Village and School District in connection with the Project.

Section 10. Binding Nature of this Agreement. This Agreement shall be binding upon the parties and their respective transferees, successors and assigns.

Section 11. Notices. Any notice permitted or required by the provisions of this Agreement shall be served upon the other party by mailing notices to the following individuals and addresses:

All notices permitted or required to be given under the terms of this Agreement shall be in writing and either (a) served personally during regular business hours; (b) served by facsimile transmission during regular business hours; or (c) served by recognized national courier.

Notices served personally or by facsimile transmission shall be effective upon receipt and notices served by recognized national courier shall be effective upon receipt as verified by the courier. Each party may designate a new individual and/or location for service of notices by serving notice thereof in accordance with the requirements of this section and without compliance with the amendment provision set forth in Section 8 above.

Section 12. Severability. The invalidity or enforceability of any of the provisions of this Agreement shall not affect the validity or enforceability of the remainder of the Agreement.

Section 13. Captions and Headings. The captions and headings hereof are for convenience only and shall not be used to interpret this Agreement.

Section 14. Governing Law; Venue. This Agreement shall be governed by the laws of the State of Illinois both as to interpretation and performance.

Section 15. Term of this Agreement. The term of this Agreement shall begin on the date this Agreement is fully executed and shall continue in full force and effect until all work on the Project is accepted by the Village. However, the parties to this Agreement expressly agree that the provisions of this Agreement pertaining to the maintenance of the completed Project, and the Village's access to the Project area via School District property, shall survive the termination of this Agreement.

Section 16. Insurance. In addition to the requirements of Section 6 and not in lieu thereof, the Village agrees to require the development company to provide the School District a certificate of insurance with applicable insurance coverage regarding or applicable to the work required for the Project, including, but not limited to, general liability insurance, vehicle insurance, governmental entity insurance or other insurance applicable to the construction of the Project. Any insurance provided by any development company contractor shall be primary and non-contributory and any insurance secured by the School District shall be excess insurance. Prior to commencing construction, inspection, maintenance or repair, the Village shall provide the School District with the development company's proof of insurance.

Section 17. Construction Security. Prior to commencement of construction, the Village shall require the development company to provide construction security acceptable to the School District (which, by way of example and not as a limitation, may be in the form of a performance bond, letter of credit, or other similar guaranty) to guarantee completion of the Project and remediation of rip-rap easement property under the jurisdiction of the School District.

Section 18. Signature in Counterparts. This Agreement may be signed in counterparts and by electronic signature (i.e. pdf signature) which together shall be binding as an original.

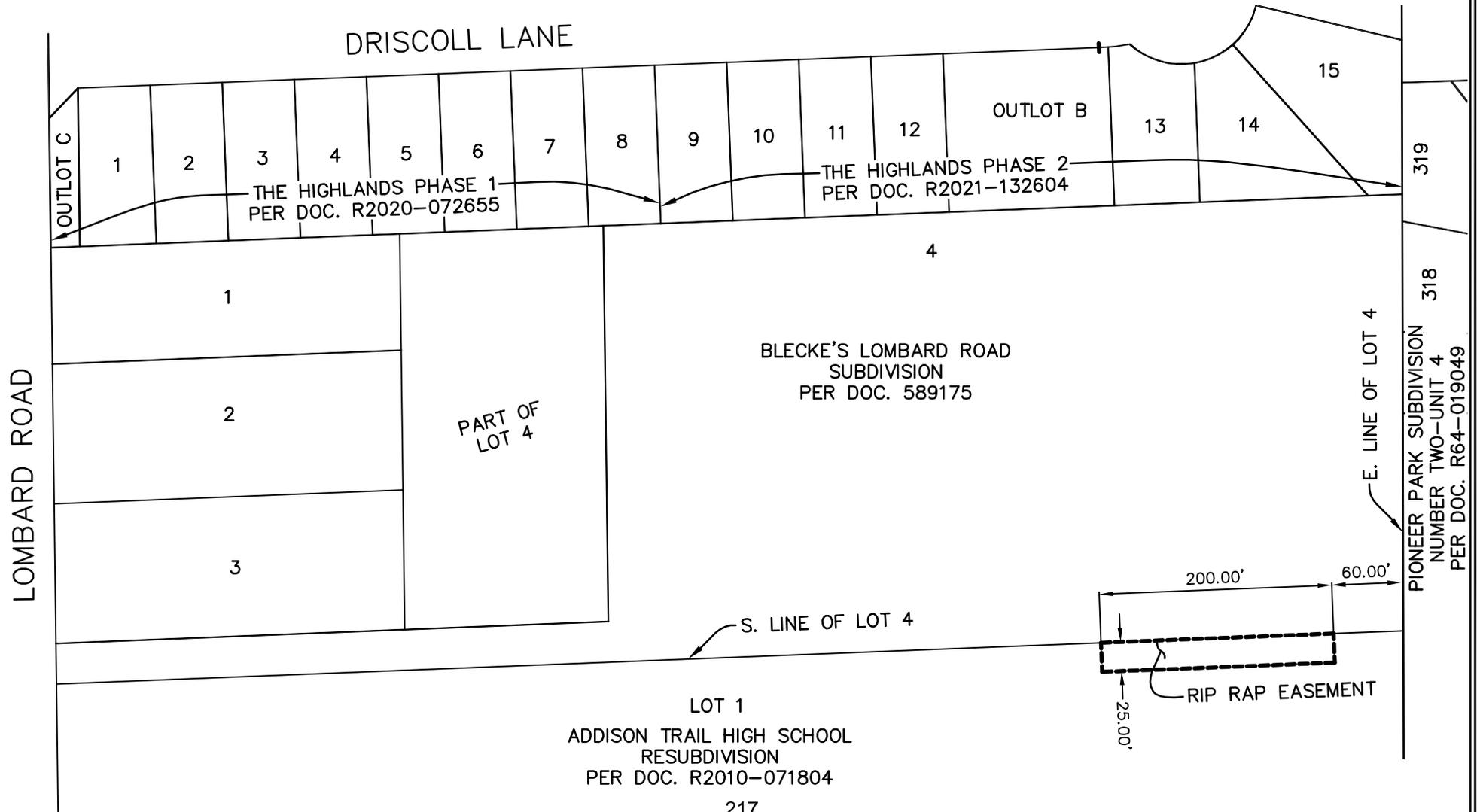

Suspension Without Pay

The School Board or Superintendent or designee may suspend without pay: (1) a professional employee pending a dismissal hearing, or (2) a teacher as a disciplinary measure for up to 30 employment days for misconduct that is detrimental to the School District.

Misconduct that is detrimental to the School District includes:

- Insubordination, including any failure to follow an oral or written directive from a supervisor;
- Violation of Board policy or Administrative Procedure;
- Conduct that disrupts or may disrupt the educational program or process;
- Conduct that violates any State or federal law that relates to the employee's duties; and
- Other sufficient causes.

The Superintendent or designee is authorized to issue a pre-suspension notification to a professional employee. This notification shall include the length and reason for the suspension as well as the deadline for the employee to exercise his or her right to appeal the suspension to the Board or Board-appointed hearing examiner before it is imposed. At the request of the professional employee made within five calendar days of receipt of a pre-suspension notification, the Board or Board-appointed hearing examiner will conduct a pre-suspension hearing. The Board or its designee shall notify the professional employee of the date and time of the hearing. At the pre-suspension hearing, the professional employee or his/her representative may present evidence. If the employee does not appeal the pre-suspension notification, the Superintendent or designee shall report the action to the Board at its next regularly scheduled meeting.

Suspension With Pay

The Board or Superintendent or designee may suspend a professional employee with pay: (1) during an investigation into allegations of disobedience or misconduct whenever the employee's continued presence in his or her position would not be in the School District's best interests, (2) as a disciplinary measure for misconduct that is detrimental to the School District as defined above, or (3) pending a Board hearing to suspend a teacher without pay.

The Superintendent shall meet with the employee to present the allegations and give the employee an opportunity to refute the charges. The employee will be told the dates and times the suspension will begin and end.

Employees Under Investigation by Illinois Dept. of Children and Family Services (DCFS)

Upon receipt of a DCFS recommendation that the District remove an employee from his or her position when he or she is the subject of a pending DCFS investigation that relates to his or her employment with the District, the Board or Superintendent or designee, in consultation with the Board Attorney, will determine whether to:

1. Let the employee remain in his or her position pending the outcome of the investigation; or
2. Remove the employee as recommended by DCFS, proceeding with:
 - a. A suspension with pay; or
 - b. A suspension without pay.

Repayment of Compensation and Benefits

If a professional employee is suspended with pay, either voluntarily or involuntarily, pending the outcome of a criminal investigation or prosecution, and the employee is later dismissed as a result of his or her criminal conviction, the employee must repay to the District all compensation and the value of all benefits received by him or her during the suspension. The Superintendent will notify the employee of this requirement when the employee is suspended.

6:140 Education of Homeless Children

Each child of a homeless individual and each homeless youth has equal access to the same free, appropriate public education as provided to other children and youths. A *homeless child* is defined as provided in the McKinney-Vento Homeless Assistance Act and the ~~III.~~ Education for Homeless Children Act. The Superintendent or designee shall act as or appoint a Liaison for Homeless Children to coordinate this policy's implementation.

A homeless child may attend the District school that the child attended when permanently housed or in which the child was last enrolled. A homeless child living in any District school's attendance area may attend that school.

The Superintendent or designee shall review and revise rules or procedures that may act as barriers to the enrollment of homeless children and youths. In reviewing and revising such procedures, consideration shall be given to issues concerning transportation, immunization, residency, birth certificates, school records and other documentation, and guardianship. Transportation shall be provided in accordance with the McKinney-Vento Homeless Assistance Act and State law. The Superintendent or designee shall give special attention to ensuring the enrollment and attendance of homeless children and youths who are not currently attending school. If a child is denied enrollment or transportation under this policy, the Liaison for Homeless Children shall immediately refer the child or his or her parent/guardian to the ombudsperson appointed by the Regional Superintendent and provide the child or his or her parent/guardian with a written explanation for the denial. Whenever a child and his or her parent/guardian who initially share the housing of another person due to loss of housing, economic hardship, or a similar hardship continue to share the housing, the Liaison for Homeless Children shall, after the passage of 18 months and annually thereafter, conduct a review as to whether such hardship continues to exist in accordance with State law.

2:230 Public Participation at School Board Meetings and Petitions to the Board

For a maximum of 60 minutes during each regular and special open meeting of the Board, any person may comment to or ask questions of the School Board (*public participation*), subject to the reasonable constraints established and recorded in this policy's guidelines below.^{Q1} The Board listens to comments or questions during public participation; responses to comments to or questions of the Board are most often managed through policy 3:30, *Chain of Command*. The time limit for public participation at a meeting may be extended upon the majority vote of the Board members at the regular or special meeting.

To preserve sufficient time for the Board to conduct its business, any person appearing before the Board is expected to follow these guidelines:

1. Address the Board only at the appropriate time as indicated on the agenda and when recognized by the Board President. This includes following the directives of the Board President to maintain order and decorum for all.
2. Sign-in. Use a sign-in sheet, if requested.
3. Identify oneself and be brief. Ordinarily, the time for any one person to address the Board during public participation shall be limited to five minutes. In unusual circumstances, and when an individual has made a request to speak for a longer period of time, the Board President may allow a person ~~may be allowed~~ to speak for more than five minutes. If multiple individuals wish to address the Board on the same subject, the group is encouraged to appoint a spokesperson.
4. Observe, when necessary and appropriate, the Board President's authority to:
 - a. Shortening of the time for each person to address the Board during public participation to conserve time and give the maximum number of people an opportunity to speak; ~~and/or~~
 - b. ~~Expansion of the overall minimum of 30 minutes for public participation and/or the 20 minute minimum total length of time for any one subject; and/or~~
 - c. ~~Determination of~~ procedural matters regarding public participation not otherwise covered in Board policy.
 - d. ~~Determination of~~ procedural matters regarding public participation not otherwise covered in Board policy.
5. Conduct oneself with respect and civility toward others and otherwise abide by Board policy 8:30, *Visitors to and Conduct on School Property*.

2. Purchasing recycled paper and paper products in amounts that will, at a minimum, meet the specifications in the School Code, if economically and practically feasible.
3. Periodic review of procedures on the reduction of solid waste generated by academic, administrative, and other institutional functions. These procedures shall: (a) require recycling the District's waste stream, including landscape waste, computer paper, and white office paper, if economically and practically feasible; (b) include investigation of the feasibility of potential markets for other recyclable materials that are present in the District's waste stream; and (c) be designed to achieve, before July 1, 2020, at least a 50% reduction in the amount of solid waste that is generated by the District.

3. Serves as a communication link between the school and parents/guardians;

7:15 Student and Family Privacy Rights

Surveys

All surveys requesting personal information from students, as well as any other instrument used to collect personal information from students, must advance or relate to the District's educational objectives as identified in School Board policy 6:10, *Educational Philosophy and Objectives*, or assist students' career choices. This applies to all surveys, regardless of whether the student answering the questions can be identified or and regardless of who created the survey.

Surveys Created by a Third Party

Before a school official or staff member administers or distributes a survey or evaluation created by a third party to a student, the student's parent(s)/guardian(s) may inspect the survey or evaluation, upon their request and within a reasonable time of their request.

This section applies to every survey: (1) that is created by a person or entity other than a District official, staff member, or student, (2) regardless of whether the student answering the questions can be identified, and (3) regardless of the subject matter of the questions.

Survey Requesting Personal Information

School officials and staff members shall not request, nor disclose, the identity of any student who completes any survey or evaluation (created by any person or entity, including the District) containing one or more of the following items:

1. Political affiliations or beliefs of the student or the student's parent/guardian.
2. Mental or psychological problems of the student or the student's family.
3. Behavior or attitudes about sex.
4. Illegal, anti-social, self-incriminating, or demeaning behavior.
5. Critical appraisals of other individuals with whom students have close family relationships.
6. Legally recognized privileged or analogous relationships, such as those with lawyers, physicians, and ministers.
7. Religious practices, affiliations, or beliefs of the student or the student's parent/guardian.
8. Income other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program.

The student's parent(s)/guardian(s) may:

1. Inspect the survey or evaluation upon, and within a reasonable time of, their request, and/or
2. Refuse to allow their child to participate in the activity described above. The school shall not penalize any student whose parent(s)/guardian(s) exercised this option.

A student's parent(s)/guardian(s) may inspect, upon their request, any instructional material used as part of their child's educational curriculum within a reasonable time of their request.

The term "instructional material" means instructional content that is provided to a student, regardless of its format, printed or representational materials, audio-visual materials, and materials in electronic or digital formats (such as materials accessible through the Internet). The term does not include academic tests or academic assessments.

Physical Exams or Screenings

No school official or staff member shall subject a student to a non-emergency, invasive physical examination or screening as a condition of school attendance. The term *invasive physical examination* means any medical examination that involves the exposure of private body parts, or any act during such examination that includes incision, insertion, or injection into the body, but does not include a hearing, vision, or scoliosis screening.

The above paragraph does not apply to any physical examination or screening that:

1. Is permitted or required by an applicable State law, including physical examinations or screenings that are permitted without parental notification.
2. Is administered to a student in accordance with the Individuals with Disabilities Education Act ([20 U.S.C. §1400 et seq.](#)).
3. Is otherwise authorized by Board policy.

Prohibition on Selling or Marketing Students' Personal Information ~~Is Prohibited~~ [PRESSPlus1](#)

No school official or staff member shall market or sell personal information concerning students (or otherwise provide that information to others for that purpose). The term *personal information* means individually identifiable information including: (1) a student or parent's first and last name, (2) a home or other physical address (including street name and the name of the city or town), (3) a telephone number, (4) a Social Security identification number or (5) driver's license number or State identification card.

Unless otherwise prohibited by law, the above paragraph does not apply: (1) if the student's parent(s)/guardian(s) have consented; or (2) to the collection, disclosure or, use of personal information collected from students for the exclusive purpose of developing, evaluating or providing educational products or services for, or to, students or educational institutions, such as the following:

1. College or other postsecondary education recruitment, or military recruitment.
2. Book clubs, magazines, and programs providing access to low-cost literary products.
3. Curriculum and instructional materials used by elementary schools and secondary schools.
4. Tests and assessments to provide cognitive, evaluative, diagnostic, clinical, aptitude, or achievement information about students (or to generate other statistically useful data for the purpose of securing such tests and assessments) and the subsequent analysis and public release of the aggregate data from such tests and assessments.
5. The sale by students of products or services to raise funds for school-related or education-related activities.
6. Student recognition programs.

Under no circumstances may a school official or staff member provide a student's *personal information* to a business organization or financial institution that issues credit or debit cards.

Notification of Rights and Procedures

The Superintendent or designee shall notify students' parents/guardians of:

1. This policy as well as its availability upon request from the general administration office.
2. How to opt their child out of participation in activities as provided in this policy.
3. The approximate dates during the school year when a survey requesting personal information, as described above, is scheduled or expected to be scheduled.
4. How to request access to any survey or other material described in this policy.

This notification shall be given to parents/guardians at least annually, at the beginning of the school year, and within a reasonable period after any substantive change in this policy.

Transfer of Rights

The rights provided to parents/guardians in this policy transfer to the student when the student turns 18 years old, or is an emancipated minor.

Therefore, in cases where the *covered information* is collected, disclosed, or used that also meets the definition of *personal information* under this policy, the PPRA and CPPPEA exceptions to the prohibition on selling students' personal information may not be available. STUDENTS

7:270 Administering Medicines to Students

Students should not take medication during school hours or during school-related activities unless it is necessary for a student's health and well-being. When a student's licensed health care provider and parent/guardian believe that it is necessary for the student to take a medication during school hours or school-related activities, the parent/guardian must request that the school dispense the medication to the child and otherwise follow the District's procedures on dispensing medication.

No School District employee shall administer to any student, or supervise a student's self-administration of, any prescription or non-prescription medication until a completed and signed *School Medication Authorization Form (SMA Form)* is submitted by the student's parent/guardian. No student shall possess or consume any prescription or non-prescription medication on school grounds or at a school-related function other than as provided for in this policy and its implementing procedures.

Nothing in this policy shall prohibit any school employee from providing emergency assistance to students, including administering medication.

The Building Principal shall include this policy in the Student Handbook and shall provide a copy to the parents/guardians of students.

Self-Administration of Medication

A student may possess and self-administer an epinephrine injector, e.g., EpiPen®, and/or asthma medication prescribed for use at the student's discretion, provided the student's parent/guardian has completed and signed an *SMA Form*. The Superintendent or designee will ensure an Emergency Action Plan is developed for each self-administering student.

A student may self-administer medication required under a *qualifying plan*, provided the student's parent/guardian has completed and signed an *SMA Form*. A qualifying plan means: (1) an asthma action plan, (2) an Individual Health Care Action Plan, (3) an Ill. Food Allergy Emergency Action Plan and Treatment Authorization Form, (4) a plan pursuant to Section 504 of the federal Rehabilitation Act of 1973, or (5) a plan pursuant to the federal Individuals with Disabilities Education Act.

The District shall incur no liability, except for willful and wanton conduct, as a result of any injury arising from a student's self-administration of medication, including asthma medication or epinephrine injectors, or medication required under a qualifying plan. A student's parent/guardian must indemnify and hold harmless the District and its employees and agents, against any claims, except a claim based on willful and wanton conduct, arising out of a student's self-administration of an epinephrine injector, asthma medication, and/or a medication required under a qualifying plan.

School District Supply of Undesignated Asthma Medication

The Superintendent or designee shall implement [105 ILCS 5/22-30\(f\)](#) and maintain a supply of undesignated asthma medication in the name of the District and provide or administer them as

necessary according to State law. *Undesignated asthma medication* means an asthma medication prescribed in the name of the District or one of its schools. A school nurse or trained personnel, as defined in State law, may administer an undesignated asthma medication to a person when they, in good faith, believe a person is having *respiratory distress*. Respiratory distress may be characterized as *mild-to-moderate* or *severe*. Each building administrator and/or his or her corresponding school nurse shall maintain the names of trained personnel who have received a statement of certification pursuant to State law.

School District Supply of Undesignated Epinephrine Injectors

The Superintendent or designee shall implement [105 ILCS 5/22-30\(f\)](#) and maintain a supply of undesignated epinephrine injectors in the name of the District and provide or administer them as necessary according to State law. *Undesignated epinephrine injector* means an epinephrine injector prescribed in the name of the District or one of its schools. A school nurse or trained personnel, as defined in State law, may administer an undesignated epinephrine injector to a person when they, in good faith, believe a person is having an anaphylactic reaction. Each building administrator and/or his or her corresponding school nurse shall maintain the names of trained personnel who have received a statement of certification pursuant to State law.

School District Supply of Undesignated Opioid Antagonists

The Superintendent or designee shall implement [105 ILCS 5/22-30\(f\)](#) and maintain a supply of undesignated opioid antagonists in the name of the District and provide or administer them as necessary according to State law. *Opioid antagonist* means a drug that binds to opioid receptors and blocks or inhibits the effect of opioids acting on those receptors, including, but not limited to, naloxone hydrochloride or any other similarly acting drug approved by the U.S. Food and Drug Administration. *Undesignated opioid antagonist* is not defined by the School Code; for purposes of this policy it means an opioid antagonist prescribed in the name of the District or one of its schools. A school nurse or trained personnel, as defined in State law, may administer an undesignated opioid antagonist to a person when they, in good faith, believe a person is having an opioid overdose. Each building administrator and/or his or her corresponding school nurse shall maintain the names of trained personnel who have received a statement of certification pursuant to State law. Dept. of Human Services for information about opioid prevention, abuse, public awareness, and a toll-free number to provide information and referral services for persons with questions concerning substance abuse treatment.

School District Supply of Undesignated Glucagon

The Superintendent or designee shall implement [105 ILCS 145/27](#) and maintain a supply of undesignated glucagon in the name of the District in accordance with manufacturer's instructions.

When a student's prescribed glucagon is not available or has expired, a school nurse or delegated care aide may administer undesignated glucagon only if he or she is authorized to do so by a student's diabetes care plan.

Administration of Medical Cannabis

The Compassionate Use of Medical Cannabis Program Act allows a *medical cannabis infused product* to be administered to a student by one or more of the following individuals:

1. A parent/guardian of a student who is a minor who registers with the Ill. Dept. of Public Health (IDPH) as a *designated caregiver* to administer medical cannabis to their child. A designated caregiver may also be another individual other than the student's parent/guardian. Any

designated caregiver must be at least 21 years old and is allowed to administer a *medical cannabis infused product* to a child who is a student on the premises of his or her school or on his or her school bus if:

- a. Both the student and the designated caregiver possess valid registry identification cards issued by IDPH;
 - b. Copies of the registry identification cards are provided to the District;
 - c. That student's parent/guardian completed, signed, and submitted a *School Medication Authorization Form - Medical Cannabis*; and
 - d. After administering the product to the student, the designated caregiver immediately removes it from school premises or the school bus.
2. A properly trained school nurse or administrator, who shall be allowed to administer the *medical cannabis infused product* to the student on the premises of the child's school, at a school-sponsored activity, or before/after normal school activities, including while the student is in before-school or after-school care on school-operated property or while being transported on a school bus.
 3. The student him or herself when the self-administration takes place under the direct supervision of a school nurse or administrator.

Medical cannabis infused product (product) includes oils, ointments, foods, and other products that contain usable cannabis but are not smoked or vaped. Smoking and/or vaping medical cannabis is prohibited.

The product may not be administered in a manner that, in the opinion of the District or school, would create a disruption to the educational environment or cause exposure of the product to other students. A school employee shall not be required to administer the product.

Discipline of a student for being administered a product by a designated caregiver, or by a school nurse or administrator, or who self-administers a product under the direct supervision of a school nurse or administrator pursuant to this policy is prohibited. The District may not deny a student attendance at a school solely because he or she requires administration of the product during school hours.

Void Policy

The **School District Supply of Undesignated Asthma Medication** section of the policy is void whenever the Superintendent or designee is, for whatever reason, unable to: (1) obtain for the District a prescription for undesignated asthma medication from a physician or advanced practice nurse licensed to practice medicine in all its branches, or (2) fill the District's prescription for undesignated school asthma medication.

The **School District Supply of Undesignated Epinephrine Injectors** section of the policy is void whenever the Superintendent or designee is, for whatever reason, unable to: (1) obtain for the District a prescription for undesignated epinephrine injectors from a physician or advanced practice nurse licensed to practice medicine in all its branches, or (2) fill the District's prescription for undesignated school epinephrine injectors.

The **School District Supply of Undesignated Opioid Antagonists** section of the policy is void whenever the Superintendent or designee is, for whatever reason, unable to: (1) obtain for the District a prescription for opioid antagonists from a health care professional who has been delegated prescriptive authority for opioid antagonists in accordance with Section 5-23 of the Substance Use

Disorder Act, or (2) fill the District's prescription for undesignated school opioid antagonists.

The **School District Supply of Undesignated Glucagon** section of the policy is void whenever the Superintendent or designee is, for whatever reason, unable to: (1) obtain for the District a prescription for glucagon from a qualifying prescriber, or (2) fill the District's prescription for undesignated school glucagon.

The **Administration of Medical Cannabis** section of the policy is void and the District reserves the right not to implement it if the District or school is in danger of losing federal funding.

Administration of Undesignated Medication

Upon any administration of an undesignated medication permitted by State law, the Superintendent or designee(s) must ensure all notifications required by State law and administrative procedures occur.

Undesignated Medication Disclaimers

Upon implementation of this policy, the protections from liability and hold harmless provisions applicable under State law apply.

No one, including without limitation, parents/guardians of students, should rely on the District for the availability of undesignated medication. This policy does not guarantee the availability of undesignated medications. Students and their parents/guardians should consult their own physician regarding these medication(s).

PRESSPlus 1. Boards must adopt a policy that addresses the prevention of anaphylaxis and a district's response to medical emergencies resulting from anaphylaxis. See policy 7:285, *Anaphylaxis Prevention, Response, and Management Program*. Due to the structure of the School Code and the IASB Policy Reference Manual, policy 7:285, *Anaphylaxis Prevention, Response, and Management Program*, does not address the administration of epinephrine and instead refers to this policy 7:270, *Administering Medicine to Students*. The accompanying administrative procedure for policy 7:285, 7:285-AP, *Anaphylaxis Prevention, Response, and Management Program*, is available at **PRESS**

7:285 Anaphylaxis Prevention, Response, and Management Program

Title has been updated. Original Title: Food Allergy Management Program

School attendance may increase a student's risk of exposure to allergens that could trigger anaphylaxis. [PRESSPlus1](#) Students at risk for anaphylaxis benefit from a School Board policy that coordinates a planned response in the event of an anaphylactic emergency. [PRESSPlus2](#) Anaphylaxis is a severe systemic allergic reaction from exposure to allergens that is rapid in onset and can cause death. Common allergens include animal dander, fish, latex, milk, shellfish, tree nuts, eggs, insect venom, medications, peanuts, soy, and wheat. A severe allergic reaction usually occurs quickly; death has been reported to occur within minutes. An anaphylactic reaction can also occur up to one to two hours after exposure to the allergen.

While it is not possible for the District to completely eliminate the risks of an anaphylactic emergency when a student is at school, an Anaphylaxis Prevention, Response, and Management Program using a cooperative effort among students' families, staff members, students, health care providers, emergency medical services, and the community helps the District reduce these risks and provide accommodations and proper treatment for anaphylactic reactions. [PRESSPlus3](#)

The Superintendent or designee shall develop and implement an Anaphylaxis Prevention, Response, and Management Program for the prevention and treatment of anaphylaxis that:

1. Fully implements the Ill. State Board of Education (ISBE)'s model policy required by the School Code that: (a) relates to the care and response to a person having an anaphylaxis reaction, (b) addresses the use of epinephrine in a school setting, (c) provides a full food allergy and prevention of allergen exposure plan, and (d) aligns with 105 ILCS 5/22-30 and 23 Ill.Admin.Code §1.540. [PRESSPlus4](#)
2. Ensures staff members receive appropriate training, including: (a) an in-service training program for staff who work with students that is conducted by a person with expertise in anaphylactic reactions and management, and (b) training required by law for those staff members acting as *trained personnel*, as provided in 105 ILCS 5/22-30 and 23 Ill.Admin.Code §1.540. [PRESSPlus5](#)
3. Implements and maintains a supply of undesignated epinephrine in the name of the District, in accordance with policy 7:270, *Administering Medicines to Students*. [Q1](#)
4. Follows and references the applicable best practices specific to the District's needs in the Centers for Disease Control and Prevention's *Voluntary Guidelines for Managing Food Allergies in Schools and Early Care and Education Programs* and the *National Association of School Nurses Allergies and Anaphylaxis Resources/Checklists*. [PRESSPlus6](#)
5. Provides annual notice to the parents/guardians of all students to make them aware of this policy. [PRESSPlus7](#)
6. Complies with State and federal law and is in alignment with Board policies.

Monitoring [PRESSPlus8](#)

Pursuant to State law and policy 2:240, *Board Policy Development*, the Board monitors this policy at least once every three years by conducting a review and reevaluation of this policy to make any necessary and appropriate revisions. The Superintendent or designee shall assist the Board with its reevaluation and assessment of this policy's outcomes and effectiveness. PRESSPlus Comments

PRESSPlus 1. This policy is updated in response to 105 ILCS 5/2-3.182, added by P.A. 102-413, requiring districts to adopt or update by 8-17-22 an anaphylaxis policy addressing prevention of and response to anaphylaxis in accordance with the model policy developed by the Ill. State Board of Education (ISBE), *Anaphylaxis Response Policy for Illinois Schools*, (*ISBE Model*), available at: www.isbe.net/Documents/Anaphylactic-policy.pdf.

It is presented as rewritten for PRESS Plus subscribers, however, a redlined version showing the changes made is available at **PRESS** Online by logging in at www.iasb.com.

The law requires the *ISBE Model*, and in turn a board's policy based on the *ISBE Model*, to include: (a) a procedure and treatment plan, including emergency protocols and responsibilities for school nurses and other appropriate school personnel, for responding to anaphylaxis, (b) requirements for a training course for appropriate school personnel on prevention and responding to anaphylaxis, (c) a

procedure and appropriate guidelines for the development of an individualized emergency health care plan for children with a food or other allergy that could result in anaphylaxis, (d) a communication plan for intake and dissemination of information provided by Illinois regarding children with a food or other allergy that could result in anaphylaxis, including a discussion of methods, treatments, and therapies to reduce the risk of allergic reactions, including anaphylaxis, (e) strategies for reducing the risk of exposure to anaphylactic causative agents, including food and other allergens, and (f) a communication plan for discussion with children who have developed adequate verbal communication and comprehension skills and with the parents or guardians of all children about foods that are safe and unsafe and about strategies to avoid exposure to unsafe food. 105 ILCS 5/2-3.182(b).

The *ISBE Model* is primarily focused on item (a). Little to no guidance for schools regarding items (b)-(f) exists in it other than to generally cite to voluminous resources made available by the Centers for Disease Control and Prevention (CDC) and National Association of School Nurses (NASN). This policy and its implementing procedures (available at **PRESS** Online by logging in at www.iasb.com) are designed to supplement the *ISBE Model* and further lead school officials to resources regarding items (b)-(f). 105 ILCS 5/2-3.182(b)(1-6).

Issue 109, May 2022

PRESSPlus 2. The *ISBE Model* does not provide a specific definition for *anaphylactic emergency*, but it appears to use that term and *anaphylaxis* interchangeably. **Issue 109, May 2022**

PRESSPlus 3. The *ISBE Model* provides that students at risk for anaphylaxis benefit from a policy that coordinates a planned response in the event of an anaphylactic emergency, and it emphasizes that an emergency plan should include all stakeholders. The clause “using a cooperative effort among students’ families, staff members, students, health care providers and emergency medical services, and the community” is optional and can be removed. The purpose of the clause is to share responsibility for management among all stakeholders. **Issue 109, May 2022**

PRESSPlus 4. Number one outlines the goals that the legislature directed ISBE to include in the topics covered by the *ISBE Model*. 105 ILCS 5/2-3.149(a)-(c). The *ISBE Model* is based on the *Virginia Dept. of Education Anaphylaxis Policy*, available at: www.doe.virginia.gov/support/health_medical/anaphylaxis_epinephrine/, and it incorporates NASN recommendations for a comprehensive anaphylaxis school policy. See the *NASN Sample Anaphylaxis Policy*, at: www.nasn.org/nasn-resources/resources-by-topic/allergies-anaphylaxis. Boards may add further expectations and include additional goals that reflect those expectations here. Ensure that any additional expectations or goals align with policy 7:270, *Administering Medicines to Students*. **Issue 109, May 2022**

PRESSPlus 5. Number two includes the biennial in-service training program required by 105 ILCS 5/10-22.39(e) and training required by 105 ILCS 5/22-30(g) for those staff members who will be *trained personnel*, authorized by 105 ILCS 5/22-30(b-10), to provide or administer undesignated epinephrine in specific situations. The law authorizes *school nurses* and *trained personnel* to administer undesignated epinephrine. See policy 5:100, *Staff Development Program* (or, if the board has not adopted the list of all training in the policy, see f/n 5 of the sample policy at **PRESS** Online, available by logging in at www.iasb.com), and 7:270-AP2, *Checklist for District Supply of Undesignated Asthma Medication, Epinephrine Injectors, Opioid Antagonists, and/or Glucagon* (available at **PRESS** Online by logging in at www.iasb.com).

105 ILCS 5/22-30(b-5) does not specifically state that staff members authorized to administer (student-specific) epinephrine under a student's specific individual plan must also complete the more rigorous training required for *trained personnel*. However, the *ISBE Model* is clear that “[o]nly trained personnel should administer epinephrine to a student believed to be having an anaphylactic reaction,” and it requires each building-level administrator to identify at least two employees, in addition to the school nurse (if any), to be *trained personnel*. The more in-depth training for staff members who may administer epinephrine (whether student-specific or undesignated) is also a best practice emphasized in the *CDC Guidelines*, which is referenced in the *ISBE Model*. **Issue 109, May 2022**

PRESSPlus 6. Number four refers to the CDC's *Voluntary Guidelines for Managing Food Allergies in Schools and Early Care and Education Programs*, at: www.cdc.gov/healthyschools/foodallergies/pdf/20_316712-A_FA_guide_508tag.pdf (*CDC Guidelines*), which is cited in the *ISBE Model* as a resource for a “full food allergy and prevention of allergen exposure plan.” Adopting the entire, voluminous *CDC Guidelines* document as policy is not practical. The *CDC Guidelines* also state that not every recommendation will be appropriate or feasible for every district's needs. The *National Association of School Nurses Allergies and Anaphylaxis Resources/Checklists*, at: <http://www.nasn.org/nasn-resources/resources-by-topic/allergies-anaphylaxis>, are also linked as a resource in the *ISBE Model*. The *ISBE Model* acknowledges that not all schools have access to school nurses or other health staff on a regular basis, and it encourages districts to take this into consideration when developing building-level plans. **Issue 109, May 2022**

PRESSPlus 7. Number five is required by 105 ILCS 5/2-3.182(c), added by P.A. 102-413. The notification must include contact information for parents/guardians to engage further with the district to learn more about individualized aspects of the policy. For ease of administration, districts may want to include this notification in student handbook(s). The Ill. Principal's Association (IPA) maintains a handbook service that coordinates with **PRESS** material, *Online Model Student Handbook (MSH)*, at: www.ilprincipals.org/resources/model-student-handbook. **Issue 109, May 2022**

PRESSPlus 8. 105 ILCS 5/2-3.182(e) provides that ISBE shall review and update its model policy at least once every three years. Although this section does not expressly state that boards must also conduct a review within this time frame, that is the logical conclusion based on a board's duty in 105 ILCS 5/10-16.7 to direct the superintendent through policy. **Issue 109, May 2022**

We have been a member of the Collective Liability Insurance Cooperative (CLIC) since November 2004. CLIC is a self-funded insurance cooperative currently representing 188 school districts throughout Illinois. The coverage includes all property, automobile, general liability, boiler/machinery, school board liability, crime, student accident, concussion, excess property, excess liability, cyber risk, fiduciary liability and if needed foreign travel and builders' risk. The executive summary of the renewal along with specific limits of coverage by type, deductible and other related information is attached.

The annual renewal meeting for 2022-23 was held May 19, 2022 with the final program funding approved by the membership. Therefore, our "tentative" annual premiums, including the separate fiduciary policy, will be \$315,702 (\$313,552+\$2,150). This is tentative in that CLIC has not yet secured coverage for the Cyber Liability insurance. Therefore, the tentative renewal reflects an increase of \$27,947 or 9.48% excluding the cyber coverage for both years. This renewal reflects both our five-year loss ratio that decreased slightly to 104.5% from the prior year 104.8%, the hardening insurance market and unprecedented challenges to secure cyber risk coverage. Once again, our five-year loss ratio resulted in a premium debit (increased cost) of 20% and it is primarily due to the air conditioning chiller claim in 2018-19 and the culvert washout claim in 2019-20. The CLIC pool continues to aggressively market the program and has created some unique pricing alternatives to assist us with driving costs down while not compromising coverage. As you will see in the attached CLIC Pool renewal letter, there are a number of coverage areas that are experiencing escalation in both frequency and severity of claim costs. In addition, they highlight some of the global market trends that affect the pricing, particularly cyber-attacks targeting school districts. The CLIC pool continues to provide extensive coverage at competitive pricing levels exclusively for schools.

They continue their strong commitment to address the escalating cyber risk with professional services to both harden our operations to prevent such actions and if necessary assist when such events take place. The insurance carriers that underwrite cyber coverage are escalating premiums and many have actually exited the market. The fact is that school districts are easy targets for these ransomware attacks and the financial impact is far exceeding the pricing from insurance carriers. Dr. Lenaghan has been actively working to protect the district and comply with the insurance underwriting conditions that should reduce the risk of such an event. The following year 2022-23 will include the full implementation of multi-factor authentication measures for all staff. We expect there will be further differentiation of membership and pricing by the CLIC pool for those that are implementing procedures, training and investing to minimize their cyber risk. Ultimately the purchase of insurance is an opportunity to shift some of the risk of financial exposure and operational disruption.

We complete an annual comprehensive risk assessment and claim review with the insurance pool to then target areas to minimize future losses and target safety training. We appreciate the quality of the program and professional services for both loss control and claims handling that the CLIC pool provides. We look forward to continuing to work with the CLIC pool service teams, and their partners, to minimize our risk exposure and protect the district.

⁽¹⁾ The CLIC Property/Casualty Program Management Operating Fee is allocated to each member by the CLIC treasurer. This fee is solely used to pay for those expenses such as the Treasurer Services, Legal Services, Publication of Safe Schools Newsletter, Appraisal Cost, Audit Expenses, D&O Insurance, Actuarial Expenses and Meeting Expenses that are needed to operate the pools operations. In the past, the cooperative has utilized loss fund interest earnings to pay for those expenses. Due to the lack of interest income to cover the cooperatives expenses, a slight fee must be allocated to each member. The CLIC Executive Committee concurred that beginning with the 2014/2015 renewal a Program Management Operating Fee will be instituted only on the Property/Casualty Program. The fee will be based upon the minimum fee of \$552 per district with a rate per student charge. The maximum amount a member district could pay is \$5,980. For Fiscal Year 2022-2023, the CLIC Executive Committee has elected to continue the suspension of this charge per the treasurer's recommendation due to sufficient interest earnings to cover these costs.

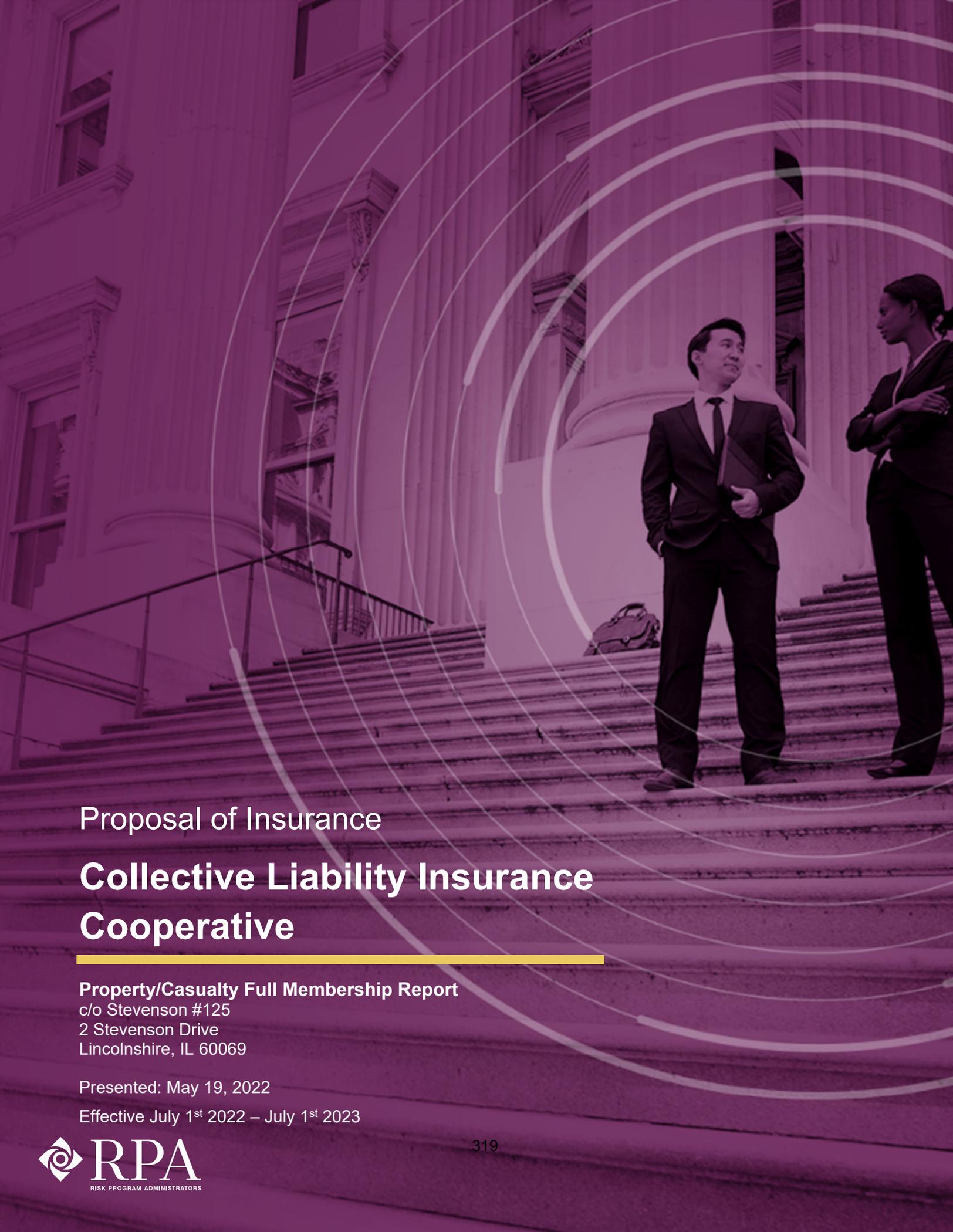

Executive Summary

PROPERTY/CASUALTY

On July 1, 2022 CLIC will celebrate its 40th year of service to Illinois Public School Districts. We are truly honored to have the opportunity to be of service to all of you.

The past two years have been a true test of character and patience for all of us. We have lived through a worldwide pandemic. Over 980,000 people in our country have lost their lives to this virus. If you or your family lost a family member caused by the virus during the last year our thoughts, as well as our hearts, go out to all of you. The pandemic has caused us to debate and think about things we haven't had to before; can masks be required in schools? Or should they be optional? Hopefully as the school year comes to a close we can put decisions like this behind us along with the litigation they led to (i.e. DeVore suit).

As discussed at our Mid-Year meeting in December, the state of the insurance marketplace continues to deteriorate for certain lines of coverage. We continue to see significant rate increases on property, school board legal liability, excess liability and cyber liability.

The pace of changes in the property marketplace continues to accelerate. Carriers are saying this continues to be the most dynamic property marketplace since 2001. Loss trends continue to outpace pricing models and as a result we have seen continuous rate increases due to their difficulty in obtaining reinsurance at a reasonable cost.

A few of the reasons why rates continue to rise as result of reinsurance issues are as follows:

- In the Midwest carriers continue to adjust their models to reflect severe convective storm loss costs. This means carriers have to go get and find additional reinsurance to protect themselves. Those costs on average are increasing over 50%.
- Inflation and costs of construction have caused insurers to mandate inflationary increases to ensure undervalued properties are not a concern. Carriers are scrutinizing client's statements of values based on construction costs showing unprecedented increases (2021 ended with costs up on average almost 20%). For CLIC's renewal we were able to get our insuring partners, Travelers to agree to an inflationary increase of 6%.
- When Hurricane Ida made landfall caused significant damages in the Southeast and Northeastern United States.

The casualty marketplace continues to see the effects of social inflation. In the umbrella/excess casualty market carriers are restricting the amount of limit they are willing to put forth. What this means to us is that many times we need to involve substantially more carriers at more premium to

have the same limits as expiring. Carriers continue to add exclusions for schools on sexual abuse, traumatic brain injury (TBI), opioids, cannabis and violent acts.

On the automobile liability, claims frequency has risen due to the dwindling talent pool of drivers. The average driver's age has surpassed 65 years. In addition new technology makes vehicles more expensive to repair.

The renewal terms offered by CLIC's primary liability, crime and stop-loss reinsurer, Great American Insurance Company, was a nominal increase to the premium rate and a modest decrease to the loss fund. Based on market conditions we were very happy to receive these terms.

In regards to the excess property renewal, we continue to maintain a very competitive rate which will be just over 2 cents for the upcoming policy term. Due to increases in reinsurance costs CLIC's excess property reinsuring partner, Travelers, needed a rate increase of just over 5% in addition to the inflation factor of 6% on values previously mentioned. While the percent increase appears somewhat substantial, it is important to remember the competitiveness of the rate CLIC has maintained over the years with standalone Public K-12 School Districts in Illinois on average having property rates of 6 – 10 cents.

As we approach the third year anniversary of the school board legal panel reboot, the results continue to show improvement. During this past fall CLIC embarked upon another legal review with QBE and the Summit Risk Teams. We had over 18 firms apply to be on the school board legal panel. The results of the reboot will be presented later during today's presentation.

Even with the reboot, school board legal liability claims from prior to the reboot 7-1-2014 to 7/1/2018 have continued to mature and settlements have risen.

For the 2022/2023 school board legal liability renewal, we will see a competitive renewal with slight increases in premium and loss fund contributions.

As we have been driving home the past couple years, due to cyber claims frequency and severity, the impact and the uncertainty have left insurers with no choice but to strengthen their underwriting requirements. They have restricted their scope of coverage, limits of liability and have increased their rates. Carriers are less and less willing to cover reinsurance costs and in many cases are pushing for cost sharing with insureds.

As we have said numerous times during the past year, carriers are looking for minimum cyber loss control measures be in place:

- Multi Factor Authentication (MFA)
 - For All Staff Email
 - For Critical Systems
 - For Cloud Deployments

- Weekly Backup of Data & Systems stored in an offsite location (Disconnected from Main Network & Encrypted)

- Endpoint Detection & Response (EDR)
- Annual Phishing Training for Staff & Quarterly Exercises
- Regular Updating of software patches/fixes including Anti-Virus software and Firewalls
- Business Continuity Plan
- Active System Monitoring

Public entities with the above controls and protocols in this marketplace are seeing premium increases in the 40%-60% range. Those without are seeing increases beginning at 150% with some coverages excluded, or in a worst case scenario terms not being offered at all.

CLIC will continue to be able to offer all members Cyber protection with those without the proper protocols seeing sublimits on Ransomware coverages.

A new product that is being incorporated into the CLIC program of coverages for the 2022/2023 policy term is a program that helps members meeting ADA compliance on their websites. The program is administered by AAAtraq. The firm assists your Tech team in addressing ADA compliance updates that are needed as well as making sure website updates moving forward are in compliance. Your executive committee felt this coverage is needed by all districts that they elected to make this a mandatory coverage for all members and it will not cost a member any premium. It will be paid for out of interest earnings for the 2022/2023 policy term and be effective July 1, 2022.

CLIC's boiler and machinery carrier is the Chubb Insurance Company. Chubb has been a long term strategic partner for the cooperative. Last year we negotiated a two year rate guarantee subject to a loss ratio. We are pleased to announce we qualified for that guarantee in 2022 and even better yet, extended the rate guarantee another year (subject to favorable losses).

CLIC's Student Accident coverage is written by Amwins/Zevitz and is going on a year two of a rate guarantee. If you also remember last year, we raised the catastrophic coverage benefit from \$5,000,000 to \$6,000,000 for all CLIC districts.

CLIC's ancillary lines of coverage such as Gallagher Crisis protect, foreign liability, pollution liability and fiduciary liability, all of these lines are seeing competitive renewals terms from a coverage and pricing standpoint.

In spite of the unfavorable marketplace with cyber liability coverage, CLIC's 2022/2023 renewal pricing, coverages, limits and deductibles remain highly competitive. We continue to be approached by local school districts who find CLIC extremely attractive.

As we have seen during these past few years of a hard market CLIC offers distinct security, stability, and protection from the standard marketplace. CLIC continues to be ranked nationally as one of the premier scholastic cooperatives in the risk management community. Many carriers would like to be partners with CLIC.

As we embark from the COVID era and return to some form of normalcy in our lives and workplaces, we want to thank you and your staff for your time and dedication that each of you brought to your districts and staff during the past two years.

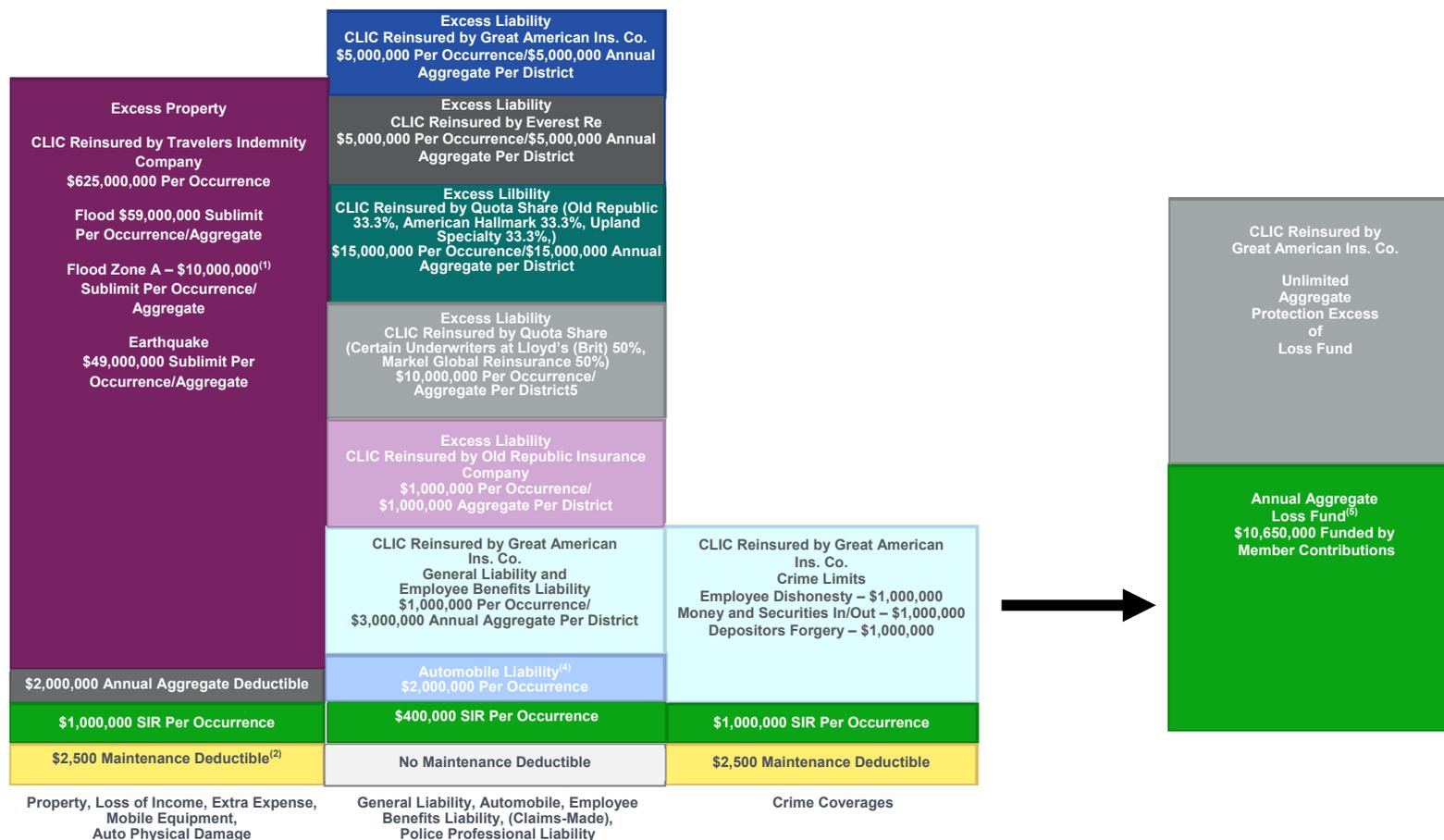

Primary School Board Legal Liability

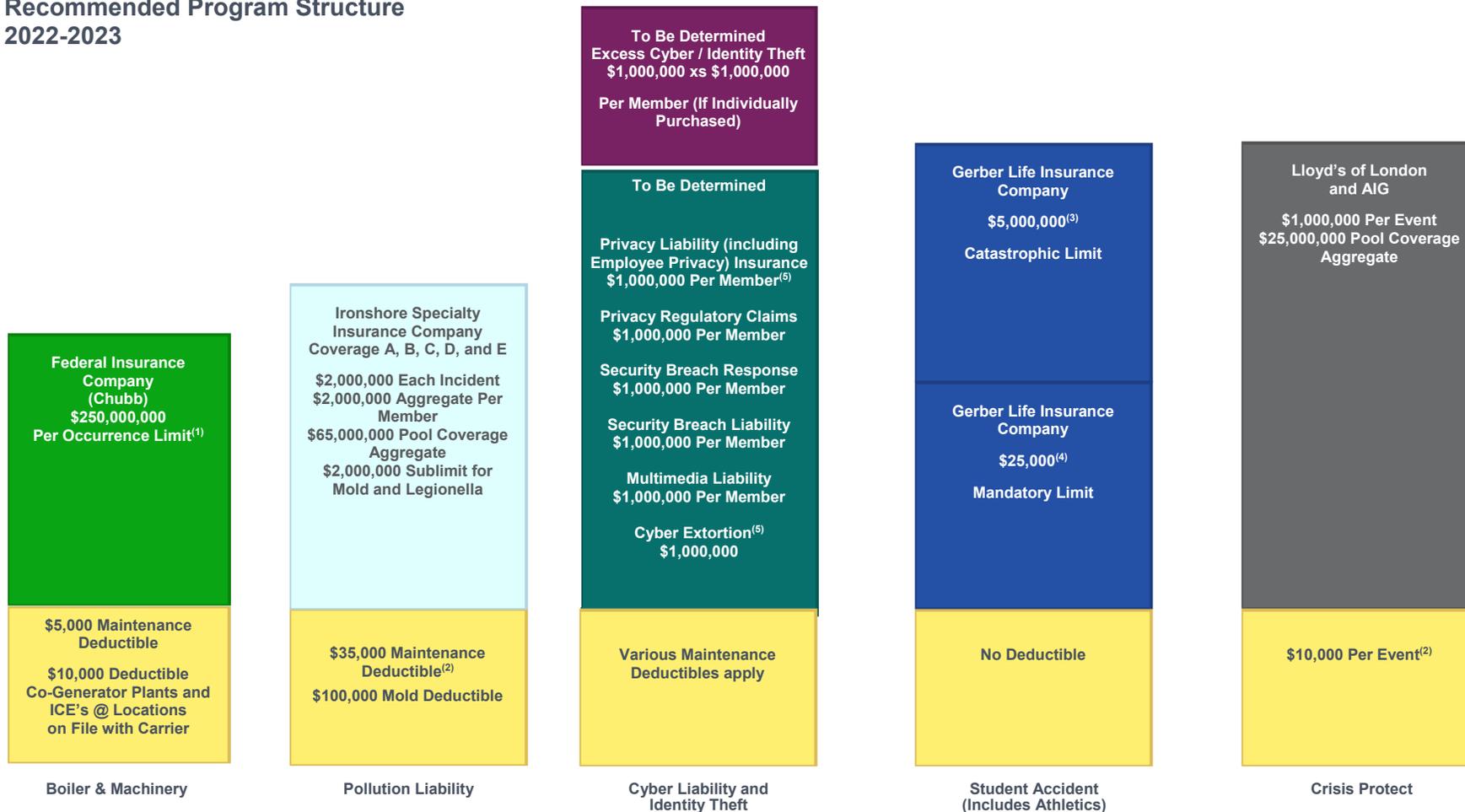

2:230 Public Participation at School Board Meetings and Petitions to the Board

The School Board will allocate an overall minimum of 30 minutes for public participation (any person may comment to or ask questions of the School Board). The public participation session of the School Board meeting is subject to the reasonable constraints established and recorded in this policy's guidelines below. During public participation, there will be a 20-minute minimum total length of time for any one subject. When public participation takes less time than these minimums, it shall end.

To preserve sufficient time for the Board to conduct its business, any person appearing before the Board is expected to follow these guidelines:

1. Address the Board only at the appropriate time as indicated on the agenda and when recognized by the Board President.
2. Identify oneself and be brief. Ordinarily, the time for any one person to address the Board during public participation shall be limited to five minutes. In unusual circumstances, and when an individual has made a request to speak for a longer period of time, the person may be allowed to speak for more than five minutes.
3. Observe, when necessary and appropriate, the:
 - a. Shortening of the time for each person to address the Board during public participation to conserve time and give the maximum number of people an opportunity to speak;
 - b. Expansion of the overall minimum of 30 minutes for public participation and/or the 20-minute minimum total length of time for any one subject; and/or
 - c. Determination of procedural matters regarding public participation not otherwise covered in Board policy.
4. Conduct oneself with respect and civility toward others and otherwise abide by Board policy 8:30, *Visitors to and Conduct on School Property*.

8:30 Visitors to and Conduct on School Property

The following definitions apply to this policy:

School property - District and school buildings, grounds, and parking areas; vehicles used for school purposes; and any location used for a School Board meeting, school athletic event, or other school-sponsored or school-sanctioned events or activities.

Visitor - Any person other than an enrolled student or District employee.

All visitors to school property are required to report to the Building Principal's office and receive permission to remain on school property. All visitors must sign a visitors' log, show identification, and wear a visitor's badge. When leaving the school, visitors must return their badge. On those occasions when large groups of parents/guardians, friends, and/or community members are invited onto school property or when community members are attending Board meetings, visitors are not required to sign in but must follow school officials' instructions. Persons on school property without permission will be directed to leave and may be subject to criminal prosecution.

Except as provided in the next paragraph, any person wishing to confer with a staff member should contact that staff member to make an appointment. Conferences with teachers are held, to the extent possible, outside school hours or during the teacher's conference/preparation period.

Requests to access a school building, facility, and/or educational program, or to interview personnel or a student for purposes of assessing the student's special education needs, should be made at the appropriate building. Access shall be facilitated according to guidelines from the Superintendent or designee.

The School District expects mutual respect, civility, and orderly conduct among all people on school property or at a school event. No person on school property or at a school event (including visitors, students, and employees) shall perform any of the following acts:

1. Strike, injure, threaten, harass, or intimidate a staff member, Board member, sports official or coach, or any other person.
2. Behave in an unsportsmanlike manner, or use vulgar or obscene language.
3. Unless specifically permitted by State law, possess a weapon, any object that can reasonably be considered a weapon or looks like a weapon, or any dangerous device.
4. Damage or threaten to damage another's property.
5. Damage or deface school property.
6. Violate any Illinois law, or town or county ordinance.
7. Smoke or otherwise use tobacco products.
8. Distribute, consume, use, possess, or be impaired by or under the influence of an alcoholic beverage, cannabis, other lawful product, or illegal drug.
9. Be present when the person's alcoholic beverage, cannabis, other lawful product, or illegal drug consumption is detectable, regardless of when and/or where the use occurred.
10. Use or possess medical cannabis, unless he or she has complied with policy 7:270, *Administering Medicines to Students*, implementing *Ashley's Law*.
11. Impede, delay, disrupt, or otherwise interfere with any school activity or function (including using cellular phones in a disruptive manner).

12. Enter upon any portion of school premises at any time for purposes other than those that are lawful and authorized by the Board.
13. Operate a motor vehicle: (a) in a risky manner, (b) in excess of 20 miles per hour, or (c) in violation of an authorized District employee's directive.
14. Engage in any risky behavior, including roller-blading, roller-skating, or skateboarding.
15. Violate other District policies or regulations, or a directive from an authorized security officer or District employee.
16. Engage in any conduct that interferes with, disrupts, or adversely affects the District or a School function.

Convicted Child Sex Offender

State law prohibits a child sex offender from being present on school property or loitering within 500 feet of school property when persons under the age of 18 are present, unless the offender is:

1. A parent/guardian of a student attending the school and has notified the Building Principal of his or her presence at the school for the purpose of: (i) attending a conference at the school with school personnel to discuss the progress of his or her child academically or socially, (ii) participating in child review conferences in which evaluation and placement decisions may be made with respect to his or her child regarding special education services, or (iii) attending conferences to discuss other student issues concerning his or her child such as retention and promotion; or
2. Has permission to be present from the Board, Superintendent, or Superintendent's designee. If permission is granted, the Superintendent or Board President shall provide the details of the offender's upcoming visit to the Building Principal.

In all cases, the Superintendent, or designee who is a certified employee, shall supervise a child sex offender whenever the offender is in a child's vicinity.

Exclusive Bargaining Representative Agent

Upon notifying the Building Principal's office, authorized agents of an exclusive bargaining representative will be provided reasonable access to employees in the bargaining unit they represent during duty free time in accordance with State law. Such access shall be conducted in a manner that will not impede the normal operations of the District.

Enforcement

Any staff member may request identification from any person on school property; refusal to provide such information is a criminal act. The Building Principal or designee shall seek the immediate removal of any person who refuses to provide requested identification.

Any person who engages in conduct prohibited by this policy may be ejected from school property. The person is also subject to being denied admission to school events or meetings for up to one calendar year.

Procedures to Deny Future Admission to School Events or Meetings

Before any person may be denied admission to school events or meetings as provided in this policy, the person has a right to a hearing before the Board. The Superintendent may refuse the person admission pending such hearing. The Superintendent or designee must provide the person with a hearing notice, delivered or sent by certified mail with return receipt requested, at least ten days before the Board hearing date. The hearing notice must contain:

1. The date, time, and place of the Board hearing;
2. A description of the prohibited conduct;
3. The proposed time period that admission to school events will be denied; and
4. Instructions on how to waive a hearing.

This position would allow the district to have the next Chief Financial Officer work alongside Mr. Hoster for one year. This will allow for the seamless transition of the position and ensure we continue to meet the financial goals of the district.

We are recommending the approval of Mr. Ryan Domeracki for the position of Assistant Chief Financial Officer for the 2022-2023 school year.

It is recommended that the board approve the appointment of Ryan Domeracki as Assistant Chief Financial Officer, effective July 1, 2022, with a base salary of \$130,000 and Board Paid employee share of IMRF Pension at \$6,125.60. Board Paid Health Insurance \$24,644.20 and a Board paid Life Insurance policy valued at \$289.80 for a total compensation package of \$161,079.60.

Move that the Board of Education approve the appointment of Mr. Ryan Domeracki as Assistant Chief Financial Officer, as presented, effective July 1, 2022.

Appointment of Chief Financial Officer (2023)

District 88 has a strong financial footing and is well respected within the county and recognized at the state level for our excellent financial rating. Mr. Hoster and the Chief Financial Officers who came before him have helped place the district in a position to provide all students with the resources they need to succeed in school and life

We are recommending the approval of Mr. Ryan Domeracki for the position of Chief Financial Officer in 2023-2024. Ryan has demonstrated exemplary leadership during his 4 years as the Director of Business Services. Ryan's role in accounts receivable and payable, student transportation, the national school lunch program, and overseeing the building operations has helped to prepare him for the position of Chief Financial Officer. Ryan has also worked closely with the building administration to review daily operations along with organizing safety procedures and training for the building teams. Ryan's professionalism, attention to detail, work ethic, and passion for the district make him an ideal candidate for this role.

Prior to his current role as Director of Business Services, Ryan was the Assistant Director of Finance and Operations at North Chicago CUSD 187 for 2 years. Like in his current role, Ryan oversaw accounts receivable and payable, transportation, food service, operations, and security. Before entering the education arena, Ryan worked for almost 5 years for Aon Hewitt as an Operations Manager. Ryan received his undergraduate degree in Finance and Economics from Western Illinois University and his Masters of Arts in Educational Administration, Chief School Business Official from Northern Illinois University.

It is also recommended that the board approve the appointment of Ryan Domeracki as Chief Financial Officer/Chief School Business Official, effective July 1, 2023, with a base salary of \$160,000, Board Paid TRS Pension at \$15,824.16, Board Paid THIS at \$1,440.00. Board Paid Health Insurance \$24,644.20 and a Board paid Life Insurance policy valued at \$485.76 for a total compensation package of \$202,414.12. (the THIS and Health Insurance are subject to change once 2023 rates are released).
