If, during the course of this meeting it is determined that discussion of any item on the agenda, in addition to the items specified below, should be held in a closed session, the Board will conduct a closed session in accordance with the Texas Open Meetings Act, Tex. Government Code, Chapter 551, Subchapters D and E. Before any closed meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the closed meeting. All final votes, actions or decisions will be taken in the open meeting. The subjects to be discussed or considered, or upon which any formal action may be taken, are as follows: (Items do not have to be taken in the same order as shown on the meeting notice.)

1. Call to Order - Determine if a Quorum is Present
2. Pledge of Allegiance to the United States and Texas Flags
3. Moment of Silence
4. Public Forum/Comments to Board (limit 5 minutes each or 30 minutes total)
5. Executive Session as authorized by Government Code, Chapter 551, Subchapters D and E:
 - A. Pursuant to Texas Government Code Section 552.0821, deliberation and possible action regarding a matter involving a public school student which may reveal personally identifiable information about the student.
 - B. Pursuant to Texas Government Code Section 551.074, to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee.
 - C. Pursuant to Texas Government Code Section 551.071, to consult with the District's attorney, in person or by phone, to seek the advice regarding pending or contemplated litigation, a settlement offer, or on a matter in which the duty of the attorney to the District under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Texas Government Code.
 1. Consultation with the Board's attorney regarding process and procedures for the hearing to be conducted in agenda items 5.C.2 and 5.C.3.
 2. Pursuant to Board Policy FNG (LOCAL), conduct a hearing regarding the consolidated Level III complaints filed by Mr. and Mrs. Wes Timmons on December 9, 2014, and January 8, 2015.
 3. Pursuant to Board Policy FNG (LOCAL), conduct a hearing regarding the Level III complaint filed by Mr. and Mrs. Wes Timmons on December 12, 2014.
 4. Consultation with the Board's attorney regarding agenda items 7.A and 7.B.
