Trustees may take action to authorize Superintendent to act on behalf of the District moving forward in the aforementioned Writ of Mandamus legal matter. Superintendent shall be the District's representative in this matter and may take certain actions to further the lawsuit, including but not limited to, communicate with counsel, negotiate with opposing party, and make decisions regarding full and final resolution of the matter.
