Pursuant to due call and notice thereof, a special meeting of the School Board of Independent School District No. 146 (Barnesville Public Schools), State of Minnesota, was duly held in the School District on November 12, 2024, at 7:00 o'clock p.m. for the purpose, in part, of canvassing its special election.

Member Andrew Maier moved the adoption of the following resolution:

**RESOLUTION CANVASSING RETURNS
OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 146, State of Minnesota, as follows:

1. It is hereby found, determined and declared that the special election of the voters of this School District held on November 5, 2024, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 2,730 voters of the School District voted on the question of increasing the general education revenue of the School District for taxes payable in 2025 and thereafter (SCHOOL DISTRICT QUESTION 1), of which 1,065 voted in favor, 1,665 voted against the same. Said proposition, having (not) received the approval of at least a majority of such votes, is hereby declared to have carried (failed).

3. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 2,658 voters of the School District voted on the question of increasing the general education revenue of the School District for taxes payable in 2025 and thereafter (SCHOOL DISTRICT QUESTION 2), of which 993 voted in favor, 1,665 voted against the same. The passage of School District Question 2 is contingent upon the passage of School District Question 1. School District Question 1 having carried (failed), and Question 2 having (not) received the approval of at least a majority of such votes, Question 2 is hereby declared to have carried (failed).

4. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 2,652 voters of the School District voted on the question of approving a capital project levy authorization for taxes payable in 2025 and thereafter (SCHOOL DISTRICT QUESTION 3), of which 978 voted in favor, 1,674 voted against the same. Said proposition, having (not) received the approval of at least a majority of such votes, is hereby declared to have carried (failed).

5. The Clerk is hereby directed to certify the results of the election to the county auditor of each county in which the School District is located in whole or in part. The Clerk is further directed to notify the Commissioner of Education of the results of the special election within fifteen (15) days following the adoption of this resolution.
