- Kathy nominated Trina Perez for board chair; Vanessa seconded.
- Both nominees, Andrew Biggs and Trina Perez, confirmed they were willing to serve.
- The board proceeded to vote first on the nomination for Andrew Biggs.
- Andrew Biggs was elected board chair with four votes in favor (Kelsey, Andrew, Andrea, and Nicole).
- Andrew Biggs will serve as the new board chair for the 2025-2026 school year.

2.2. Nominations & Elections of the 2025-2026 KFCS Board of Education Vice Chair

- The board opened nominations for the position of 2025-2026 Board Vice Chair.
- Andrea Jensen was nominated for vice chair by Nicole Trejo and the nomination was seconded by Andrew Biggs.
- Trina Perez was also nominated for vice chair by Kathy Hewitt, and the nomination was seconded by Vanessa Bennett.
- Both nominees, Andrea Jensen and Trina Perez, accepted their nominations.
- A vote was held for Andrea Jensen as vice chair, receiving votes from herself, Nicole and Andrew.
- A vote was then held for Trina Perez as vice chair. Trina received four votes in favor (herself, Kathy, Vanessa, and Kelsey).
- Trina Perez was elected vice chair of the board for the 2025-2026 school year.

2.3. Approval of Resolution #26-01, Legislative Service Year 2025-2026

- A comment was made to have the option to conduct this organizational business in July or potentially wait until August next year.

- The board reviewed the consent agenda, which included:

- A discussion was held about whether the district conducts exit interviews when staff resign. Administration confirmed exit interviews are offered but not consistently conducted, and participation is limited. Board members expressed interest in potentially improving this process to better understand staff turnover.

MOTION: Kelsey Bitzer made a motion to approve the consent agenda items as presented, Vanessa Bennett seconded the motion.

DISCUSSION: Andrew Biggs recognizing the motion and second called for discussion, seeing none he called for the vote.

VOTE: Andrea Jensen, Andrew Biggs, Nicole Trejo, Vanessa Bennett, Trina Perez, Kelsey Bitzer and Kathy Hewitt voted in the affirmative. There were no dissentions. **The motion carried.**

4. NEW BUSINESS/ACTION ITEMS

4.1. Approval of the Students Rights and Responsibilities Handbook: 2025-2026 Code of Conduct

Presenter: Renee Clark, Human Resources Director

Summary – Approval of 2025-2026 Code of Conduct

- **Presentation & Purpose:**
 - The 2025-2026 Code of Conduct was presented for approval. It contains updates based on board-approved policies revised over the past year.
- **Cell Phone Policy Discussion:**
 - Board members raised questions about the new state mandate prohibiting cell phone use in schools.
 - Currently, the district's policy has not changed; updates are pending further directives from ODE.

- The new policy must be adopted by October 31, 2025, with full implementation by January 1, 2026.
- Discussion occurred around potentially updating handbooks now to avoid conflicting guidance next year. It was clarified that handbooks typically update annually, but any significant mid-year changes could be communicated separately to families.
- **Communication & Clarity of the Document:**
 - A board member suggested creating a simpler, one-page summary of student and parent rights and responsibilities to accompany the longer, legally detailed Code of Conduct, so expectations are clearer for families.
- **Discussion on Flag Etiquette Instruction:**
 - Concerns were shared regarding students' behavior during the national anthem at events, despite the Code stating instruction would be provided on flag respect.
 - Administration confirmed principals have been reminded to include such instruction, although implementation varies by school and setting. The schools will strengthen their procedures for teaching students how to properly prepare for reciting the Pledge of Allegiance and singing the National Anthem.

MOTION: Vanessa Bennett made a motion to the Students Rights and Responsibilities Handbook: 2025-2026 Code of Conduct as presented, Kelsey Bitzer seconded the motion.

DISCUSSION: Andrew Biggs recognizing the motion and second called for discussion, seeing none he called for the vote.

VOTE: Andrea Jensen, Andrew Biggs, Nicole Trejo, Vanessa Bennett, Trina Perez, Kelsey Bitzer and Kathy Hewitt voted in the affirmative. There were no dissentions. **The motion carried.**

4.2. Approval of the Elementary Student/Parent 2025-2026 Handbook Presenter: Renee Clark, Director of Human Resources

Summary – Approval of Elementary Student/Parent Handbook

- The board reviewed the elementary student/parent handbook for 2025-26.
- Updates include revised policies, dates, and new sections on the ROOMS program (communication platform), the Raptor visitor system, and Medicaid parental notifications.
- A suggestion was made to add footer labels to printed pages of all school handbooks (elementary, middle, and high school) for clarity.
- A discussion arose about the state's policy allowing students with head lice to attend school. Board members and staff shared concerns and experiences, noting that the district follows Oregon Health Authority (OHA) guidance and handles situations individually. There's potential to explore creating a district-specific policy.

- Board members discussed consistency among school handbooks, suggesting common elements like strategic priorities, and aligning rules (e.g., cell phones, energy drinks, dress code) to avoid confusion as students move between schools.
- Dress code enforcement was a major topic.
 - Members stressed the need for consistent enforcement, especially in elementary and middle school, to prepare students for high school expectations.
 - Administrators acknowledged challenges, including student defiance, teacher discomfort in addressing dress code violations, and balancing discipline with maintaining students in class.
 - Ideas included creating clear, simplified summaries of key rules for parents and students to sign, and producing educational videos that could be shared across grade levels.
 - Principals shared efforts to enforce dress codes, especially regarding items like pajama pants and revealing clothing, with noted improvements at Ponderosa Middle School.
- Additional discussion addressed differences in rules like hats in school, with administrators explaining the rationale for relaxing some prohibitions while still addressing respect and professional standards.
- The conversation emphasized the importance of consistency, clear communication, and proactive education around expectations, especially for dress code and personal conduct.

MOTION: Kelsey Bitzer made a motion to approve the 2025-2026 Elementary Student/Parent Handbook as presented, Nicole Trejo seconded the motion.

DISCUSSION: Andrew Biggs recognizing the motion and second called for discussion, seeing none he called for the vote.

VOTE: Andrea Jensen, Andrew Biggs, Nicole Trejo, Vanessa Bennett, Trina Perez, Kelsey Bitzer and Kathy Hewitt voted in the affirmative. There were no dissentions. **The motion carried.**

4.3. Approval of the Secondary Student/Parent 2025-2026 Handbooks

Presenter: Renee Clark, Director of Human Resources

Summary – Approval of Secondary Student/Parent Handbooks

- The board reviewed the secondary student/parent handbooks for KUHS, Eagle Ridge, KLC, and Ponderosa.
- Extensive discussion focused on updates and revisions, including:
 - **Weighted GPA and Valedictorian Criteria:**
 - New weighted GPA system to start with incoming freshmen.
 - Honors/AP courses to carry higher weight; clarification requested on labeling AP vs. honors classes.
 - Questions were raised about how outside AP courses should count toward honors credit and GPA calculations.
 - **Grade Scale Changes:**

- Discussion on including “A+” designations and whether to simplify grading scale.
- **Valedictorian Calculation Details:**
 - Clarification provided on handling pass/no pass grades, transfer credits, and the impact of different credit loads on rankings.
- **Athletics Handbook Revisions:**
 - Debate over removal of explicit references to theft, vandalism, and cheating as athletic violations; board members favored keeping these infractions explicitly listed to ensure consistent standards across student activities.
 - Discussion about uniformity of rules across different sports teams, rather than allowing each coach to maintain separate discipline policies.
 - Discussion about academic eligibility requirements for student-athletes and ensuring clear communication to parents and students.
- **Truancy Notifications:**
 - Members requested restoring parent contact for first truancy offenses rather than waiting until a second incident.
- **Cell Phone Policy:**
 - Consensus to implement a bell-to-bell cell phone ban, aligning with anticipated state requirements, but allowing use off-campus during open lunch periods.
- **Dress Code Enforcement:**
 - Ongoing concerns about consistency, challenges enforcing dress code at the high school level, and the importance of reinforcing standards in elementary and middle school to set expectations for high school.
 - Discussion about hats being allowed in school but emphasizing removal during national anthem or Pledge of Allegiance as a sign of respect.
- **Communication Suggestions:**
 - Interest in adding footers identifying the specific school to printed handbook pages.
 - Suggestions to create clear summary documents of key rules (e.g. cell phones, dress code, expectations) for families to sign and acknowledge, to complement the longer handbooks.
 - Encouragement to produce educational videos for consistency across grade levels.
- **Energy Drinks:**
 - Noted discrepancy in rules prohibiting energy drinks at Ponderosa while they’re available at KU, suggesting the need for alignment across schools.
- **Agreed Changes:**
 - Add explicit references to academic dishonesty, theft, and vandalism back into the athletic policy.
 - Clarify language distinguishing AP and honors courses and criteria for external AP credits.
 - Implement bell-to-bell cell phone prohibition on campus.

- Clarify GPA calculation rules in handbook text.

DISCUSSION: Andrew Biggs recognizing the motion and second called for discussion, seeing none he called for the vote.

VOTE: Andrea Jensen, Andrew Biggs, Nicole Trejo, Vanessa Bennett, Trina Perez, Kelsey Bitzer and Kathy Hewitt voted in the affirmative. There were no dissentions. **The motion carried.**
