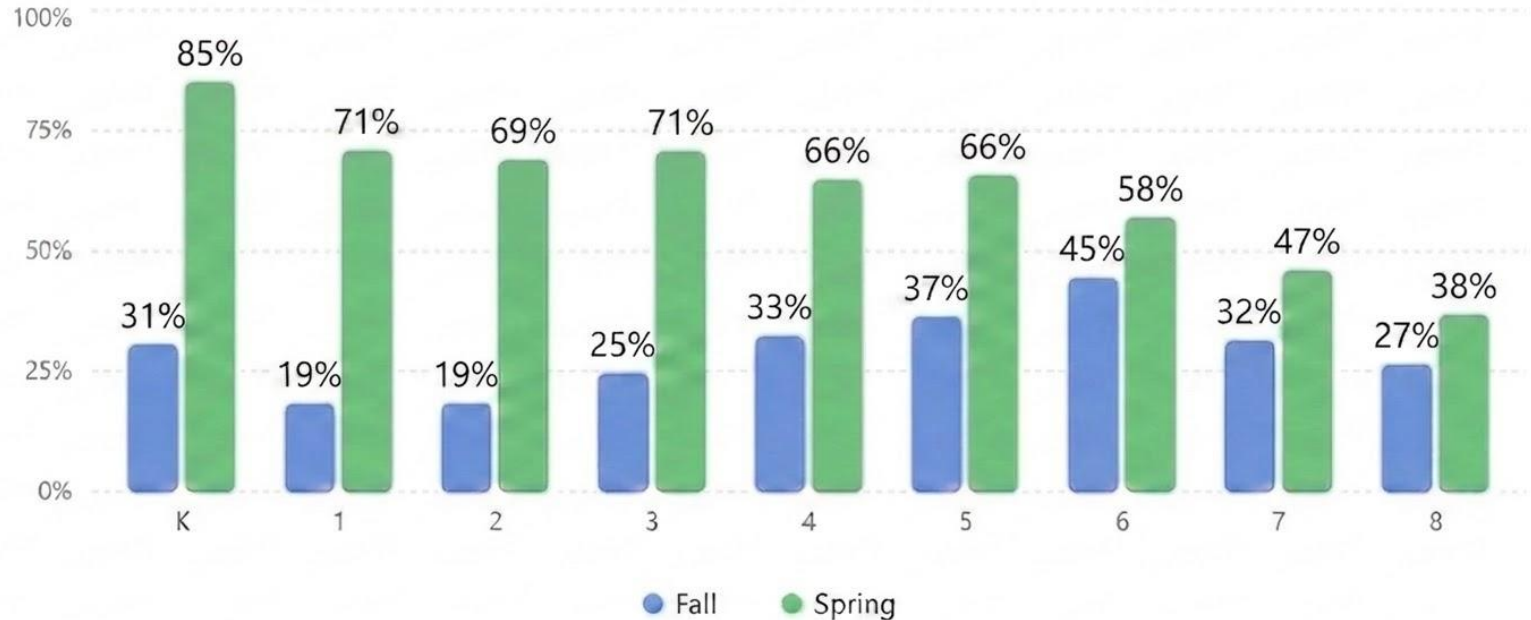

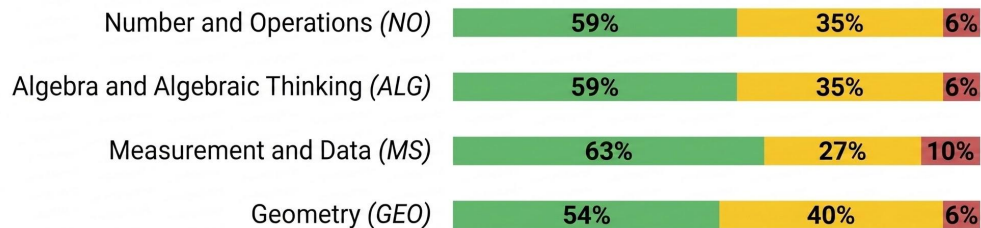
Math Achievement Fall or Spring

Percentage of students performing on or above grade level in math by grade.

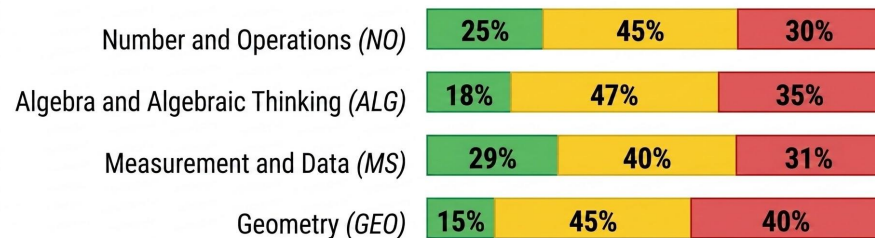


Placement by Domain In Math

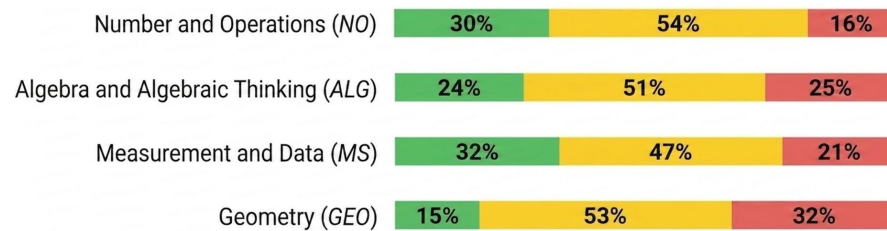

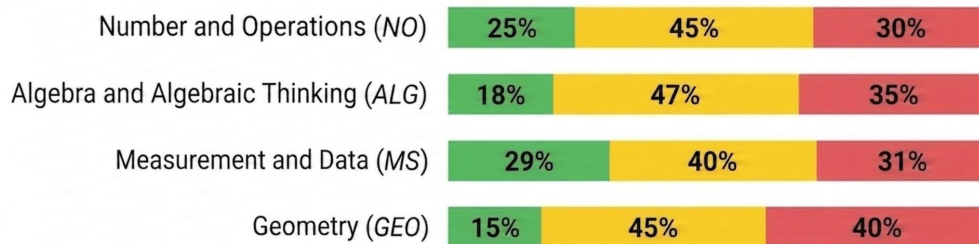

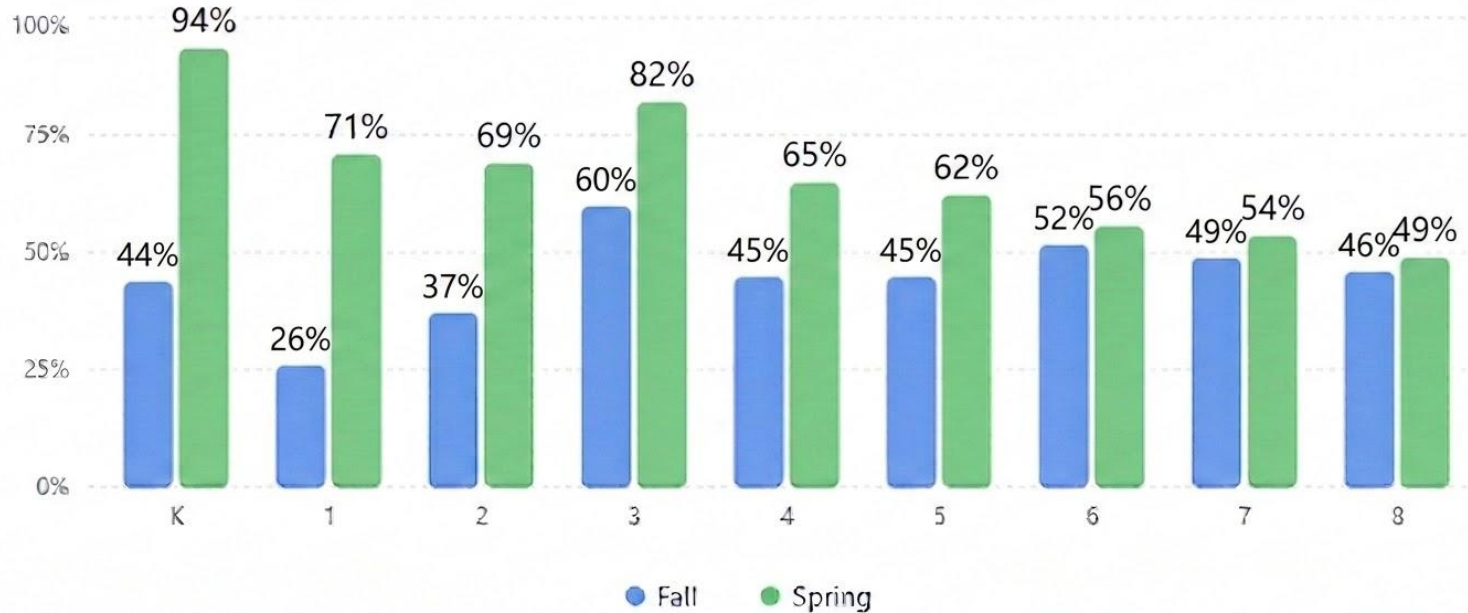

Reading Growth Data

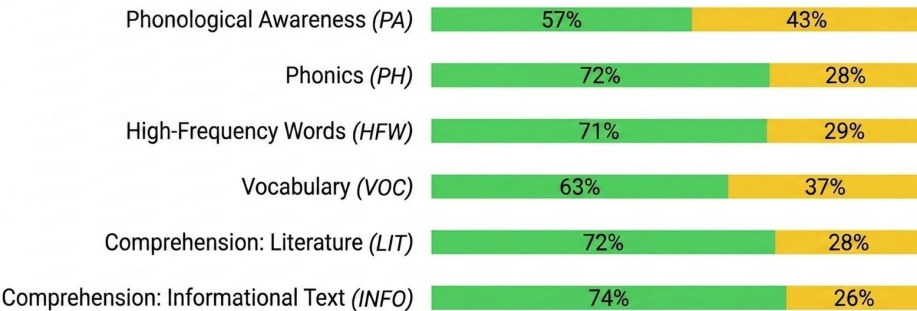
Fall vs. Spring Reading Achievement

Percentage of students performing on or above grade level in reading by grade.

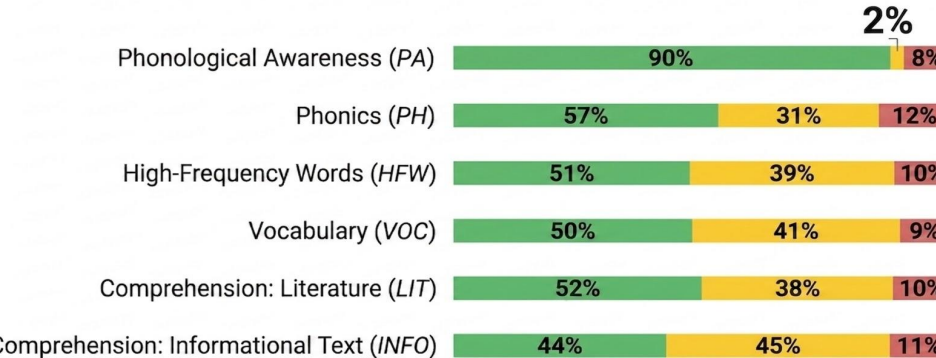

Although we celebrate our consistent growth, the percentage of students performing at or above grade level in both reading and mathematics remains below the expectations we have for our students.

We will continue to strengthen our Tier 1 instruction and provide targeted Tier 2 interventions especially in the areas of vocabulary, informational text comprehension and geometry.

Teachers will continue to work to analyze our Tier 1 curriculum to make adjustments as needed, including the standards being taught and pacing.

Moving Forward



Our newly implemented literacy and math blocks with a push-in intervention model, will address consistency across all schools and grade levels, k-5.

District wide, the new Professional Learning Communities model will strengthen our focus of using student data to adjust and inform instruction.

In the fall we will compare the i-Ready scores to M-Step scores to identify more trends and gaps.
