4.1 Student Enrollment Update and Classroom Openings

Mrs. Palese provided an enrollment update. Since August 2025, Mid-Valley has welcomed forty new students, with 2 additional pending placement. Eighteen students have either returned to their home schools, accepted their diplomas, or moved.

4.2 Staffing Update

Mr. McDonald reported no significant changes.

4.3 2026-27 Projections Update

Mrs. Palese shared current estimates indicate we will begin the 2026–27 school year with approximately 48 more students than at the start of August 2025. Based on these early projections, we anticipate starting out the year with several classrooms filled or close to capacity.

4.4 2026-27 Staffing Update

Mrs. Palese informed that the current plan reflects an overall reduction compared to the 2025–26 board-approved staffing levels, including decreases of 4.3 FTE certified/therapist staff and 5.0 FTE classified staff. It is important to note that these recommendations remain preliminary and may change as additional referrals are received and pending student placements are finalized.

Mr. McDonald shared the Business Meeting Minutes. Key points were Billing for FY27 and Transition Facility discussion.

RE: Monthly Financial Report - April 2026

Background: Administration monitors revenues and expenditures on an ongoing basis and provides the Board with monthly financial updates. The following reflects the financial position as of April 30, 2026.

Discussion:

Revenue:

As of April 30, total revenue received is approximately \$17,670,543.69, representing strong overall collection performance relative to the adopted budget. Tuition revenue has reached approximately 95.2% of the budget, indicating that the majority of anticipated revenue has been realized. Other local revenue is significantly exceeding expectations at approximately 224.1% of the budget, driven by higher than anticipated receipts in this category. State and federal revenue stands at approximately 74.5% of the budget, reflecting typical timing differences associated with payment and reimbursement cycles.

Current collections indicate that revenue performance remains strong and continues to support the organization's positive financial outlook and operational stability. At this time, there are no areas of concern within the revenue budget.

Expenditures:

Total expenditures through April are approximately \$13,494,483.21, reflecting continued alignment with budget expectations. Instructional expenses are at approximately 70.1% of budget, demonstrating a controlled pace of spending relative to the fiscal year timeline. Administration and Board expenses are at approximately 75.9% of budget, indicating moderate utilization with no significant concerns. Operations and Maintenance expenses are at approximately 79.8% of budget, trending slightly higher than other categories but remaining within an expected range for this point in the year.

Overall, spending across instructional and support service areas remains stable, with no significant variances noted. The organization continues to maintain a solid financial position, supported by consistent expenditure management and favorable revenue performance.

As of April 30, 2026, the Cooperative's cash position remains stable and sufficient to meet current operational needs.

Recommendation: Administration recommends that the Board accept the Mid-Valley Financial Report as presented.

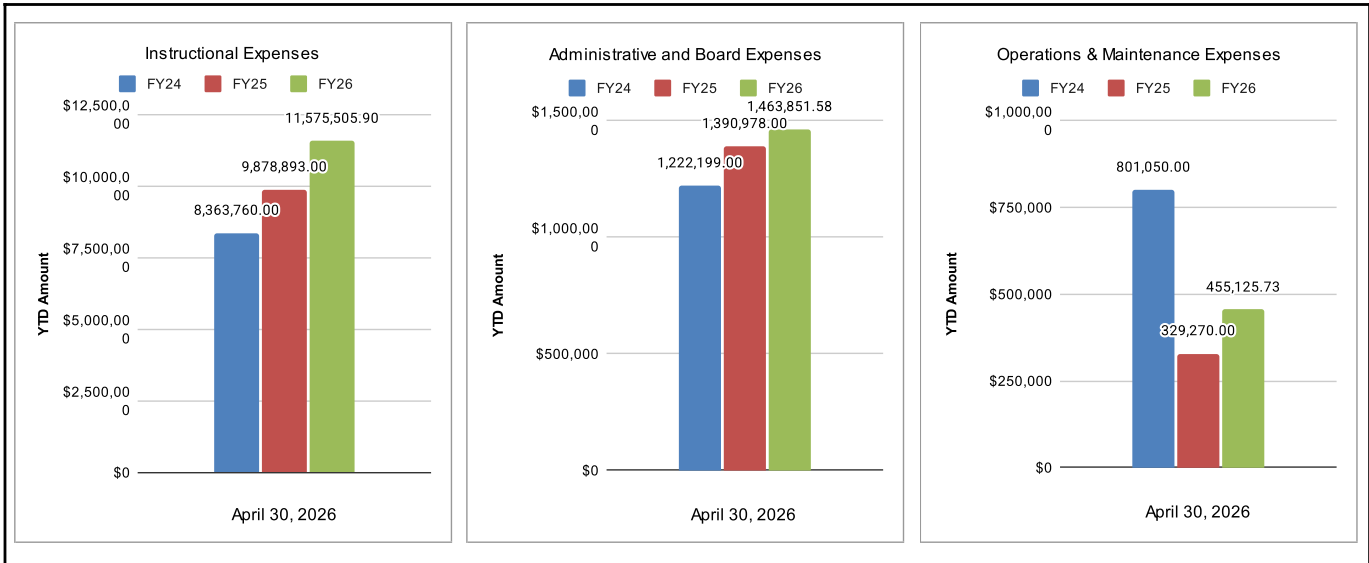

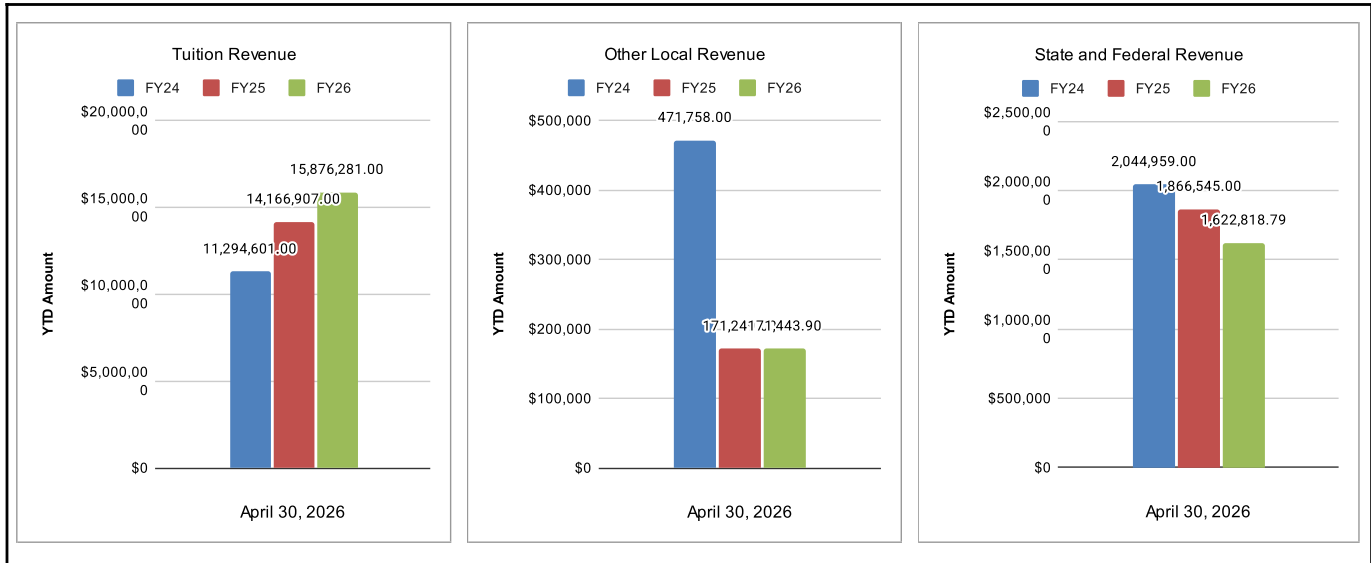
Expense Insight:

Year-to-date expenses across all major categories continue to track generally in line with budget expectations through April. Instructional expenses are at approximately 70.1% of budget, reflecting a controlled pace of spending relative to the fiscal year timeline. Administration and Board expenses are at 75.9% of budget, indicating moderate utilization with no immediate concerns. Operations and Maintenance expenses are at 79.8% of budget, trending slightly higher than other categories but still within an expected range for this point in the year. Overall, expenditures remain stable and aligned with anticipated spending patterns.

Revenue Insight:

Revenue collections remain strong overall, with some categories exceeding expectations. Tuition revenue has reached approximately 95.2% of the annual budget, indicating that the majority of anticipated revenue has already been realized. Other local revenue is significantly above budget at 224.1%, driven by higher-than-expected receipts in this category. State and federal revenue stands at 74.5% of budget, reflecting a more typical pacing based on funding schedules. In total, revenue performance continues to support the organization's financial position through April.

RE: Projections Update

The purpose of this memorandum is to provide the Board with an update on enrollment projections for the 2026–27 school year as of April 29, 2026. These projections are preliminary and are expected to change multiple times before August 2026.

Current estimates indicate we will begin the 2026–27 school year with approximately **40** more students than at the start of August 2025. Based on these early projections, we anticipate starting out the year with several classrooms filled or close to capacity.

The data below reflects the following.

- Several classrooms are **at or very close to capacity**, with only 0–3 openings available in many.
- A few areas still have **some space** (New Directions K–1, New Pathways K–5 Kaneland, SAFE), but some of that depends on pending students.
- We're already making **adjustments based on numbers**, including reducing TA support in a few lower-enrolled high school classrooms.
- There will likely be **some student movement** (especially in New Directions) to balance caseloads.
- Several programs have **pending students or active referrals**, which could quickly fill remaining openings.
- **SAIL Intensive Needs is over capacity** and can't take more students without adding staff; SEA/SAIL may start the year a bit high, depending on pending enrollments.
- Unfortunately, we do not currently have the space to open a new classroom at MJS.

RE: Preliminary Staffing Recommendations

This memo provides an update to our preliminary staffing recommendations as we continue transitioning many pending students to active status. The current plan reflects an overall reduction compared to the 2025–26 board-approved staffing levels, including decreases of 3.2 FTE certified/therapist staff and 6.4 FTE classified staff.

These reductions are primarily in Teacher/Case Manager positions, TA/CNA/JC staff, Instructional Coaches, and Hearing services. Adjustments are based on current enrollment projections, program efficiencies, and refinements to service delivery models. Several related service positions (SLP, OT, PT) have been slightly reduced to better align with actual FY26 utilization, while one Administrative Assistant position has been added to support increasing operational demands.

It is important to note that these recommendations remain preliminary and may change as additional referrals are received and pending student placements are finalized. We are currently projecting 301 students, compared with 299 in Spring 2025. Of the 301 projected students, 24 are currently pending, which is higher than typical for this point in the year.

This elevated number of pending students will likely impact staffing needs, particularly with our support staff.

A RESOLUTION AUTHORIZING THE DISPOSAL OF COOPERATIVE-OWNED PROPERTY

WHEREAS, the Executive Advisory Board of Mid-Valley Special Education Cooperative, Kane County, Illinois (the "Board"), is authorized pursuant to the Illinois School Code (105 ILCS 5/10-22.8 and other applicable provisions) to dispose of personal property belonging to the Cooperative that is no longer needed for school purposes; and

WHEREAS, the Board has determined that certain items of personal property owned by the Cooperative are obsolete, surplus, or no longer necessary or useful for school purposes; and

WHEREAS, the administration has compiled a list of such property and recommended that it be disposed of in a manner consistent with applicable law and Board policy;

NOW, THEREFORE, BE IT RESOLVED by the Executive Advisory Board of Mid-Valley Special Education Cooperative, Kane County, Illinois, as follows:

Section 1. Determination of Surplus Property

The Board hereby determines that the items of personal property listed in Exhibit A, attached hereto and incorporated herein by reference, are no longer needed for school purposes and are declared surplus property.

Section 2. Authorization of Disposal

The Superintendent or designee is hereby authorized to dispose of the surplus property listed in Exhibit A in accordance with Illinois law and Board policy, including but not limited to:

- Sale by public auction or competitive bidding;
- Private sale where permitted by law;
- Trade-in for replacement equipment;
- Donation to eligible nonprofit organizations or governmental entities;
- Recycling or disposal if the property has no market value.

Section 3. Compliance with Law and Board Policy 4:80

All actions taken pursuant to this Resolution shall comply with the Illinois School Code (including 105 ILCS 5/10-22.8), applicable administrative regulations, and Board Policy 4:80 (Accounting and Audits), as well as any other Board policies governing the disposal of Cooperative property.

Section 4. Proceeds

Any proceeds from the sale or disposition of such property shall be deposited into the appropriate Cooperative fund as required by law.

Section 5. Repealer

All prior resolutions or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Section 6. Effective Date

This Resolution shall be in full force and effect upon its adoption.
