Dear Mrs. Martinson:

In response to Nome Public Schools' notice regarding the current vacancy on the School Board, I respectfully submit this letter asking that I be considered. I don't take this step lightly, but I want to ensure the School Board has a variety of qualified, committed people to select from.

As you may know, I am a 45 year resident of Nome with a couple of years living in Savoonga with my wife, Vera, and family, and that I retired from Northwest Campus after 28 years working in registration, advising, and eventually as director. This has led me to an educational leadership philosophy that 1) Education is a change agent; 2) All active study must be endorsed and supported, whether academic, vocational, or cultural and identity; 3) Scholarship and expertise in any of these must be recognized and celebrated; and 4) Inquiry and discovery connects all scholars, educators, and learners. I believe these to be consistent with Nome Public Schools Mission Statement and Goals. As I read the 2020 Strategic Plan, I was very glad to see these same beliefs reflected in the document's Aspirations. This plan is really powerful with goals and objectives that will provide solid direction for NPS.

Even with my background, I need to admit that I'm unsure that a retired, white male is a needed perspective for our School Board. Even though I do recognize my privilege and consciously refuse to apply my personal educational journey to our Nome or Bering Strait context, I understand that this could be a consideration. However, I have family and dear friends with children attending our schools, and I will always keep each in mind when listening and discussing NPS policies and issues.

Lastly, I would like to sincerely thank the recent and current School Boards for creating change to a more inclusive, relevant school system. The quality of life in Nome greatly depends on what happens in our schools and if I can help this progress, I'll gladly serve. Thank you for your consideration, and, if invited I look forward to our discussion on July 19.

## BACKGROUND INFORMATION

The District disseminated a Request for Proposal for transportation services for the five year period FY22-FY26 and received one response from Morgan Enterprises. The costs for proposed services are reasonable, and the contract contains a clause providing an opportunity for adjustment based on the reimbursement rate from the State of Alaska as well as the Consumer Price Index. DEED has reviewed and approved the Proposal.

**PUPIL TRANSPORTATION CONTRACT**

BETWEEN NOME PUBLIC SCHOOLS AND MORGAN ENTERPRISES, LLC.

FY 2022 - FY 2026

(July 1, 2021 through June 30, 2026)

This contract is entered into this \_\_\_ day of July, 2021 by and between Nome Public Schools (hereinafter referred to as "District") and Morgan Enterprises, LLC. (hereinafter referred to as "Contractor").

The State of Alaska and the District provide for the transportation of all pupils to attendance centers specified by the District. These services and students are identified and specified in the Pupil Transportation Service Request for Proposal 21-001. The Contractor affirms by signature below that they have read all of the provisions of the Request for Proposal and all explanations sent via email and understand and agree that these documents are part of the contract between the Contractor and the District. The Contractor further agrees to furnish pupil transportation services as specified in these documents for the life of the contract, and to complete Pupil Transportation Program reports as specified in the Request for Proposal and/or as required by the State of Alaska Department to Education.

The term of this contract is for five (5) years, beginning with the 2021-2022 school year, with the first day of school beginning on August 25, 2021 and ending with the closing of the 2025-2026 school year.

The District hereby waives the performance bond requirement.

The Contractor agrees to furnish transportation services at a compensation rate of \$2,998.15 per day for all 3 regular routes during the 2021-2022 school year. The second and remaining years (2022-2023 through 2025-2026) will be adjusted up or down with a cost-of-living allowance (COLA) to coincide with the Average Daily Membership (ADM) reimbursement rate from the State and the annual change in Consumer Price Index (CPI). Additionally, in the second and remaining years, the District will increase the base by 1 percent each year.
