BACKGROUND INFORMATION

On August 10, 2020, the Board of Trustees called for a General Election to be held on Tuesday, November 3, 2020, for the purpose of electing four Trustees to the Board of Trustees from Single Member District 1, Single Member District 4, Single Member District 5 and Single Member District 6 for a term of four years. Additionally, the Board of Trustees called for a General Election to be held on Tuesday, November 3, 2020, for the purpose of electing a Trustee to the Board of Trustees in Single Member District 3 to fill the unexpired two-year portion of its normal four-year term, as required by applicable law.

ADMINISTRATIVE CONSIDERATION

On November 3, 2020, a General Election was held for Single Member Districts 1, 3, 4, 5 and 6. Texas Election Code Section 67.03 requires that the governing body canvass the election results.



ACTION ITEM

BACKGROUND INFORMATION

After the governing body completes the canvasses, the presiding officer shall prepare a Certificate of Election for each candidate who is elected to an office for which the official result is determined by that authority's canvass. [Texas Election Code, Sec. 67.016]

Before an elected officer may assume the duties of the office, the officer must first file a Statement of Elected or Appointed Officer with the official records of the governing body. [Tex. Const. Art. XVI, Sec. 1]

All elected officers shall take the Oath of Office after the Statement has been signed and before they begin their duties. A copy of the Statement of Elected or Appointed Officer and the Oath of Office can be found in Policy BBB (Exhibit).

ADMINISTRATIVE CONSIDERATION

The Oath of Office must be administered by someone authorized to administer an oath under Texas Law. Commonly used officials include notary publics and judges.

ADMINISTRATIVE RECOMMENDATION

It is recommended that the Board of Trustee qualify newly elected trustees for office through the Certificate of Election, Statement of Elected or Appointed Officer and the Oath of Office.
