CERTIFICATE AS TO POSTING OR GIVING OF NOTICE

An emergency or urgent public necessity exists pursuant to Texas Government Code Section 551.045(b)(2) that requires immediate discussion and possible action of the Board due to a reasonably unforeseeable situation as follows:

The COVID-19 pandemic and impact on schools qualifies under "epidemic" emergency meeting provisions of 551.045(b)(2). COVID-19 poses an ongoing imminent threat to public health and safety. Immediate action of the Board is necessary to address conflicting directives the District has received from Bexar County, the City of San Antonio, MetroHealth compared to guidance from the Texas Education Agency and orders from the Governor, as well as conflicting legal orders from various state district courts in Bexar County and Travis County as well as the Texas Supreme Court. On this 18th day of August, no later than 5:30 PM, this notice was posted on a bulletin board located at a place readily

accessible and convenient to the public at the Richard A. Middleton Education Center, 8961 Tesoro Drive, San Antonio, Texas, as well as the North East Independent School District website. Notice of the emergency meeting has also been provided to the local news media in accordance with Section 551.047 of the Texas Government Code.
