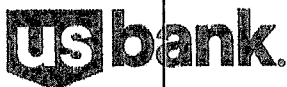

1. Financial Report

We have received all PO's from staff and are looking through them all and will get those approved or denied in the coming weeks. 2. Transportation, Buildings, and Grounds

The completed plan provides a focused framework for continued growth and accountability in serving all learners.

These responsibilities included staff supervision and support, student discipline matters, budget and financial oversight, planning for staffing and scheduling needs for the upcoming school year, communication with families and community members, attendance at school activities and events, and ongoing collaboration with administrators, teachers, and the Board of Education to address district needs and priorities.

As we move into the final weeks of the school year, the district remains focused on finishing the year strong while continuing preparations for summer projects and the 2026–2027 school year.
