
# Meeting Notice

**Public Input to the Board**

It is the policy of the Board of Education to provide for and encourage input from its various constituents in an appropriate and orderly fashion at regularly scheduled Board of Education meetings. The board is open to and encourages input on school issues from the public. The board would prefer that individuals or groups with school related concerns first attempt to resolve those concerns through established administrative channels.

1. Matters concerning an individual school shall be discussed first with the respective building administrator of the school.
2. If the matter is not resolved satisfactorily at the school level, it may then be brought to the Superintendent.
3. If the matter is not resolved satisfactorily at the Superintendent's level, it may then be brought before the board of education by:
  - a. Addressing the matter during Open Forum at a regular, monthly board meeting; individual presentations should be no longer than three (3) minutes and the total allotted Open Forum agenda time will be a maximum of thirty (30) minutes.
  - b. Requesting a formal agenda item by contacting the superintendent or board president on or before the Thursday prior to the regular, monthly meeting which, unless otherwise announced, will be on the first Monday of every month.
  - c. Submitting the matter in writing, said documentation can either be presented at the regular meeting or appended to the agenda, if received in the superintendent's office on the designated Thursday.
4. A response will be provided once the board has the opportunity to inquire about the matter. Possible board responses when appropriate may include, but are not limited to: directing the superintendent to address the matter; tabling for further study; appointing a temporary board committee to study and/or resolve the matter; scheduling a special meeting to hear the matter; or not taking action. Public input to the board is heard during Open Forum. Matters brought to the board in this fashion will be taken under advisement and not acted upon at that time.

**Note: The chair will not allow complaints about individuals. There are appropriate channels to address such matters. Because of the potential of introducing bias into board hearings on termination cases, complaints on individual employees will be received by the board only through the Superintendent of schools.**

**THIS CONSULTING AGREEMENT (the "Agreement") dated March 25 2026 BETWEEN:**

**Bess Scott, Pause, Please!, 8900 Roca Road, Roca, NE 68430**  
(the "Consultant").

**BACKGROUND:**

- A. The Client is of the opinion that the Consultant has the necessary qualifications, experience and abilities to provide consulting services to the Client.
  
- B. The Consultant is agreeable to providing such consulting services to the Client on the terms and conditions set out in this Agreement.

**IN CONSIDERATION OF** the matters described above and of the mutual benefits and obligations set forth in this Agreement, the receipt and sufficiency of which consideration is hereby acknowledged, the Client and the Consultant (individually the "Party" and collectively the "Parties" to this Agreement) agree as follows:

## Services Provided

1. The Client hereby agrees to engage the Consultant to provide the Client with the following consulting services (the "Services"):
  - meet with the superintendent individually as requested to continue to hone feedback and evaluation skills,
  - facilitate professional learning about Collaboration,
  - support the piloting of the Central Office evaluation process with a focus on department and district strategic plans, and

## Term of Agreement.

11. Upon the expiry or termination of this Agreement, the Client will return to the Consultant any property, documentation, records, or Confidential Information which is the property of the Consultant.

**Capacity/Independent Contractor**

12. In providing the Services under this Agreement it is expressly agreed that the Consultant is acting as an independent contractor and not as an employee. The Consultant and the Client acknowledge that this Agreement does not create a partnership or joint venture between them, and is exclusively a contract for service. The Client is not required to pay, or make any contributions to, any social security, local, state or federal tax, unemployment compensation, workers' compensation, insurance premium, profit-sharing, pension or any other employee benefit for the Consultant during the Term. The Consultant is responsible for paying, and complying with reporting requirements for, all local, state and federal taxes related to payments made to the Consultant under this Agreement.

### **Notice**

### **Indemnification**

14. Except to the extent paid in settlement from any applicable insurance policies, and to the extent permitted by applicable law, each Party agrees to indemnify and hold harmless the other Party, and its respective directors, shareholders, affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever, which result from or arise out of any act or omission of the indemnifying party, its respective directors, shareholders, affiliates, officers, agents, employees, and permitted successors and assigns that occurs in connection with this Agreement. This indemnification will survive the termination of this Agreement.

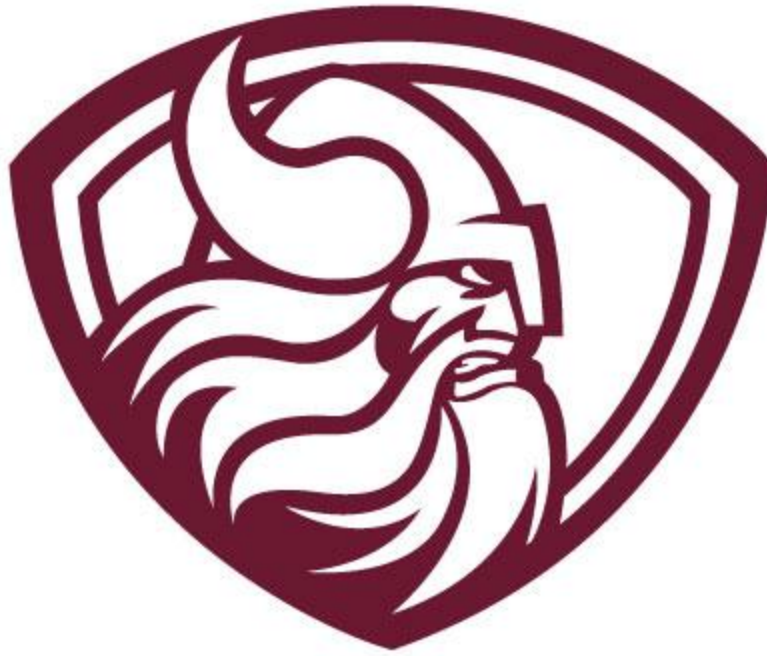

### **Personnel & Programming Proposal:**

- Middle School Track & Field is an existing activity offered by Waverly Middle School. It is recognized as an Eastern Midlands Conference Activity as well as a Nebraska Schools Activities Association Activity. The Waverly Middle School Track & Field Team has experienced tremendous growth and success in recent years.

### **Participation Numbers and Relevant Details:**

- The Track & Field program has seen a steady high number of athletes over the past few seasons.
  - 2021 - 72 Boys, 77 Girls, 149 Combined
  - 2022 - 69 Boys, 69 Girls, 138 Combined
  - 2023 - 84 Boys, 63 Girls, 147 Combined
  - 2024 - 79 Boys, 75 Girls, 154 Combined
  - 2025 - 66 Boys, 74 Girls, 140 Combined

The MS Activity Department recommends the following changes to the District #145 Negotiated Agreement and current operating framework within the Waverly Activities Department for the 2025-2026 Academic Year & Beyond:

- **Add ONE 7-8 Girls/Boys Track Coach Stipend at CAT. IV; 4.75% - 6.25% based on experience.**
  - This would align with the other current 6 track & field coaches we currently have on our negotiated agreement.
- **The financial impact to School District #145 is \$1,929 - \$2,538 for the 2025-2026 Academic Year.**
  - The increase to the school district would be determined based on any previous coaching experience.
  - It should be noted that this figure will increase as the Base Salary Increases.

### **Rationale:**

- Supervision
  - The unique aspect of track & field is that athletes are in multiple locations throughout the stadium and surrounding areas. An additional coach would help fulfill a better ratio of athlete to coach within each event group and provide better overall supervision.
- Practice Facilities
  - The layout of our facilities has throwing events in two different locations and we currently do not have coaches able to be at both spots.

- Meets
  - Half of our meets are triangular in which the boys and girls teams go to separate schools to compete. As it is currently, one group each meet is without their throws coach as they are at the other meet.
  - By having an additional throws coach, we can have one throws coach at both meets providing guidance, feedback, etc.
- Event Groups
  - As it currently stands we have the following coaching spots with an approximate number of athletes that participate in those events per coach:
    - Distance (20-50 athletes, 1 coach)
    - Sprints (100+ athletes, 2 coaches)
    - Hurdles (20-40, 1 coach)
    - Long/Triple Jump (60+ athletes, 1 coach)
    - Shot Put/Discus (30-50+, 1 coach)
  - We would likely utilize an additional coach for shot put and/or discuss, as our practice locations are in different areas. This could also be a coaching position that could be used for jumps, as we have a large number of athletes in those events.

**JUSTIFICATIONS COMPARED TO OTHER EMC & SURROUNDING SCHOOLS:**

I've reached out to teams within the Conference to see what their coaching format for track & field looks like compared to ours. Roster numbers are based off of 2024-25 season:

Bennington South School - 2 Head Coaches, 4 Assistant Coaches (139 Athletes)  
 Elkhorn Middle School - 2 Head Coaches, 5 Assistant Coaches (150 Athletes)  
 Elkhorn Grandview School - 2 Head Coaches, 5 Assistant Coaches (140 Athletes)  
 Elkhorn North Ridge School - 2 Head Coaches, 5 Assistant Coaches (87 Athletes)

 Norris Middle School - 6 Coaches (154 Athletes) - Norris is also considering an additional coach.

### **Overview:**

- Waverly Activities has never had more offerings for students than we currently have. With NSAA sanctioned events alone, the only sanctioned event Waverly doesn't have that most Class A schools do have is swimming and diving. Additionally, I would challenge that within just our NSAA sanctioned activities Waverly has more participation than many Class A schools.
- WHS club offerings continue to be highly participated in. We provide more offerings such as Esports and Educator's Rising, both of which offer college scholarship opportunities as well. With the addition of our new video boards, our STRIV broadcasting class has branched out in the publication and video area and we also have a high level of interest in our newly offered digital design class. Each of these areas the current AD is overlooking in some capacity.

### **Purpose and Relevant Details:**

- Assist with facilitation and supervision of high school activities in collaboration with high school administration.
- Assist and/or lead various functions of the high school activities department.
- Provide leadership opportunities for Waverly staff interested in pursuing administration, specifically in High School Activity Administration.

### **Position Expectations:**

- Depending on the season, plan for 2-3 days/nights per week including select Saturdays.
  - Assistant Activities Director(s) will team with Activities Director to lead/supervise
    - All home Varsity Events including Invitationals
    - Multiple home activities occur on the same day
    - Lower-level home events
    - Supervision for Away Varsity Events may occur
    - Assist with setup of hosted outside events
- There are also other leadership opportunities that candidates can lead and/or assist with including, but not limited to: Branding, Academic Activity Eligibility, guiding & leading Viking Crew student group, assist with WHS weekly newsletter incorporating activity department information, Summer Camp organization, bound scheduling & facility scheduling, Scoreboard assistance, organization of concessions, organization of club activity days.
- Other duties as assigned

### **Qualifications:**

- Must be a current employee of District #145
- Master's Degree in Education Administration/Leadership or pursuing a degree in Education Administration/Leadership.
  - Preferred, but not required.
- Experience and/or interest in high school activity leadership is required.

## Proposed Stipend:

The Viking Activity Department recommends the following changes to the District #145 Negotiated Agreement and current operating framework within the Waverly Activities Department starting in the 2026-2027 Academic Year & Beyond:

- **Add 3 seasonal Assistant Activity Director Stipends at CAT. V; 6.50% - 8.00% based on experience.**
  - The placement of this stipend is close to where comparable schools have these positions listed with a similar structure.
  - The placement of Category V would be in line of our CTE sponsors, SPED unit leader, marching band and play director assistants.
  - Three seasonal positions; one for the Fall, Winter, and Spring. No one person can work more than two seasons
  - Request that any current or previous years of coaching or sponsorship at the high school level for qualified and selected candidates be accepted for specific level placement within said category.
- **The financial impact to School District #145 is \$8,055 - \$9,912 for the 2026-2027 Academic Year.**
  - The increase to the school district would be determined based on any previous coaching experience.
  - It should be noted that this figure will increase as the Base Salary Increases.

## Rationale:

- Using the [Waverly Comparability Activities Analysis](#) you can see of the 17 schools that have reported data in this area, only 5 schools including Waverly do not have any form of supports in place for their activity department.
  - This model mirrors what our competition South of Waverly (Norris) currently practices.
  - Other schools such as Seward, Hastings and Bennington practice a similar model
- Having an assistant each season will help alleviate the amount of supervision the current admin team has and help better balance out evenings.
- An assistant for each season can also help in enhancing some of the areas of the department that get short changed such as facility reservation procedures and protocols, Viking Crew student supports, social media and branding including communication of department happenings, and other duties as assigned.

## Current Program & Leadership Analysis:

- The addition of an assistant activities director each season will allow the Waverly High School Administrative Team to continue representing the school with excellence. These positions will contribute to the continued success, growth, and positive impact of the program within the school and community.
