1. PUBLIC NOTICE FOR THE TAYLOR ISD BOARD OF TRUSTEES SPECIAL MEETING - August 10, 2020 @ 7:00 P.M.

Members of the public may access the meeting by livestream from the Taylor Press Facebook Page.

Due to the mandate that the public observe certain social distancing and social gathering practices to address health and safety concerns related to the COVID-19 coronavirus, this meeting will be only viewable to the public by livestream. The meeting will also be viewable after the meeting concludes on the Taylor Press Facebook Page. This meeting is in accordance with the provisions of Sections 551.125 or 551.127 of the Texas Government Code that have not been suspended by order of the governor.

2. PUBLIC COMMENTS:

Members of the public who desire to address the board regarding an item on this agenda must comply with the following registration procedures: Members of the public seeking to provide comments concerning an agenda item shall be required to register to provide comment by sending an email to the Superintendent of Schools at keith.brown@taylorisd.org no later than 3:00 p.m. the day of the board meeting indicating the (1) person's name; (2) Subject the Member of the Public wishes to discuss, and; (3) telephone number at which the Member of the Public may be reached.

When it is time for the portion of the meeting to listen to registered public comments for agenda items, the District shall attempt to contact the registrant in the order in which the registration was received. If

for any reason the registrant does not answer the phone call, the Board will proceed to call the next registrant. This process shall continue until the list of registrants has been exhausted. The registrant will have 3 minutes to provide public comment concerning the subject identified by the registrant. If a registrant does not speak English they must indicate so when registering and list the name of their translator, and additional time shall be provided in accordance with law. If a registrant requires the use of a TTY system, the registrant must indicate this requirement at the time of registration and the registrant shall be allowed to communicate on a topic for twice the amount of time allowed for persons not requiring the use of the TTY system.

3. CLOSED SESSION: Pursuant to the Texas Open Meetings Act (Texas Gov't Code 551.001) the Board of Trustees will meet in Closed Session to discuss personnel matters (Texas Gov't Code §551.074) with its attorney (Texas Gov't Code §551.071), including but not limited to District Leadership and the upcoming Fall semester. Any action will be taken in Open Session.
4. ADJOURN:

As determined by the Board of Trustees, there may be a closed session pursuant to the Texas Open Meetings Act (Texas Gov't Code 551.001) to discuss items relating to personnel (Texas Gov't Code, Section 551.074), student discipline (Texas Gov't Code, Section 551.082(1)), attorney consultation (Texas Gov't Code, Section 551.071) and/or the purchase, exchange, lease or value of real property (Texas Gov't Code, Section 551.072) Medical or Psychiatric Records (Texas Gov't Code 551.0785), Security (Texas Gov't Code, Section 551.076), Assessment Instruments (Education Code 39.030(a)), Economic Development Negotiations (Texas Gov't Code, Section 551.087), Prospective Gift (Texas Gov't Code, Section 551.073), Personally Identifiable Student Information (Texas Gov't Code 551.0821), Representative of Employee group (Texas Gov't Code 551.083). Any action will be taken in public session.
