Board of Education Meeting
April 5, 2011
Meeting Minutes

1. The public session of the Board of Education was called to order by Chairperson Coffey at 7:30 p.m. Ms. Coffey led the Pledge of Allegiance.

2 School / Community Session

2.1 Recognitions:

2.1.1 National Library Week, April 10-16, 2011

Mr. Klein announced that National Library week is April 10-16th and expressed his gratitude to the staff of the Madison Public Schools' Library Media Centers as well as the Scranton Memorial Library. Mr. Klein commented that these individuals are invaluable to our school community and the District is fortunate to have such wonderful people in these roles.

2.1.2 Public School Volunteer Week, April 17-23, 2011

Mr. Klein next announced Public School Volunteer Week from April 17th to the 23rd. He commented that the Board members all know how much our school volunteers do throughout the year, and that we could not do this important work without them.

2.1.3 Administrative Professionals Week, April 24-30, 2011

Mr. Klein also stated that Administrative Professionals Week is coming up later this month. He commented that these individuals at the school buildings as well as Central Office are crucial to the fine work we do and our students are the direct beneficiaries.

2.1.4 Daniel Hand High School Art Student Awards

Mr. Klein stated that he was pleased to recognize students from Daniel Hand High School for awards they recently won in the Connecticut Scholastic Art Awards Program and the Future Choices Exhibit. He read the following information about each program which was furnished by DHHS Art Teacher and Program Coordinator Angela Medley:

Connecticut Scholastic Art Awards Program

Recently the **22nd Annual Connecticut Scholastic Art Awards** program, sponsored by the Connecticut Art Education Association, recognized the work of talented young artists in grades 7 to 12 from public, private and parochial schools throughout Connecticut.

Student artwork was juried by professional artists and university art faculty and some pieces were included in a three-week art exhibit held at the University of Hartford Art School.

The exhibit included 663 artworks out of almost 2,000 student entries from 135 schools. Artworks were recognized with Gold Key, Silver Key and Honorable Mention awards, as well as special awards that included "Best in Show" cash prizes, art product awards and university scholarships.

The Connecticut Scholastic Art Awards is an affiliate of the National Scholastic Art Awards and The Alliance For Young Artists and Writers. The work of Gold Key winners from each national region -- including Connecticut -- was reviewed by a national panel of judges in March and selected pieces will be included in an exhibit in [New York City](#) during June. The national awards ceremony will be held at [Carnegie Hall](#) in mid-June.

Future Choices Exhibit sponsored by the Shoreline Arts Alliance

Future Choices, now in its 27th year is an annual juried student art show presented by the Shoreline Arts Alliance. This competition and exhibition is open to all high school students who live or go to school in any of the 18-town region* that Shoreline Arts Alliance serves.

Mrs. Medley and DHHS Art Teacher Suzanne Gaskell assisted in presenting Certificates of Recognition to the students present: Megan Brink, Anne Pancak, Tiffany Li and Wilson Stevens. Mrs. Medley stated that the students who were unable to attend were likely involved in the upcoming musical at Daniel Hand or with sports, and they would receive their certificates.

- The Madison Public Schools K-12 Art Show opens at the Scranton Memorial Library the following day (Wednesday, April 6th) and the work of some DHHS Seniors will be on display at an Art Show in New Haven beginning on May 12th.
- The Annual Greater New Haven Area High School Art Exhibition at the John Slade Ely House Center for Contemporary Art, 51 Trumbull Street in New Haven, April 21-May 1, 2011
- The Daniel Hand High School Annual Arts Exhibit. Opens with a reception on May 12th from 7:00 to 8:30; the show is available for public viewing after school hours from May 12th-26th.

3. Board of Education Student Representatives' Report
(Andrew Chapman and Jessica Buller)

Mr. Chapman reported on the following:

- The Spring Musical, Fiddler on the Roof, will be performed this Thursday, Friday and Saturday, April 7th – 9th.
- There has been a 'no texting while driving campaign' all week, with information being released each day. On Wednesday and Thursday, students will be able to add their fingerprints to a banner and take a pledge not to text while driving.
- The Connecticut Drama Association Festival took place at the end of March. The students did well, performing in a play called "Thank You for Flushing My Head in the Toilet". It is about three students being bullied and how it affected them. It will be shown to freshman and sophomores on Friday, April 15th.

Ms. Buller reported on these additional items:

- CAPT testing is completed and trimester 3 is underway.
- A student group called LIFE (Living Intoxication Free Everyday), which works to promote making good choices, has been active all year, creating a billboard which was next to Zhang's Restaurant in Madison, and bringing in the performance of "DIRT". Next on their agenda is a pasta dinner on May 22nd to raise funds for youth leadership training.

4. Superintendent's Report

4.1. Enrollment Update

Mr. Klein reported that enrollment currently stands at 3,611; 28 students more than the ADS projection of 3,583.

For the 2011-2012 school year, current enrollment is 3,431; only 20 under the ADS projected 3,451. While the variance in actual vs. projected enrollment usually lies in kindergarten, ADS has projected 123 kindergarteners for next year, and actual enrollment is currently at 118. Mr. Klein commented that there is typically a much bigger differential at this time of year, but could not say why the numbers are so much closer this year. He explained that there are eight sections planned for kindergarten next year which would put class sizes at approximately 15 students per class. Even if we do enroll more students than ADS has projected, we have the ability to absorb them while maintaining very manageable class sizes.

Mr. Klein reported on some upcoming out of state field trips for Daniel Hand High School students.

Ms. Meier stated that two Madison students who also attend ECA (Education Center for the Arts) in New Haven are performing in a concert the following evening in New Haven. She commented that it is another example of what arts oriented students are doing.

12. Future Agenda Items

Mr. Klein noted the following upcoming presentations.

12.1. NAVIANCE Presentation for Grades 5 & 6: Scheduled for May 3, 2011

Mr. Klein also stated that he is working to bring our State Legislators to a Special Meeting of the Board later this month. He explained that Public Act 10-111 may be delayed two, possibly four years. Issues that may be affected include high school reform, student success plans and kindergarten reform. Mr. Klein stated that this delay will not affect Madison moving forward with student success plans, as the initiative is already underway and we will continue to do the work we see as appropriate. Mr. Klein stated that it is important to have these direct conversations with our representatives in Hartford, to find out what bills are gaining strength and as well as to let them know what we see as important. He stated that the Board members will be contacted shortly with some possible dates, and the Board of Selectmen and Board of Finance will also be invited to this meeting once a date is confirmed.

13. Meetings of Importance

Ms. Coffey noted the list of meetings on the agenda, and again pointed out the Budget Public Hearing scheduled for April 25th. She encouraged all Board members to attend to support what is the lowest requested budget in more than a decade. Ms. Coffey pointed out that the Board of Education's requested budget for 2011-2012 is \$57,000 less than the current year's budget. She credited the Superintendent, Administration, and the Board's Negotiations Team for bringing forth a budget which will allow us to continue with the quality program currently in place. Atty. Klaskin

commented that the low budget is also a credit to the Madison Educators Association (MEA), who negotiated their new contract in good faith recognition of the financial burdens facing the town.
