1. ESTABLISH QUORUM AND CALL TO ORDER AND 2. PLEDGE OF ALLEGIANCE

S. Thompson, Chair, after determining that a quorum was present, called the meeting to order at 7:00 p.m. and led attendees in the Pledge of Allegiance.

3. CONSENT AGENDA

The Chair requested action on the minutes from the February meetings.

A motion was made by D. Dale and seconded by R. Ike that the Bloomfield Board of Education approve the minutes of the:

- Thursday, February 18, 2010 Regular Meeting
- Thursday, February 18, 2010 Executive Session
- Thursday, February 25, 2010 Special Meeting

The motion passed unanimously.

4. PRESENTATIONS

The Chair requested this matter be deferred to a later time. There was no discussion.

5. PUBLIC/PTO COMMENT

Mr. A. Taylor addressed the Board with his concern that negative and non-supportive forces are speaking against the school system. He urged all Bloomfield citizens to support Bloomfield schools, staff, and students so as to not fail them.

6. SUPERINTENDENT'S REPORT

A. CONNCAN VIDEOS-LAUREL AND J.P. VINCENT ELEMENTARY SCHOOLS

Dr. Title reported that ConnCAN (Connecticut Coalition for Achievement Now) is a state-level education advocacy group whose major projects include the ranking of Connecticut public schools and providing video profiles of successful schools. This group recently announced that it awarded state-wide rankings of #2 for Laurel and #3 for J.P. Vincent Elementary Schools.

Ms. K. Parks provided the audience with the group's video interviews of staff at these two schools. The videos were well received by those attending the meeting.

B. FINANCIAL REPORT

The Superintendent commented on the February month-end Budget Projection.

Subsequent information from the State indicates that due to budgetary constraints, Special Education payments will be less than previously determined. This will reduce the \$542.3K favorable Budget Variance shown on the month-end projection.

Favorable variances come from Certified Salaries, Transportation, and Building Maintenance and Operations. Dr. Title said the district will finish the year in the black but at some amount less favorable than currently projected.

C. "REACH FOR THE STARS" PROGRAM

Dr. Title reported this program is being made available through the Town's Youth Services Department. It is coming to the Carmen Arace School on 5/25/10 and will feature several well known former UConn women basketball stars now playing professionally.

D. CONNECTICUT CENTER FOR SCHOOL CHANGE NEWS

The Superintendent commented on the district's partnership with this group. The Connecticut Center for School Change consults with school districts to improve student outcomes.

The Center supports comprehensive reform through a combination of grants, technical assistance, leadership development programs, conferences/seminars, research and application of best practices.

The district is the recipient of a \$100K grant over four years from this group. The district's work with the Center is going well.

7. OLD BUSINESS

The First Reading of these proposed policies occurred at the 2/18/10 meeting of the Board of Education.

SECOND READING OF PROPOSED POLICIES

A. POLICY 5300 – STUDENT DRESS

A motion was made by D. Seldon and seconded by D. Dale that the Bloomfield Board of Education approve Policy 5300 – Student Dress. The motion passed unanimously.

B. POLICY 9015 – STUDENT REPRESENTATIVE

A motion was made by D. Seldon and seconded by D. Dale that the Bloomfield Board of Education approve Policy 9015 – Student Representative to the Board. The motion passed unanimously.

C. POLICY 9150 – MEETING CONDUCT

A motion was made by D. Seldon and seconded by D. Dale that the Bloomfield Board of Education approve Policy 9150 – Meeting Conduct. The motion passed unanimously.

D. POLICY 9160 – MINUTES

A motion was made by D. Seldon and seconded by D. Dale that the Bloomfield Board of Education approve Policy 9160 – Minutes. The motion passed unanimously.

8. NEW BUSINESS

Dr. Title reported there will be a new Health requirement for graduation. Currently, 23.4 credits are the minimum requirement for graduation. This includes a combined Physical Education/Health requirement of 1.5 credits and an Electives requirement of 7.5 credits.

For the Class of 2014, the minimum required number of credits for graduation remains unchanged at 23.4 credits. The Physical Education component remains unchanged at 1.5 credits.

However, a Health requirement of .5 credits will be added and the amount of Electives credits will be reduced to 7.0 (from 7.5).

FIRST READING OF PROPOSED POLICY

A. POLICY 6310 – REQUIREMENTS FOR GRADUATION

A motion was made by D. Seldon and seconded by D. Dale that the Bloomfield Board of Education approve the First Reading of Policy 6310 – Requirements for Graduation. The motion passed unanimously.

B. NON-RENEWAL OF NON-TENURED CERTIFIED EMPLOYEE CONTRACTS

This is a procedural matter requiring Board approval.

A motion was made by D. Seldon and seconded by D. Dale that the Bloomfield Board of Education Non-Renew the employment contracts of the Non-Tenured Teachers as listed on the enclosed memorandum from the Superintendent of Schools. The motion passed unanimously.

9. ADJOURNMENT

The Chair requested a motion to adjourn.

At 7:25 p.m., a motion was made by D. Quinones and seconded by D. Dale to adjourn. The motion passed unanimously.
