IV. CONSENT AGENDA

C. Approval of Minutes: Regular Meeting - November 15, 2011

Student Representative Report

Maria Nieves, student representative, Big Picture High School, stated, at first, the students were reticent about the school's redesign, but are gaining enthusiasm. The most prominent student concern is including lower grades. Sweatshirts are being designed by the uniform committee to increase the student's school spirit. A couple of the activities at the school are an upcoming all night event and preparation for CAPT Testing. A CAPT Pep Rally will be held. In January and February, voluntary CAPT Preparation Sessions will be held after school and on Saturday mornings.

VII. SUPERINTENDENT'S REPORT

A. Stakeholders' Meeting - January 4, 2012

J. Thompson stated this leads into the next five years. An evening meeting of stakeholders' is planned for the 4th of January 2012. The agenda is attached.

B. 2011 - 2012 REVISED Academic Calendar

The revised calendar was distributed. The seven days already missed due to weather will be made up by having school on 11/11/2011 and 5/25/2012. School will be in session on 2/17/2012 and 2/20/2012. Three days will be added to the end of the school year in June changing the last day of school to 6/20/2012. Any additional snow days will result in school being in session on 6/21/2011, 6/22/2012 and then April vacation will be affected. School will not go beyond 6/22/2011.

C. Update on District Website

C. Leone presented a prototype of the website that will be available in early January. The website will be easier to use and contain pertinent district information. A style guide was distributed to the Board Members.

D. Financial Reports

Per C. Leone, the financials are healthy through November. Major line items are being monitored. Transfers will begin with this reporting month. The board members requested a description of the line items.

E. Budget Impact from Storm Alfred

Facilities costs were \$16,604.23 and Food Service costs were \$20,185.33. These dollars have been submitted to the town for possible reimbursement from FEMA.

F. CREC Tuition Payment

Based on the enrollment of Bloomfield students at CREC Schools, as of October 1, 2011, there is a deficit of \$45,996.00 in the 2011/2012 budget. This will be covered by a budget transfer.

VIII. OLD BUSINESS

No Old Business was brought up for discussion.

IX. NEW BUSINESS

A. First Reading of Proposed Policy - 5221 Safe School Climate Plan

B. Silvers reviewed the highlights of the first draft of the policy. The Policy Committee will review it prior to the January 2012 Board Meeting. The policy needs to be established by January 2012.

B. Acceptance of Donation of Vehicle to Bloomfield Public Schools

A motion was made by R. Ike and seconded by D. Seldon to have the Bloomfield Board of Education accept the donation of a vehicle to the Bloomfield Public Schools. The motion was passed unanimously.

C. Budget Transfers

A motion was made by S. True and seconded by D. Seldon to have the Bloomfield Board of Education approve the budget transfers, as presented. The motion was passed unanimously.

D. Approval of July 1, 2012 to June 30, 2015 Collective Bargaining Agreement Between the Bloomfield Board of Education and the Bloomfield Administrators' Association

A motion was made by D. Seldon and seconded by M. R. Walters to approve the July 1, 2012 to June 30, 2015 collective bargaining agreement between the Bloomfield Board of Education and the Bloomfield Administrators'

Association, *as presented*. The motion was passed unanimously.
