M. R. Walters, Chair, called the meeting to order at 6:40. The roll was called and a quorum was present.

**3. NEW BUSINESS**

**3. A. Presentation of Design for the Bloomfield Learning Academy**

E. Stoltz distributed and reviewed a booklet about the Learning Academy of Bloomfield. The objectives were highlighted and how the learning academy aligns to the District Accountability Plan. The current enrollment and the enrollment capacity were discussed. All were invited to visit the learning center and see the environment that has been created. The Carnegie Foundation recently visited the academy. In the future, it may be a possible regional model. This is not an expulsion program, although expelled students meeting the criteria may be considered. Any student in the 11<sup>th</sup> grade, by credit, will sit for the CAPT Test.

**3. B. Presentation of CMT and CAPT Targets**

E. Stoltz began the CAPT and CMT testing presentation by stating the new targets have been established based on last year's results and closing the gap.

B. Silver continued by presenting the new goals and the inclusion of stretch goals. The goals are aggressive, but realistic.

The discussion turned to retaining students in the district. Increased test results are very important. Other key factors included principal involvement and one on one enrollment marketing.
