RESOLUTION 11 (SERIES 2025)

A RESOLUTION OF THE CITY OF OURAY, COLORADO, BANNING ALL PERSONAL FIREWORKS WITHIN THE CITY OF OURAY UNTIL RESCINDED BY CITY COUNCIL.

WHEREAS on June 15, 2025, the City of Ouray experienced fire events resulting from illegal personal fireworks and the fires were extinguished by the City's volunteer fire department and neighbors.

WHEREAS, given the recent fire event, the drought conditions, low winter snowpack, and ongoing critical fire weather conditions, City Council hereby declares a complete ban on the sale and use of any personal fireworks within the City of Ouray until further notice.

WHEREAS, the professional fireworks scheduled for July 4, 2025, at dusk will remain scheduled as planned, unless Stage 2 Fire Restrictions are implemented between now and July 4th.

WHEREAS the City Council determines that Resolution 11 is necessary to the immediate preservation of public peace, health, and safety.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OURAY, COLORADO, as follows:

1. It shall be unlawful to sell or use fireworks within City Limits until the City Council revises or rescinds this resolution.
2. This resolution supplants Ouray Municipal Code (OMC) Section 10-2-N-3. All other provisions of OMC 10-2-N remain in effect.

ADOPTED this 18th day of June 2025 by the Ouray City Council.
