- B. Encumbrance to Bison Electric in the amount of \$33,233.00 for providing and installing LED light bollards at the Aviation Campus. The existing illuminated bollards at the Aviation Career Campus have experienced repeated electrical failures and are no longer serviceable. [Operations]
- C. Encumbrance Agreement with Durante Construction, Inc. as general contractors for the Metro Technology Centers, STEM exterior Main Entry Project in the amount of \$46,717.60 (Pricing, terms and conditions per quote). Bond funds will be utilized for this project. [Operations]
