### FULL-TIME STUDENTS' TUITION REFUND POLICY

## Career Major Description

According to the most recent ADE Automotive Service Technician standards, students in this major will cover the skills necessary to become an entry-level technician. Students will concentrate on courses in introduction, brakes, steering & suspension, electrical/electronics, engine performance, heating & air conditioning, engine repair, automatic transmission, and manual drive train and axles. They will learn how to diagnose and complete brake service, perform vehicle steering and suspension alignment, as well as electrical theory, electrical/ electronic diagnostics. Students will cover engine performance diagnostics and techniques for repair using a variety of diagnostic equipment.
