Summary

The John Hersey School renovation project commenced in December 2024. Following the bidding process, the painting and wallcovering contract was awarded to D.E.S. Painting, the lowest bidder, and approved by the School Board on November 14, 2024.

Administrative Considerations

D.E.S. Painting has not responded to the Notice to Proceed issued by Pepper Construction. As a result, administration requests that the Board of Education rescind the previous award to D.E.S. Painting and instead award the contract to the second lowest bidder, Midwest Decorating, Inc., at a cost of \$72,200.

Recommended Action

In compliance with the terms of the public bid for 2025 Interior Improvements Project at John Hersey High School that were received on October 15, 2024, it is recommended that the Board of Education rescind the award to D.E.S. Painting due to their unresponsive nature and award the contract to the second lowest bidder, Midwest Decorating Inc., at a cost of \$72,200.

Re: 2025-2026 Preliminary Budget Guidelines and Assumptions

BACKGROUND INFORMATION

Budgets are estimates of projected revenues and projected expenditures for a specified period of time. For school districts this is a one-year period (fiscal year), which runs from July 1 through June 30.

In December 2024, the Board of Education approved its 2024 property tax levy. The Fiscal Year 2025 budget will be developed to ensure a balanced operating budget. The district will continue cost containment initiatives as the 2025-26 budget is prepared. These projections are preliminary and may be adjusted as data becomes available.

With recent market inflation and fluctuation, the District 214 budget may face necessary adjustments and/or reductions during preparation. As financial data is updated, we will adjust the District 214 budget accordingly.

ADMINISTRATIVE CONSIDERATIONS

The Board of Education authorizes the development of the district's budget for the 2025-26 fiscal year. These estimates are subject to change as more accurate data is collected, but serve as a well-informed starting point for the development of the budget.

Listed below are the guidelines, assumptions, and parameters that will be used in developing the 2025-26 budget:

REVENUE

- The Equalized Assessed Valuation (EAV) for 2023 \$11.4 billion. The Equalized Assessed Valuation (EAV) for 2022 was \$11.2 billion. The EAV for 2021 was \$9.4 billion. Next year's overall tax receipts are based on the Consumer Price Index (CPI), the estimated new growth to the tax base, the impact of tax caps, and refunds.
- The Consumer Price Index (CPI) reported as of December 31, 2024 is 2.9%.
- During 2025-26, we anticipate a leveling off of our interest earning increases on the backside of the pandemic, however we will continue to monitor market volatility.
- Property taxes continue to be the district's largest source of revenue for 2025-26.
- Corporate Personal Property Replacement Taxes (CPPRT) is currently estimated to remain flat into the coming fiscal year. Updates from the Department of Revenue prior to the final budget adoption will inform adjustments.
- Instability of Federal Funding in relation to the new administration in DC may result in an impact on future resources.
- The administration will continue to explore and review new revenue options as they become available.

ENROLLMENT

- The two-year cohort survival enrollment projections will be used in calculations for enrollment-related budget allocations. The enrollment report projects a slight enrollment decrease for 2025-26.

STAFFING

- The administration follows a formal staffing process each year. The staffing calendar identifies the dates that staffing decisions are scheduled. As further information becomes available, we will incorporate the impact into the Tentative Budget which will be presented for Board approval at the June 12th Board of Education meeting. Factors such as student enrollment, program needs, funding, staff retirement and strategic alignment will impact this portion of the budget.

Education Association (EA) Staffing

- For the purposes of the development of the preliminary 2025-26 budget, staffing will be determined based on estimated student enrollment, program needs, and funding sources.
- Annual compensation increases as per the current collective bargaining agreement.

Custodial Maintenance Association (CMA) Staffing

- Review and plan for reallocation, attrition, and efficiency of operations based on program needs and funding sources.
- Annual compensation increases as per the current collective bargaining agreement.

Educational Support Personnel (ESP) Staffing

- Review and plan for reallocation, attrition, and efficiency of operations based on program needs and funding sources.
- Annual compensation increases as per the current collective bargaining agreement.

Administrators/Supervisors

- Review and plan for reallocation, attrition, and efficiency of operations based on program needs and funding sources.
- Annual compensation increases as per the current agreements

Food Service Employees

- Staffing will remain stable with current levels.
- Annual compensation generally increases by CPI.

BENEFITS / INSURANCE

- Health insurance costs are projected at a 15% increase. However, insurance rules and regulations may be enacted which may cause potential changes to occur.
- Board Legal, Property and Casualty, Workers Compensation and Cyber Liability Insurance is projected to increase by approximately 15% in 2025.

BUDGET ADJUSTMENTS

- We will continue to review and contain costs working with market trends and availability. We will continue to monitor conditions for items such as utilities, gas, and postage.
- Efficiency analysis and cost containment initiatives will be considered as the 2025-26 budget is prepared.

TUITION INCENTIVE PROGRAM (TIP)

- In 2025-26, per the Education Association contract, professional development will be funded based on the current agreement.

SPECIAL EDUCATION

- 2025-26 NSSEO tuition costs and programs are being reviewed by NSSEO. Final NSSEO program costs will reflect funding for new budget facility improvements as well as service delivery costs.

CAPITAL PROJECTS PROGRAM (CPP)

- Approved capital projects will be included in the budget for summer 2026 construction. The administration continues work on a new long-range plan to address the significant capital needs identified in the 2023 assessment.

TECHNOLOGY

- Technology Services maintains a comprehensive hardware lifecycle replacement program to ensure all users have the resources necessary for success. These annual costs will be included in the 2025-26 budget.

TRANSPORTATION

- Operational reviews, resulting in savings, are incorporated into the budget. When combined with the contractual cost increases, transportation costs are expected to rise by 5%. The District will continue to evaluate cost containment going forward including white bus scheduling.

TRANSFERS, LOANS, AND ACCOUNTING RECOMMENDATIONS

- Transfer from Operations and Maintenance to Capital Project Fund for funding of future Capital Projects will align with upcoming capital project costs as approved by the Board of Education.
- We do not anticipate another Cook County property tax delay in 2025.
- Transfer of working cash interest income to other funds may be recommended to address cash flow needs.

RECOMMENDED ACTION:

That the Board of Education discuss the proposed guidelines and assumptions relative to the preparation of the 2025-26 fiscal year budget.

Re: Food Service RFP Update - Discussion Item

BACKGROUND INFORMATION

As we approach the retirement of our Food Service Director, we recognize that we have an opportunity to evaluate the best solution for delivery of meals to our students. Factors that weigh on our internal discussion are varied, but the foundation of all decisions must focus on what is best for our students. As such, we published an RFP seeking management consultant solutions and options.

Our intention is to compare this model to a traditional direct hire for this position, review the results of such an analysis with the Board and make a recommendation thereafter. It should be noted that this would only impact the director position and all other food service positions will remain as direct district employees.

ADMINISTRATIVE CONSIDERATIONS

Three vendors submitted proposals: Organic Life, Quest and Whitson's. Each vendor provided a comprehensive strategy to support the student meal program into the future. In addition to reviewing the proposals, we have convened a working group to make site visits at the finalists' current high school clients. This will offer the team the opportunity to see, smell and taste what the firms are doing in peer lunch programs.

RECOMMENDED ACTION:

This item is for discussion purposes only at this time. The administration will bring a recommendation forward to the March 13, 2025 Board of Education Meeting.

Background

To better reflect the evolving needs of the District, we are proposing revisions to a number of job descriptions. The position of Associate Superintendent of Human Resources has been revised to Deputy Superintendent. The Deputy's responsibilities include leadership and strategic oversight, supervision and evaluation of principals, personnel management, collective bargaining, and serving as the key advisor to the Superintendent. We are also proposing to change the Director of Human Resources & Equitable Practices job description to the Executive Director of Human Resources & Equitable Practices. This role will plan, develop, coordinate, and evaluate the operations of the Human Resources Office and establish goals in alignment with the district's strategic plan.

The Director of Technology job description has been revised to ensure the role aligns with the district's evolving technological needs, enhancing both instructional and operational efficiency. The director will facilitate the seamless integration of technology in education and operations while maintaining compliance with internet safety protocols especially for students.

To better support the student populations at specialized schools, the district will have two Directors of Specialized Schools and two Assistant Directors of Specialized Schools. Revisions were made to these roles to reflect the modern educational landscape and the increasing complexity of their responsibilities. The updated job descriptions ensure these positions are structured to effectively support specialized schools and meet the evolving needs of students.

Administrative Consideration

These job descriptions have been reviewed by the administration and are aligned to ensure effective contributions to the district's growth and success.

Recommendation

We respectfully recommend that the Board of Education review and approve the proposed job descriptions for Deputy Superintendent, Executive Director of Human Resources & Equitable Practices, Director of Technology, Directors of Specialized Schools, and Assistant Directors of Specialized Schools.
