## Overview of Curriculum Updates

- **i-Ready in the News:** Curriculum Associates, the company behind i-Ready, has been in the news cycle recently around two topics: 1) a data privacy lawsuit filed by parents, and 2) claims regarding the lack of efficacy of Personalized Instruction. This is an effort to ensure the Board is aware of these topics and to discuss details and the District's present position.
- **K-12 Math Pilot:** The Novi Teaching and Learning team will provide an overview of the pilot process for 26-27.
- **HS Course Enrollment Information:** One question that regularly comes up from Board members relates to the high school course catalog, new approved courses, and whether courses are being run, not run, or cut. The Novi Teaching and Learning team will provide some data about course status.
