| 551.087 | Discussing commercial or financial information received from a business prospect the district seeks to have locate, stay, or expand in or near the district and with which the district is conducting economic development negotiations or to consider an offer of a financial or other incentive to such a business prospect. |



- (a) In the open meeting covered by the Notice after the School Board reconvenes in open meeting; or
- (b) At a subsequent open meeting of the School Board upon proper Notice thereof, as the School Board shall determine.

The meeting will be held in compliance with Texas Government Code Section 551.001 et seq. The meeting is also being conducted in accordance with the Americans With Disabilities Act [42 U.S.C. 12101 (1991)]. The facility where the meeting is to be held is wheelchair accessible, and handicapped parking is available.
