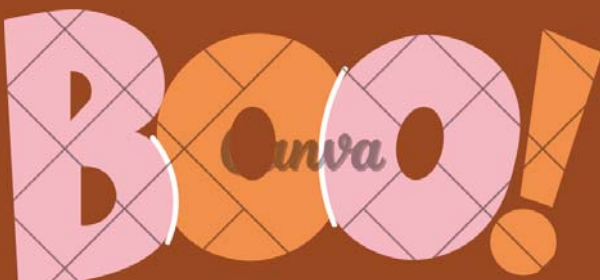

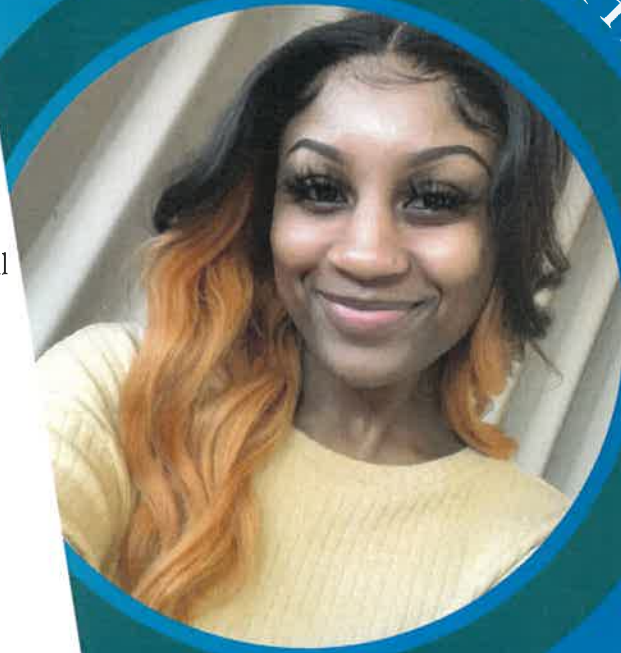

## **PAEC PROGRAM UPDATES FROM SEPTEMBER 2024**

### **PAEC Academy at Divine Infant**

Teachers were busy benchmarking students for the fall window. All but the Kindergarten class were able to complete testing. We are working very hard to get the behaviors in the Kindergarten class under control. We have made several changes to meet the needs of the individual students. Slowly we are seeing improvements and are introducing more academics daily. At this point getting these students to sit for a testing situation was simply not an option.

Open House took place on September 12, 2024. Each class had about half of their parents attend. We also made sure parents were aware of Special Olympics sign-ups and requirements. Many parents also inquired about purchasing PAEC Academy Spirit Wear which we will be ordering on September 30<sup>th</sup>.

We commemorated 9/11 by wearing red, white, and blue and having a moment of silence for all of the people who lost their lives that day. We celebrated Hispanic Heritage Month as well. Students learned about famous Hispanic people in our society.

On September 24<sup>th</sup> we had the Smiles Dentist come to PAEC Academy. Twenty-six students were seen by the dentist. On October 29, 2024 we will be seeing a play on cavities and brushing your teeth the right way. We have a lot to celebrate in October, we are currently making plans.

### **PAEC Early Childhood**

September was a wonderful month in the Early Childhood program. We have had great weather and have been able to take advantage of our updated playground almost every day. We finally hired a 1:1 Program Assistant for one student who needed that support. We are very happy to welcome Brittney Overstreet to the program. The students and staff have settled into a good routine as we only had 1 new student start this month. We had one student move from the half-day program to the full-day classroom and will have a new student start next week. The students have also come to enjoy our music therapy very much and actively participate in choosing instruments and songs. We are very grateful to Mr. Craig.

- The theme for the first two weeks of September was learning to identify and label body parts and learn "All About Me"
- Then the study of Hispanic Heritage Month commenced on September 15 and will continue into October 15<sup>th</sup>.

This month the students learned the following academic concepts: The first through the third week of September they focused on: COLORS: Yellow, Red, Blue SHAPES: Circle, Square, Triangle LETTERS: B, A, & M NUMBERS: 1, 2, 3. The fourth week all the concepts were reviewed.

### **PAEC Therapeutic Day Elementary School**

- Students continue to do well with settling into the year. The PAEC Elementary Flag Football team has won two of their three football games this year! Mentoring with the PLCCA will begin in the coming weeks offering opportunities for students to connect with community members and develop positive relationships.
- The students have really taken to music therapy and are engaging during music therapy each week. They continue to look forward to it each week. Our first round with the Therapy Dogs is October 17<sup>th</sup>, and the next is November 15<sup>th</sup>.

### **PAEC Therapeutic Day High School**

#### **Academics**

We had eight families come out for our Open House on September 11 to see the program and meet the teachers. NWEA MAP Assessment is in full swing and we are finishing with our makeup sessions. Progress reports were emailed to parents on 9/27/24 and our first quarter will end on October 18, 2024.

## Happenings

We will have our Hispanic Heritage Presentations on October 18, 2024. The students are excited to talk about their famous author and the country that the author is from. On October 29, 2024, we will have our end-of-the-quarter incentive by attending the Chicago Wolves Game. Students who have earned honor roll, perfect attendance, are on level three for twelve weeks, or increased their MAP Score by ten or more points from Spring will be eligible for the trip.

## PAEC Therapeutic Day High School Vocational Program

The Vocational Team has students starting at the Hilton Garden Inn and the Hilton Chicago Oak Brook Suites next week. It has been a couple of years since we were able to place students at the Hilton Chicago Oak Brook Suites. They are excited to restart this placement as it offers culinary and mechanical development opportunities. In the next two weeks, we will start our work training program at Firehouse Subs. Formal student interviews for PAEC's custodial work program will begin next week. The RR Trade School partnership was approved and the next step in the process will be to coordinate a twice-weekly, one-hour training session in Basic Tool Fixes and Life Skills. We will first target senior students who have an interest in the trades. Students who are assisting with the breakfast and lunch program earn credit toward their community service hours. Additionally, the financial literacy program has started this week and will continue weekly throughout the first semester.

Students are being met to complete the Transition Planning Questionnaire and interview which guides the development of agreed-upon transition goals. For those students who are behind on credits, APEX is offered as an option to make up courses so students can work toward graduation. The students enrolled in APEX are met regularly to ensure progress is being made. Graduation planning sheets are being made to keep motivation high for those students who are close to graduation. We have several students actively seeking outside employment and obtaining guidance from the Vocational Staff. We also have several students currently employed in after-school and weekend jobs.

The American Job Center (AJC) in Maywood offers federally funded training opportunities for students who have completed or left high school, ages 18-24 years old. They offer 3-9 month long training programs in professional resume building, job placement, and training in paperwork/secretarial, hospitality, healthcare, IT, and construction/transportation. Students who have an interest in these areas will be referred to the AJC once they are getting close to graduation. The AJC will also be at the Spring Career Fair hosted at PAEC HS.

## PAEC Center School

- The month of September has routines being established, students following the routines, and learning taking place. We have welcomed a few new students and they, too, are getting acclimated

to the classroom. We had a welcome back-to-school parade for both the high school and the elementary school students.

- Our Fire Drill was successful with the students and staff moving to the high school gym in an orderly fashion.
- Spirit Week was a big success. Students and staff dressed up in different themes for the week!
- We had our Hispanic Heritage Fair on September 25th. Each classroom put together a display highlighting a country and their traditions. Also, two pinatas were broken, one in the morning for the elementary students and one in the afternoon for the high school students.
- We had a Walking Taco Fundraiser. Staff were able to choose between beef or shredded chicken and loads of toppings! This is always a big hit!
- IEP and Re-Evaluation meetings have begun.
- SANDI testing has also started. Unique Curriculum is in place for our elementary students and Education Associates Vocational Curriculum is in place for high school students.
- Students and staff are acclimating to the new school year...

### **PAEC Center School Vocational/Transition Program**

We currently have **2** students employed competitively. Unemployed students are directed to apply for competitive employment online, in person, or in direct contact with employers. These students are monitored by Vocational Coordinator or Transition Staff via in person, one-on-one meets, emails, and/or text messaging. When students apply for competitive employment on their own, they are instructed to send me screenshots of completed applications. We also keep records of applications, students complete with me and/or staff.

Students have started to volunteer for the 2024-25 school year. As of today, we are servicing 6 volunteer job sites, where students are being trained on job skills that will increase their job readiness skills.

We are training our enrolled students to complete job tasks, answer mock interview questions, complete mock job applications, and more. I have continued to set up individual meetings with these students. We are practicing mock interviews, completing mock applications, and ensuring IDs have not expired, or get renewed in a timely manner. Some students are completing live applications, which we are currently waiting to hear from employers as well as contacting employers to follow up on our applications.

We are working hard to obtain competitive employment for our students. We are continuing to interview and follow up with employers to get our students hired.

### **PAEC Behavior Intervention Team**

The PAEC Behavior Intervention Team continues to provide behavioral support and interventions to reduce undesired behaviors within the Proviso Township school districts.

The Elementary Behavior Coaches are required to implement the 8-week Step Interventions & Support

Curriculum developed based on evidence-based data and documentation.

#### **PAEC Academy:**

A Behavior Coach has been assigned to the classroom referral submitted in August. The Coordinator and Coach are implementing interventions such as environmental antecedent modifications, a token economy system, clear behavioral expectations, and visual aids. The Coach has been working full-time in the classroom and will continue for another six weeks.

**District 87** - Jefferson Primary | Sunnyside Intermediate | Whittier Primary | Riley Intermediate | Northlake Middle School | MacArthur Middle School

#### **Jefferson:**

*Kindergarten Referral 1:* The Coach assigned to the student has transitioned into the classroom, and has been working diligently with the teacher for 3 weeks. The Coach has implemented a token economy system based on the student-preferred items, along with working with the parents and teachers to incorporate positive reinforcement within both settings.

*Kindergarten Referral 2:* The Teacher stated that she will no longer need Coaches to provide support/intervention within the class due to an improvement in behaviors.

*Kindergarten Referral 3:* The Coach has been assigned to the student for a week. The Coach is in the process of implementing positive reinforcement, incentives for appropriate behavior, a token economy system, and prompts prior to transitioning settings and activities.

*Kindergarten Referral 4:* The Coach has been assigned to the student for a week. The Coach is in the process of implementing small rewards for appropriate behavior, collaborating with the school Counselor regarding SEL services, prompting, and a token economy system.

#### **Whittier:**

*Kindergarten Referral:* The Coach has been assigned to the student for two weeks and has been working on data collection while starting to implement interventions such as scheduled sensory breaks,

prompting positive reinforcement, and a token economy system.

**District 92** - Lindop School

*Pre-K Referral:* The Coordinator will be conducting an initial observation on October 1st, 2024.

*Kindergarten Referral 1:* Coordinator has conducted the initial observation; a Behavior Coach has transitioned into the class as of October 1st, 2024.

*Kindergarten Referral 2:* The coordinator will contact the Coordinator of Special Ed regarding the next best day to observe the student.

**District 88** - Lincoln Primary | Grant Primary | Grant Elementary | Lincoln Elementary | McKinley Elementary | Thurgood Marshall Elementary | Roosevelt Middle School

**Lincoln Elementary:**

*Second Grade Referral:* The assigned Coach has been working with the student and Teacher for 3 weeks. The Coach has worked on implementing antecedent modifications (changing desks), enforcement of daily classroom expectations, a token economy system, positive reinforcement (verbal praise), as well as academic restructuring.

*Kindergarten Referral:* The Coordinator conducted initial observations; a Coach has been assigned to transition in the classroom on September 30, 2024.

*Second Grade Classroom Referral:* Due to minor behavioral issues within the classroom, a Coach has been assigned to conduct weekly check-ins with the Teacher.

**Thurgood Marshall:**

*Fourth Grade Referral:* A Behavior Coach has been assigned to the student for 4 weeks, working directly with the teacher to improve levels of assertion within the classroom. The Coach also has developed a token economy system based on the student's preferred items and classroom expectations.

*Kindergarten Referral:* The Coordinator will be conducting initial observations week of 9/30 - 10/4.

**McKinley Elementary:**

*Second Grade Referral:* The Coach has been assigned to the student for a total of 4 weeks. The Teacher has stated that the antecedent modification changes (rearranging furniture, posting words on the wall) have been implemented successfully and consistently. The Coach and Teacher also implement classroom expectations daily and have a token economy system designed regarding a pizza party based on desired behaviors over the course of 1 month.

*2 Second Grade Classroom Referrals:* The assigned Coach is working on a token economy system among the entire fourth-grade classroom based on desired behavior for a total of 1 month. The Coach works directly with Teachers to establish appropriate levels of assertion, daily expectations, and classroom modifications.

*2 Fifth Grade Classroom Referrals:* The Coordinator has conducted initial observations and assigned a Coach to transition into the classroom week of 9/30 - 10/04.

*2 Fourth Grade Classroom Referrals:* The Coordinator has conducted initial observations and assigned a Coach to transition into the classroom week of 9/30 - 10/04.

*1 Third Grade Classroom Referral:* The Coordinator has conducted initial observations and assigned a Coach to transition into the classroom week of 9/30 - 10/04.

### PAEC Psychology Department

Dr. Tom Naratadam (School Psychologist at Hillside 93) has been helping with the transition of students by providing morning and afternoon supervision. He has also been providing support with the MTSS process through the collection of data and observations. He has been providing instructional and behavioral support to a caseload of 10 students. Dr. Naratadam has also participated in early childhood screenings.

Ms. Annamaria Iarrapino (School Psychologist Intern) has been providing individual academic intervention support to a student at Sunnyside. She attended the ISPA Intern Conference in Bloomington on September 13th. Topics included learning about multicultural student needs as well as getting the most out of an internship to prepare for full-time work. Ms. Iarrapino participated in the District 87 Pre-School Screening on September 20th. She helped collect data via the DIAL and interviewed parents.

Ms. Dayle Ashley-Harding (PAEC Early Childhood Psychologist) has conducted numerous EC screenings and TPBAs so far this school year. She has provided support and training to staff who are new to the TPBA process, including to our two bilingual school psychology practicum students, Ms. Alexia Flores and Ms. Annette Garcia, both of The Chicago School of Professional Psychology.

Dr. Michael Cermak (PAEC Lead School Psychologist) has been providing some MTSS support to St. John Vianney. He has also been working with Mr. Kevin Grochowski, MacArthur Middle School Principal, as his school leadership intern supervisor to collect data on student attendance and connectedness to school in order to create a plan for school improvement at MacArthur as part of his internship. Dr. Cermak provides individual SEL support to several students at MacArthur on topics ranging from emotional regulation, to anger management, and organizational strategies. Dr. Cermak will be assisting District 87 with their implementation of Elyssa's Mission program in early October at Northlake and MacArthur Middle Schools.

### PAEC Social Work Department

1. Ms. Jill Collins, M.S.W., Ms. Anna Landmeier, L.C.S.W., and Ms. Ali Kagan, M.S.W., (PAEC School Social Workers-PAEC Center School) have been meeting with the students on their caseload individually and/or in group. They developed and administered a classroom needs assessment to

the high school teachers regarding the social/emotional learning and skill development needs of the students. SEL topics/activities covered include: Classroom Rules; Getting to Know You; All About Me/Self-Awareness; Various Icebreaker Activities (i.e., Classmates Bingo, Back to School Bingo, This or That; etc.); Safety; Likes/Dislikes; Respect; Learning to Keep Hands to Self; and Coping Strategies. Additionally, the PAEC Center social workers have been planning, coordinating, and assisting the program with Open House, Red Ribbon Week activities, Fall Themed Activities, Special Events, and various groups for student resources (i.e., Mrs. Merry, Dylan from And Next Comes L, etc.).

2. Ms. Kenya Dockens, L.C.S.W. (PAEC School Social Worker-Hillside School) has been facilitating various MTSS Groups: The 6<sup>th</sup> grade MTSS group has been focusing on Planning Skills; and the 7<sup>th</sup> and 8<sup>th</sup> Grade MTSS groups have been focusing on Stress Responses (i.e., Flight, Fight, Freeze, etc.). Ms. Dockens has been involved in the following Hillside School committees: New Teacher Mentor Meetings; Infinite Campus; Evacuation Procedures; and Staff Duties/Norms. Additionally, Ms. Dockens attended a training on McKinney Vento on 9/17/2024.
3. Ms. Nicole Pena, M.S.W. (PAEC School Social Worker-PAEC Academy School) has been facilitating whole classroom groups, small groups, individual sessions, and push-in social work services to the students attending PAEC Academy. Topics covered include: Hispanic Heritage; Learning to Label Your Emotions; and the Characteristics of a Good Friend. Additionally, Ms. Pena has been providing daily check-ins and check-outs with students, and has collaborated with other therapists (i.e., SLP, OT, PT, etc.) for Super Group; and has been facilitating daily breakfast push-ins to the kindergarten classroom. Ms. Pena provides ongoing consultation with teachers regarding students' behaviors, goals, and crisis intervention.
4. Ms. Lisa Pirrello, L.C.S.W., Ms. Donna Kuchera, M.S.W., Ms. Kelsey Thomas, M.S.W., Ms. Ali Kagan, M.S.W., and Ms. Tanajah Fields, Social Work Intern (PAEC Lead School Social Worker, PAEC School Social Workers, and Social Work Intern-PAEC Alternative High School Therapeutic Day School) are currently providing individual/small group social work sessions and have been covering the following topics: Conflict Resolution; Appropriate Communication Skills; Impulse Control; Grounding Techniques; Coping Strategies; and Anger Management Skills. Additionally, Ms. Pirrello is the assigned Field Instructor for the School Social Work Intern, Ms. Tanajah Fields, College of Social Work-Loyola the University of Chicago. Ms. Fields has been splitting her time between PAEC High School Therapeutic Day School and Hillside School. Currently, in the PAEC High School building, Ms. Fields has been seeing various students individually and in small groups. Additionally, Ms. Fields has been observing the IEP annual review, domain, and EDC meetings with Ms. Pirrello, and also observed a parent interview meeting. Ms. Pirrello arranged for the Comfort Dogs to visit the PAEC High School Therapeutic Day School Program, PAEC Elementary School, and PAEC Early Childhood Program on Thursday, October 17, 2024.
5. Ms. Vicki Bailey, L.C.S.W., and Ms. Glenda Liboy, L.C.S.W., (PAEC School Social Workers-Proviso West High School) continue to provide individual & small group school social work services to the students with special education needs and to students in the TST Program. Both school social workers have been covering the following topics: Getting to Know You; How to Survive the Tough Times; School Attendance Concerns; Problem Solving/Coping Strategies; and Joining School Clubs to increase Socialization Skills. Additionally, Ms. Liboy and Ms. Bailey have been attending annual review, domain, and EDC meetings, as well as scheduling and completing parent/guardian, student, and teacher interviews/meetings as it relates to triannual meetings that have been scheduled.
6. Ms. Dianna Stephens, M.S.W., A.C.S.W., P.P.S.C, C.W.A and Ms. Temika Peace, M.S.W. (PAEC School Social Workers-Proviso East High School) have established their caseload schedule for the first semester, and have begun providing individual & small group social work services. Topics covered include: Establishing Group Rules; Getting to Know You; Managing Stress, Coping Strategies, and attendance/behavior/grade concerns. Both school social workers continue to make calls to parents/guardians for students who continue to be truant from school. Additionally, Ms. Stephens assisted the District 209 school social workers in the planning for Suicide Awareness

Week Events and in building a clothing closet. Ms. Stephens has been in contact with Loyola about additional services for the life skills/transition students.

7. Ms. Monette Carlos, L.C.S.W. (PAEC School Social Worker-PAEC E.C. Program) is currently providing social work groups in the E.C. classrooms and covering the topic of Listening Skills. Ms. Carlos provided student activities using their eyes and ears (i.e., listening to different sounds; playing "I Spy", etc). During the E.C. Programs Open House, Ms. Carlos compiled the parent orientation presentation. Ms. Carlos has been reaching out to E.C. parents who were in need of some daycare resources or pediatrician referrals, as well as discussing how parents might practice certain social skills at home (i.e., sitting with family during meals, putting toys away, etc.). Additionally, Ms. Carlos wrote a mini-grant proposal for speakers to present to 3 different parent groups on such topics as Weaning from a Baby Bottle; the Importance of Establishing Sleep Routines; and Assisting the Picky Eater.
8. Mr. Patrick Rossi, L.C.S.W., and Niane Serrano, M.S.W. (PAEC School Social Workers-PAEC Elementary School) are currently providing individual & classroom group social work services to students on their caseload. Mr. Rossi and Ms. Serrano are facilitating push-in lessons, during the classroom groups, this school year. Topics discussed include: K-5<sup>th</sup> Grades: Zones of Regulation; Asking/Playing with Friends; 6<sup>th</sup>-8<sup>th</sup> Grade: CBT Triangle/Cognitive Distortions; DBT Skills and Anger Management. Additionally, Mr. Rossi and Ms. Serrano started the PAWS reward program and Student of the Week. Both social workers continue to manage ongoing crisis management and intervention strategies throughout the school day.
