The Executive Board meeting was held on Thursday, April 9, 2026. Those present included: Dr. Nicole Spatafore from District 87, Ms. Irene Daciuk, District # 87, Dr. Victoria Stockton from District #88, Dr. Antonia Hill from District # 93, and Mrs. Vanessa Schmitt from District #209

Mr. Michael James, Ms. April Cohen, Ms. LaShonda McDaniel, and Mrs. Cecy Mendoza-Jurek from PAEC Administration was also present.

Mrs. Trainette Latham from PAEC Administration was present during the ABA RoHealth Presentation.

The Executive Board reviewed and recommended approval of all action items on the agenda.

The Finance Committee met on March 7, 2026. The following items were discussed:

- **Treasurer's Report (March 2026)** — The committee reviewed and accepted the Treasurer's Report, including an overview of revenues, expenditures, and fund balances.
- **Fund Balance Discussion** — A spreadsheet was presented outlining the amounts needed to bring PAEC back into compliance with Board policy requiring a minimum 10% fund balance. The committee also discussed a plan to withhold a portion of FY2025 audit refunds to member districts, using a consistent allocation method, to support rebuilding the fund balance.
- **Transfer of Funds for Vehicle Purchase** — A resolution was discussed to transfer funds from the Operations & Maintenance Fund to the Transportation Fund to support the purchase of a replacement passenger van. The current vehicle is over 20 years old and is no longer cost-effective to repair.
- **FY2026 Amended Budget** — The proposed amended budget was presented. The budget remains balanced with no new funds required, but an amendment is necessary to reflect adjustments identified during the mid-year financial review.
- **FY2026 Audit Engagement Letter** — The committee reviewed the audit engagement letter from Baker Tilly for FY2026.

No formal action was taken. The committee will continue to review these items and provide recommendations to the Board as appropriate.

#### **1) Academics**

IAR testing for students in grades 3 through 8 was successfully administered online during the week prior to spring break. In preparation, the technology department provided valuable support in ensuring that all Chromebooks were fully updated and ready for use. Additionally, staff participated in targeted training during March's late arrival day, which helped promote a smooth and organized testing process. Although minor challenges arose, they were effectively managed, and overall, the testing experience was both efficient and well coordinated. Makeup tests will be administered until all students meet the requirement.

During the same late arrival session, teachers also engaged in a collaborative review of the Corrective Reading Curriculum. The team thoughtfully examined the various program levels and worked collectively to establish a cohesive implementation sequence moving forward. Looking ahead, the exploration and potential adoption of an updated math curriculum has been identified as a priority for the upcoming school year.

#### **2) Festivities**

Our talent show, held on March 20, 2026, was a vibrant and well attended event that truly highlighted the spirit of our school community. We were pleased to welcome representatives and families from Berkeley School District 87, Lindop School District 92, Hillside School District 93, and Bellwood School District 88, all of whom joined us in celebrating their students' talents and achievements.

On Friday, March 20th we celebrated World Down Syndrome Day (3/21/26) and had a wonderful Erin's Law presentation by Victor Pacini and learned about Safe and Unsafe Touch. On Friday, March 27th, the EC program also received Easter baskets from the Proviso Township for all the students in the EC program. We are very grateful for the nice surprise right before we went into our Spring break.

**Transitions-** There were no student transitions this month.

**Student Count:** There are 19 students in the two half day EC classrooms and 7 students in the full day EC Autism classroom that are counted under the PAEC Center numbers. Three new students are projected to be starting in the month of April. The EC Principal has also been on multiple home visits this month as new referrals from school districts and the early intervention program have been received. Home visits are done before new students enter the EC program as a way to help the parents learn about the program as well as getting to know the potential new students in a comfortable, safe environment. These visits have played a vital role in appropriate classroom placement in order to minimize multiple changes between classrooms once the students start school.

### Erin's Law Implementation



The Comprehensive Health Education Act, commonly known as Erin's Law, was signed into law in January 2013. Known formally as Illinois Public Act 097-1147, it requires public schools to provide child sexual abuse prevention education for children in pre-kindergarten through twelfth grade.

This school year, our elementary students received age-appropriate instruction as required by law. Core themes taught at all grade levels include identifying safe versus unsafe or unwanted touching, the safety rule about private areas, three key safety steps — Say "No!", Get Away, and Tell Someone — and understanding the difference between good and bad secrets. .

### Illinois Assessment of Readiness Spring 2026



The IAR is the state-mandated evaluation administered annually to students in grades 3–8, measuring proficiency in English Language Arts and Mathematics in alignment with the Illinois Learning Standards. Testing is scheduled to begin this month, and our staff has been diligently preparing students through targeted instruction and review. Results from this assessment will inform instructional decisions, support school improvement planning, and provide families with meaningful data on student academic progress.

## **Vocational Program Update**

March 2026

This month, Ms. Holsten and Mr. Tafoya were pleased to host our annual Postsecondary Options and Career Fair, which was expanded to include students and staff from PAEC Center. The event provided students with valuable exposure to a wide range of postsecondary programs, training opportunities, and additional educational institutions. Participating organizations included: APSIRE, Empire Beauty School, NAMI Metro Suburban, Pipefitters Union, Triton Community College, Community Support Services, RR Trade School, Parents Alliance Employment Project, CISCO, UCP Seguin, Chicago Women in the Trades, Mid-America Carpenters Regional Council, American Job Center of Maywood, Oak Leyden, Department of Rehabilitation Services, Chicago Lighthouse, United States Marine Corps, Lincoln Tech, Morton Community College, and Malcolm X College.

We took a tour of the new Maywood Lumity facility and are currently exploring a potential partnership with Lumity for the upcoming school year. Lumity's STEMWorks programs—including Construction & Trades Pathways (an IllinoisWorks pre-apprenticeship program), Career Launch, and YouthBuild—offer a comprehensive, student-centered approach to supporting young people without a defined college or career plan. These programs offer training in high-demand industries, including construction trades, healthcare, information technology, manufacturing, and solar installation. Participation is fully funded, and students receive stipends while developing career skills. STEMWorks also offers individualized support services, including assistance with transportation, childcare, and counseling, as well as job placement support and ongoing mentorship after program completion.

We also celebrated three students who completed the Level Up program, a six-course work-readiness series focused on essential workplace skills and professional development. Students were recognized at a celebratory lunch at the Level Up Center in Maywood, where each received a professional outfit to support their job search efforts.

Additional experiential learning opportunities this month included a field trip to the PLCCA-sponsored Career Fair at the Maywood Public Library. During this visit, students also participated in a financial literacy workshop focused on budgeting and making informed financial decisions. Finally, we coached and brought one student to attend a Starbucks hiring event, who was offered a summer position immediately after her interview.

## **PAEC Center School**

The month of March came in like a lion for sure!!!

The curriculum for the students in the elementary school is Unique Learning Systems (ULS). Using ready-made, standards-aligned lessons, automated differentiation and built-in assessment tools, ULS helps teachers save time and ensures that every learner gets the support they need.

The High School students use the Education Associates Job Ready curriculum. This series adapts the curriculum provided in the Career Exploration series to meet the needs of students with the most significant challenges. PAEC Center also uses subscriptions to Scholastic magazines as supplemental instructional materials. Additionally, current events such as Black History month for February are also recognized and curriculum developed around the day.

St. Patrick’s Day brings Green River Floats! Students were treated to the floats to help commemorate the day!

During the month of March PAEC Center also hosted the Women’s History Fair on March 25th. The students' presentations were engaging, interactive and student lead . Each classroom produced posterboard highlighting a woman who was relevant to the education and presented it on a table in the gym. The other classrooms were then able to visit the gym on a rotating basis to celebrate these achievements!

On the 27th, the students were invited to engage in an Easter Egg Hunt. Eggs were filled by high school students and elementary students were able to “hunt” for them in the playground and enjoy the treats inside.

**PAEC Behavior Intervention (BI) Team**

The PAEC Behavior Intervention Team continues to provide behavioral support and interventions to reduce undesired behaviors within the Proviso Township school districts.

The Elementary Behavior Coaches are required to implement the 8-Week Step Interventions & Support Curriculum developed based on evidenced-based data and documenting.

**District 87** - Jefferson Primary | Sunnyside Intermediate | Whittier Primary | Riley Intermediate | Northlake Middle School | MacArthur Middle School

***Whittier Primary:***

Early Childhood Referral: (On-going support) An Interventionist has been assigned to the student to provide behavior management strategies such as daily sensory walks, intentional transitions and a token economy to encourage positive behavior. *Update:* The Interventionist will continue to provide additional support for the duration of the school year based on administrators request, 3 days per week.

2nd Grade Classroom Referral: The assigned Interventionist has begun coaching the teacher on the implementation of effective interventions to improve the overall function of the class. Interventions have included a token economy system, implementations of class expectations, sensory room/calming corner and mild consequences due to high levels of disruptive and disrespectful behavior.

***Jefferson Primary:***

Kindergarten Student/Classroom Referral: (On-going support) Student has been assigned to an Interventionist due to excessive and extreme attention seeking behaviors. The student is currently receptive to the Lilo & Stitch behavioral chart designed to reduce behaviors such as screaming and blurting out. *Update:* The Interventionist continues to support the classroom due to its transition into a full classroom intervention.

First Grade Referral: (On-going support) An Interventionist has been assigned to a student to provide additional support, as this student's behavior is not extreme. Support will consist of reminding the student to focus during instructional time and maintaining attentiveness to improve academics.

2nd Grade Referral: The student has been assigned to a BI for behavioral support to improve off-task behaviors such as not attending to and completing work. The student also demonstrates a poor ability to interact with peers appropriately and positively. The Interventionist will create and provide the student with social stories regarding peer interactions and identifying a reward system to help her focus during instructional time.

First Grade Classroom Referral: There have been several students (3) referred within this class due to excessive disrespect towards the teacher. Students have displayed physical aggression such as throwing items and desks, and have collectively caused significant disruptions within the classroom. An Interventionist has been assigned to incorporate antecedent modifications (seating changes), a reward system for the on-tasks students, review of expectations and mild consequences for extreme behavior.

***McKinley Elementary:***

Kindergarten Class Referral: (on-going support) An Interventionist was assigned to coach the teacher on structuring the classroom with a schedule, class expectations, task/time management, transition methods, and token economy systems. *Update:* Interventionists continue to provide on-going support **as needed**.

First Grade Class Referral: (On-Going) A Student has been assigned an Interventionist due to displaying inappropriate behaviors with peers. The Interventionist will be working with the teacher to implement/demonstrate appropriate peer dynamics through social stories and role-playing.

First Grade Referral: The student will be assigned to a BI following spring break due to excessive negative peer interactions. The Behavior Interventionist will incorporate antecedent strategies, including structured separation from peers, to decrease inappropriate social interactions and promote on-task behavior.

***Lincoln Elementary:***

Kindergarten Student Referral: (On-going) The student has been observed exhibiting problem behaviors outside of the classroom. An Interventionist has been assigned to provide additional support with the student during special activities such as gym, art and recess.

First Grade Referral: The student has been referred due to excessive chatting and disruptions within the class setting. The student also exhibits behavior that limits his ability to participate during instructional time due to their lack of focus. An Interventionist has been assigned to assist with improving focus by implementing a pre-mack principle/reward system to encourage classroom engagement and minimize disruptions.

Fourth Grade Referral: A student was referred due to continuous oppositional and defiant behavior with adults, as well as attention seeking behavior. An Interventionist was assigned to aid in reducing classroom outburst, oppositional/noncompliance, as well as implementing a differentiated reinforcement technique to receive appropriate attention.

***Grant Primary:***

Early Childhood Student Referral: (On-going) An Interventionist has been assigned to the student and is currently in collaboration with the special education program to support with implementing a behavior/safety and crisis plan. The Interventionist also has incorporated a behavior plan based upon a token economy and small consequences for extremely disruptive and physically violent behavior. *Update:* Per administration request, the Interventionists have continued to provide on-going support due to high levels of disruptive behavior.

2nd Grade Referral: An Interventionist has been assigned due to several students displaying highly disruptive behavior such as yelling aloud, running around the classroom and oppositional behavior. The Interventionist is working with the teacher while implementing interventions such as antecedent modifications, token economy and mild consequences (limited free time) for defiant behavior.

**District 93** - Hillside Elementary

**District 209** - Proviso East High School | Proviso West High School | Proviso Mathematics and Science Academy

There are currently a total of 6 Behavior Interventionists assigned to 209; 3 are assigned to East and 3 are assigned to West.

Interventionists are now assigned to Grade Level Principals. The 209 district is in the process of implementing a new MTSS Framework within the Panorama system to ensure equitable and responsive circles of support for students. All BI's will follow this framework under the leadership of Deans and their assigned GLP's.

**PAEC OT/PT Department**

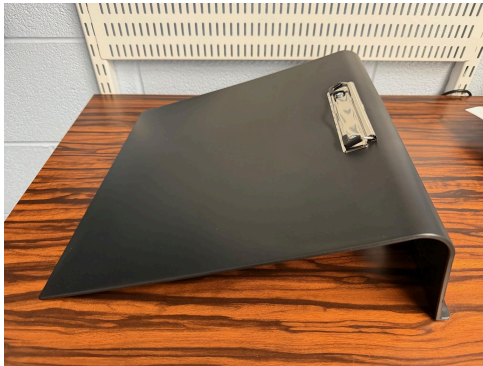

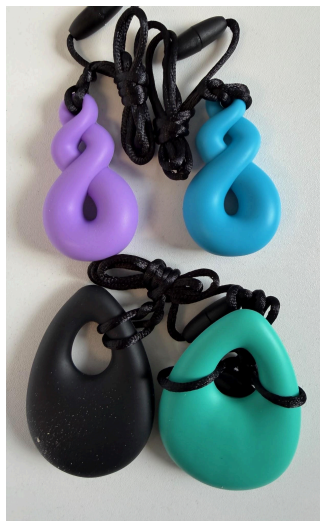

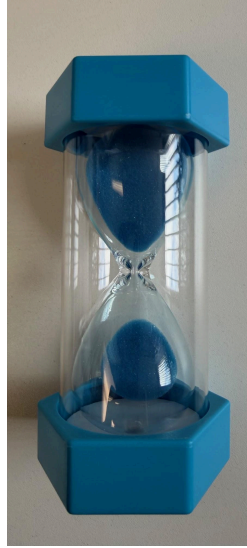

1. PAEC School Social Work Department New Hires:  
Mr. Daniel McLarin, MSW (replacing school social worker at Proviso Math & Science Academy on Maternity Leave for the remainder of the 2025-26 school year)
2. Ms. Nicole Peña, MSW (PAEC School Social Worker-PAEC Academy) has facilitated small/whole classroom groups and individual sessions and has focused on the following topics: Self-Advocacy Strategies, Practicing Life Scenarios in Group Circles, and Identifying Emotions. Ms. Peña has collaborated and facilitated various student groups (i.e., Super Groups, Weekly Lunch Groups, etc.) with other related service personnel (i.e., SLP and OT). Ms. Peña provides daily check-ins/check-outs and daily push-in groups with PAEC Academy students.
3. Ms. Cecilia Feliciano, MSW and Ms. Temika Peace, MSW (PAEC School Social Workers-Proviso East High School) continue to provide social work services to the students on their caseload and continue to develop strategies to increase student attendance and promote more student engagement in after school programs. Topics covered include emotional regulation and appropriate interactions with others. Ms. Peace and Ms. Feliciano continue to participate in weekly Student Grade Level MTSS teams, as a means of providing interventions with various academic and/or behavioral concerns.
4. Ms. Haviland Byrd, MSW and Ms. Elivette Agosto, MSW (PAEC School Social Workers-Proviso West High School) ) continues to provide individual/small group social work sessions to students on their caseloads at Proviso West High School, covering such topics as managing social media stress, engaging in appropriate communication skills, reasons behind school truancy, and emotional regulation. Ms. Byrd and Ms. Agosto continue to provide crisis intervention, as warranted, as well as complete documentation for numerous annual review and re-evaluation meetings that have been scheduled. Additionally, Ms. Agosto has been an active participant in the Language Task Force Committee at Proviso West High School, led by Dr. Jennifer Kirmes.
5. Ms. Monette Carlos-Barnes, LCSW (PAEC School Worker-PAEC E.C. Program) has been working with the children in the PAEC EC program on the following: Cross-Cat Room: Problem Solving and Asking a Friend To Play; Autism Room: Feelings, Imitation Skills and Following Directions; and Individual Sessions: Transitions and Learning to Play Together. Additionally, Ms.

Monette Carlos has been completing 3 year Re-evaluation documents for meetings that have been scheduled.

6. Mr. Patrick Rossi, LCSW and Ms. Niane Serrano, MSW (PAEC School Social Workers-PAEC Elementary) continue to provide individual/small group social work sessions to the PAEC Elementary Students, incorporating good sportsmanship, dealing with angry feelings, utilizing mindfulness, and a variety of exercises/sports to manage emotions during social skills groups. Both social workers continually provide crisis intervention, as necessary and contact parents to address care coordination and to provide additional resource information for parents to consider.

Additionally, the PAEC High School social workers continue to provide resources/support for parents in preparation for the upcoming spring break.
8. Ms. Jill Collins, MSW and Ms. Anna Landmeier, LCSW and Ms. Tanajah Fields, MSW (PAEC School Social Workers-PAEC Center School) have been participating in the coordination and planning of the upcoming PAEC Center Prom/Graduation Ceremony, End of the Year Events, as well as coordinated/facilitated/implemented Black History Month, PAEC Center Transition Fair and Women's History month celebration/activities. Ms. Collins co-coordinated the PAEC building-wide Zen Den Wellness Activity for PAEC employees throughout the PAEC Cooperative to enjoy. 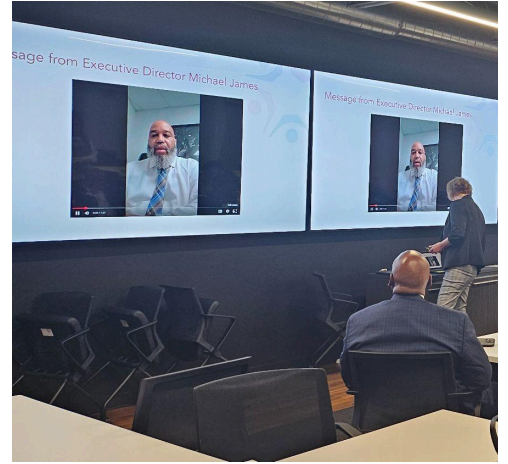

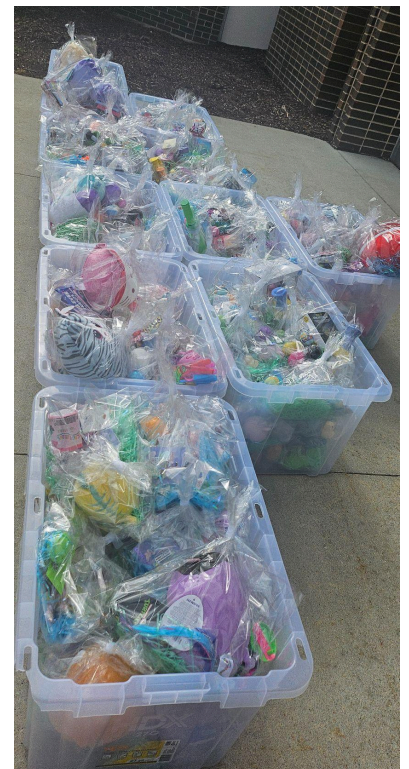
