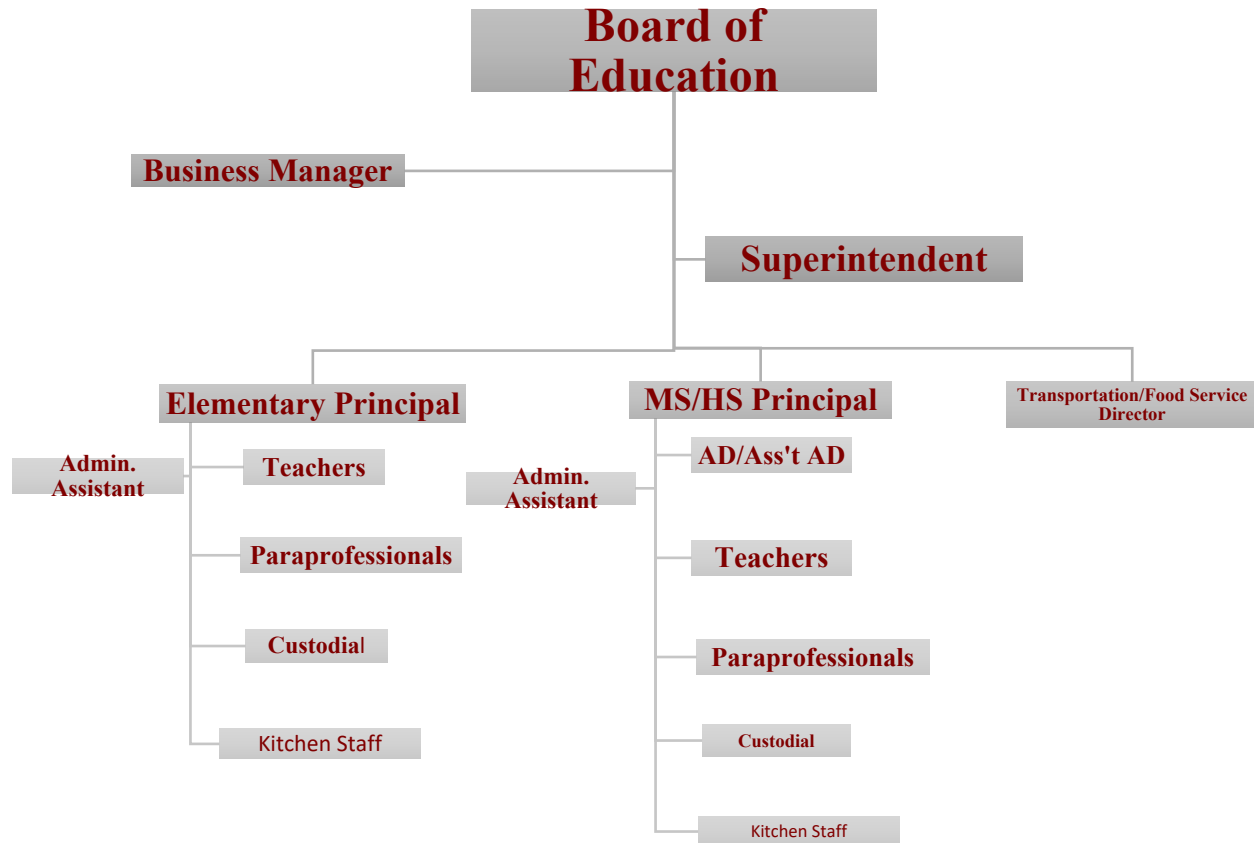

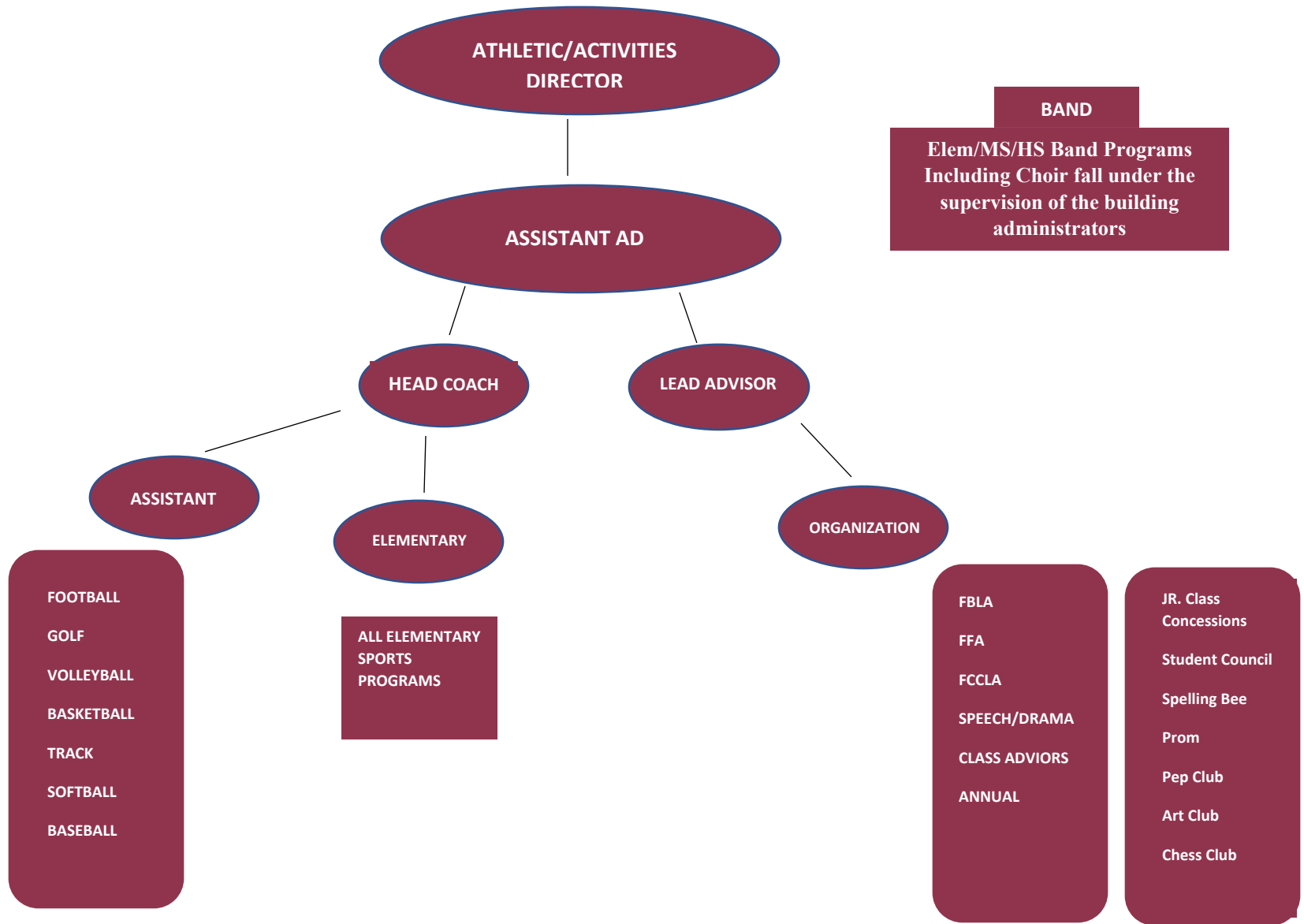

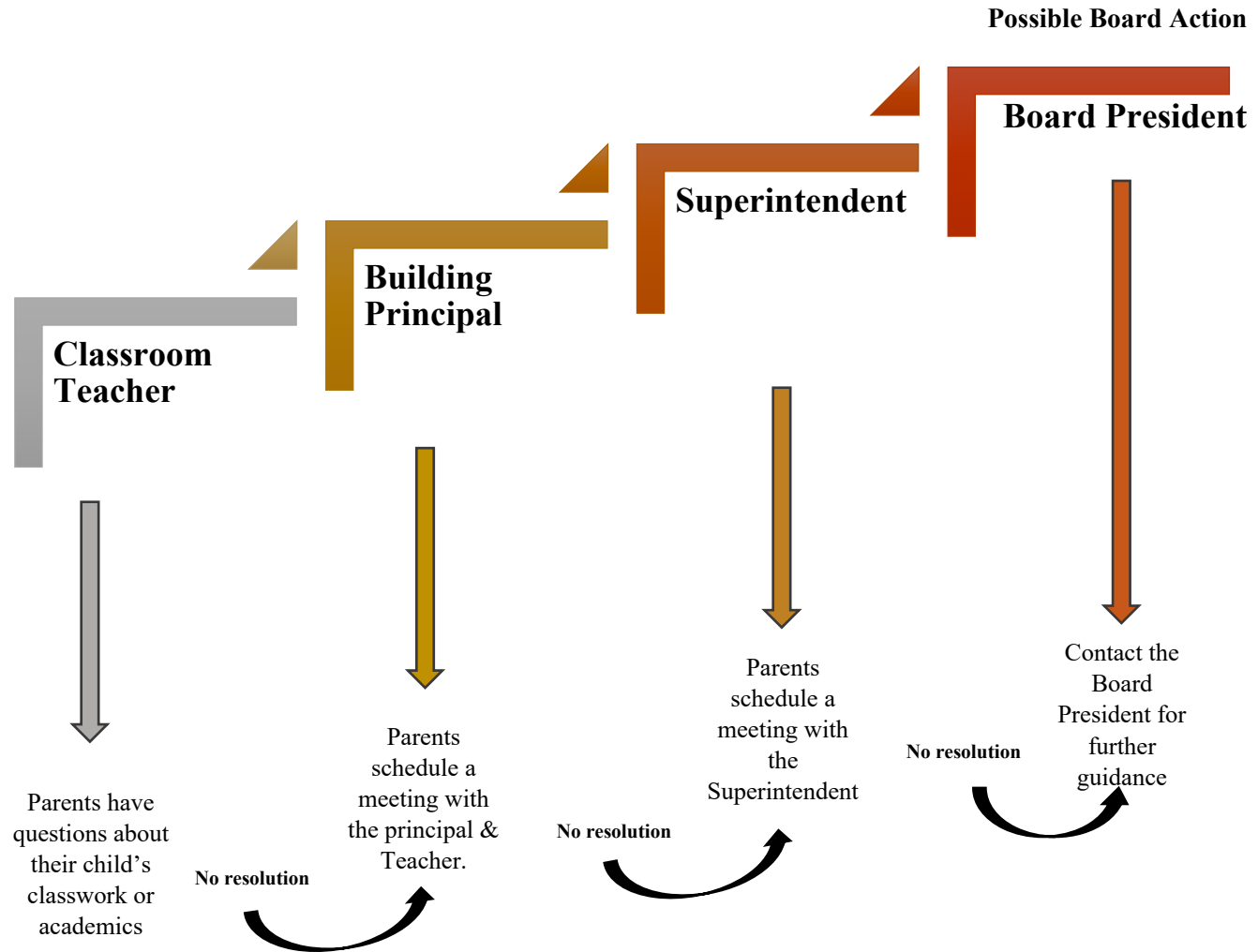
DIVIDE COUNTY SCHOOL DISTRICT ORGANIZATIONAL CHART
