RESOLUTION SETTING THE PROPERTY TAX REQUEST

RESOLUTION NO. 2024-2025

WHEREAS, Nebraska Revised Statute 77-1632 and 77-1633 provides that the Governing Body of Mullen Public Schools passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Governing Body of Mullen Public Schools resolves that:

- 1. The 2024-2025 property tax request be set at:

- 2. The total assessed value of property differs from last year’s total assessed value by 12.19 percent.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be 0.428032 per \$100 of assessed value.
- 4. Mullen Public Schools proposes to adopt a property tax request that will cause its tax rate to be 0.432309 per \$100 of assessed value.
- 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of Mullen Public Schools will increase (or decrease) last year’s budget by 2.38 percent.
- 6. A copy of this resolution be certified and forwarded to the County Clerk on or before October 15, 2024.
