DISCUSSION OR ANALYSIS

Background

Students are required to earn 3 Science Credits during their high school career to fulfill the graduation requirement that the Board of Education has set. Most students take Applied Science in 9th grade and Biology in 10th grade leaving one more full credit of Science. Chemistry and Astronomy are typically the next choices for students. The third one is Ecology. Students need to take two trimesters to earn a full credit. Some students will do two Ecology trimesters (different class curriculum) and some may do one trimester of Ecology and one of Astronomy as an example. Ecology is a great class, especially if students love the outdoors, do not want the rigor of chemistry or physics, or are unable to do the math at the level required for these other courses.

The Board of Education sets fees for classes and activities. State law requires any fees to be directly related to a cost for a course/activity and the course/activity cannot be required for graduation or a free and appropriate education .

For a certain population this is the class they need, want and fits their goals the best. It is almost a required class. The value to the district is by running it all three trimesters you help most students have the opportunity for a better high school schedule.

Data Review

Currently Ecology has a fee of \$20.00/semester. For example if you take two trimesters it costs the student \$40.00. This last school year we had 22 students take the Spring trimester of Ecology, 21 in the Fall and 18 in the Winter Semester. This resulted in us charging a total fee of \$1,220. The specific use of this fee was for busing as these classes do take multiple field trips. In 2024-25 the total was \$1,300, and in 2023-24 the total was \$1,160.

Conclusions and Recommendations

In conclusion, Ecology is a class that can almost fall into the “required” class and that is in conflict with our fee schedule. Also the impact to the district budget would be minimal and also the field trips are a necessity for the rigor and quality of the class plans.

It is the recommendation of the District Administrator to remove the fee for the Ecology Class and approve a fee structure for 2026-27 that no longer lists this fee.

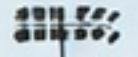

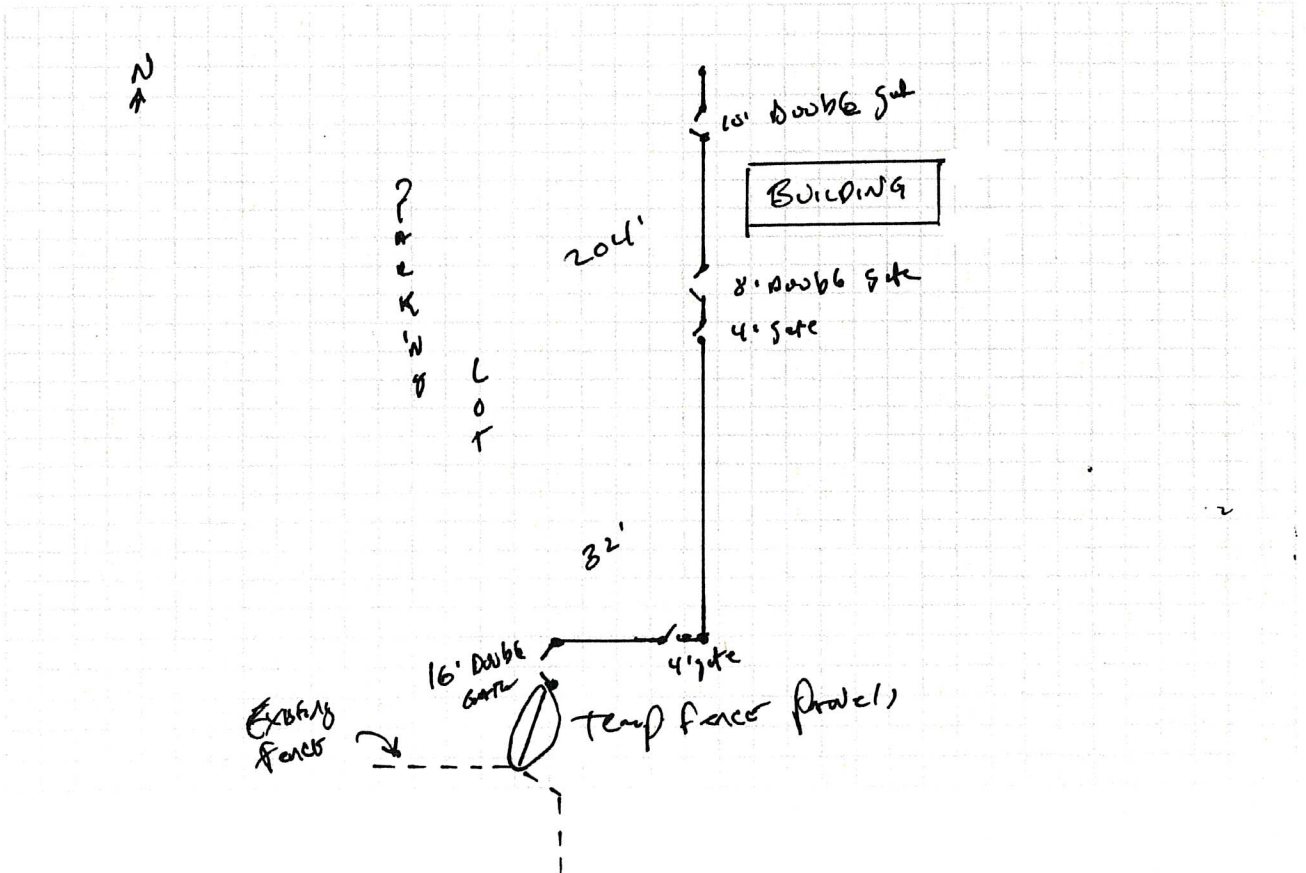

Budget Proposal: CPM Mathematics Curriculum Upgrade — Grades 6–12 Edition 2 to Edition 3

Need for Upgrade Our current CPM (College Preparatory Mathematics) curriculum at the grades 6–12 level is operating on Edition 2, a version that is no longer aligned with the most current mathematical standards, instructional best practices, or digital learning expectations. Edition 3 reflects significant updates in content sequencing, conceptual depth, and integration of technology-enhanced learning tools. As educational demands continue to evolve and students increasingly require stronger preparation for college and career pathways, remaining on an outdated edition places our students at a disadvantage. Approving this upgrade is a critical step toward ensuring our math program remains rigorous, relevant, and equitable for all learners.

What the Upgrade Includes The transition from CPM Edition 2 to Edition 3 encompasses new student textbooks and eBooks, updated teacher editions with revised lesson support, redesigned homework help resources, and access to CPM's enhanced online platform for both students and educators. Edition 3 incorporates updated problem-based learning structures, improved scaffolding for diverse learners, and more robust formative assessment tools embedded throughout each course. The upgrade applies across all seven course levels — Core Connections Courses 1, 2, and 3, Algebra 1, Geometry, Algebra 2, and Pre-Calculus — ensuring vertical alignment and a consistent instructional approach across the full grades 6–12 sequence.
